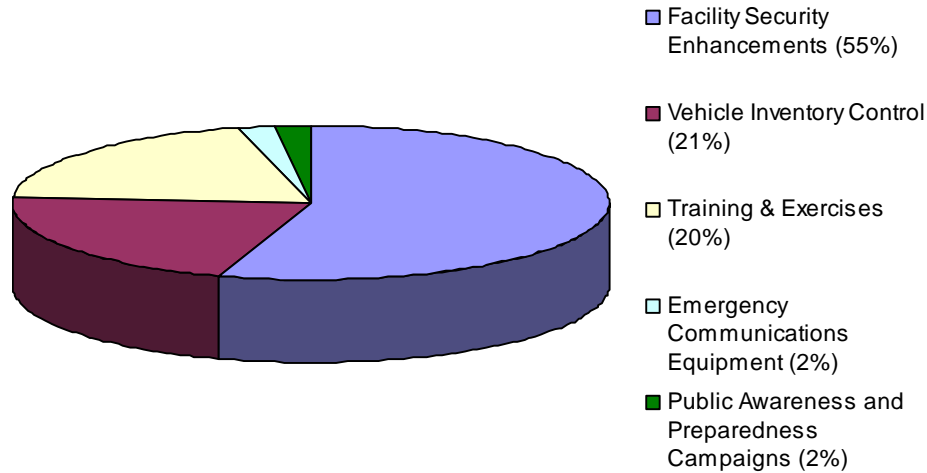


FY 2007 INTERCITY BUS SECURITY GRANT PROGRAM TIER II AWARDS

- **Eligible Requests:** 45 bus companies, 81 projects totaling \$7,530,381 in requests
- **Awards:** 33 bus companies, 52 projects totaling \$3,480,663 in competitive awards based on:
 - Providing significant security impact by aligning to the Intercity Bus Security Priorities
 - Ability to reduce risk of catastrophic events
 - Cost effectiveness
 - Sustainability without additional Federal funds and leveraging of other funding
 - Ability to complete project in within submitted timeframes
 - UASI jurisdictions served and passage through underwater tunnels



Grant Awards Address Specific Security Priorities in the Intercity Bus Sector

- The majority of the IBSGP money was awarded for three types of projects:
 - Over half of the awarded funds, representing 23 of the projects recommended for funding, will be used for facility security enhancements such as fencing, lighting, video surveillance, access controls/gates, and video monitoring
 - Over one-fifth of the awarded funds, representing 12 of the projects recommended for funding, will be used for vehicle inventory control utilizing GPS, including bus inventory, tracking, locating, and monitoring
 - 20% of the awarded funds, representing 15 of the projects recommended for funding, will be used for employee security training to help bus companies develop comprehensive training programs
