A description of OPIC support available to qualified small businesses, including financing, flexible political risk insurance coverage, and easier access through a streamlined approval process.

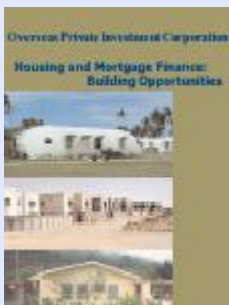
