Introduction

The U.S. International Air Passenger and Freight Statistics report has been developed to provide the public with additional access to international aviation data. The report is restricted to nonstop commercial traffic traveling between international points and U.S. airports. Global air travel systems are comprised of complex, ever-changing networks and alliances. The majority of international passengers to and from the U.S. make at least one connection before reaching their final destination. This report represents a limited aspect of international travel...nonstop flows into and out of the U.S. Cities that serve as an international gateway will have high numbers in this report, but users should bear in mind that some portion of this traffic continued on a connecting flight to their final destination. Conversely, U.S. carriers serve some international points only through an international connection; therefore it might look as if no US carrier serves a certain international point when in fact US carrier traffic is first flowing through a connecting city. Figures for U.S. nonstop market share do not necessarily correlate to the total service provided to that point by U.S. carriers.

The widespread use of code-share agreements also influences this data. Under a code-share agreement, it is common for a passenger to fly on an aircraft owned and operated by a different airline the one from which they bought their ticket. The data in this report represents the air carrier that operated the passenger or cargo flight reported. In some cases, such as U.S. to China, regulatory impediments make it difficult for U.S. domestic carriers to operate adequate service using their own equipment. U.S. carriers compensate by marketing and selling tickets under their own code to those destinations, and then arranging for a foreign code-share partner to actually transport the passengers. Therefore low U.S. market share in certain restricted markets is not indicative of the true proportion of passengers purchasing U.S. carrier tickets, but rather represents the type of carrier that transported the passenger reported. Code-sharing and network-flow data issues also apply to cargo shipments.

The data in this report is presented in a top-down format. Table 1 provides gross summaries of U.S.-International passengers, capacity, and freight. The same data is then broken down by world area, and country in Tables 2 through 5. Scheduled passengers data for the largest domestic gateway cities, the largest foreign gateway cities, and the largest U.S.- International city-pairs can be found in Tables 6,7, and 8. All data is derived from the T-100 Segment reports submitted to the Department by U.S. and foreign carriers.

The T-100 program was instituted by the Department of Transportation effective January 1, 1990. It covers traffic reports of foreign airlines operating to the United States and traffic reports of the domestic and international operations of U.S. airlines. The airlines submit these reports monthly to the Department's Office of Airline Information (OAI) of the Bureau of Transportation Statistics. The rules governing disclosure of the International T-100 data provide that data be kept confidential for a period of six months beyond the reporting date.

Users of this report should take the following points into consideration:


- The T-100 segment data includes all traffic arriving at U.S. airports and departing from U.S. airports on nonstop commercial international flights.
- Air carriers that operate aircraft with 60 seats or less are not required to file T-100 data. Therefore passenger volume in particular markets—particularly the Caribbean and certain Canadian markets is understated in this report due to the large amount of service provided by small aircraft.

- T-100 data represents only nonstop service. The absence of U.S. nonstop service, or a low U.S. flag market share, does not necessarily correlate to the amount of service provided to that point by U.S. carriers. Many international destinations are served by U.S. carriers via connecting points. Those not heavily served on a nonstop basis are underrepresented in this report.
- Conversely, traffic on U.S.– International routes that serve as connecting gateways will exceed the number of true Origin & Destination passengers on the route because of the high percentage of traffic connecting through the gateway.
- Code-share relationships may cause U.S. carriers to seem underrepresented in certain restrictive markets. This data is reported according to the operating carrier. In extensive code-share relationships (particularly to certain Asian countries) U.S. airlines sell a large number of tickets to passengers and then provide transport through the foreign code-share partner.
- Cargo carriers also employ the use of networks and code-share arrangements; therefore cargo data is susceptible to the same reporting shortcomings in this report as passenger data.
- Freight tons do not include mail.



Summary for Month of- and Year Ended- June 2000


U.S. and foreign air carriers transported 137 million passengers between the United States and the rest of the world for the year-ended June 2000. This represents a traffic increase of 6.9% over the previous year. U.S. flag market share dropped slightly from 48.9% to 49.5%.







Available seats into and out of the United States increased by nearly 4.0% to 192 million for the year-ended June 2000 compared to the previous year. There were 1.1 million flights into and out of the U.S. during the same period. U.S. flag carriers held 49.3% of seat market share, and performed 57.4% of departures.

U.S. and foreign airlines hauled 7.9 million freight tons to and from the United States during the year-ended June 2000, a 4.9% increase from the previous year. U.S. flag share increased from 41.1% to 41.5%.

Passenger Traffic

Air passenger traffic between the U.S. and the rest of the world in June 2000 grew 8.5% over June 1999, to 12,851,479 passengers. U.S. airlines carried 51.3% of passengers traveling to or from international destinations. Charter passengers accounted for 5.8% of international travel.

For the year-ended June 2000, U.S.-world traffic was up 6.9% over the previous year, to 137,335,071 passengers. U.S. airlines carried 49.5% of passengers, compared to 48.9% the previous year. Charter passengers accounted for 5.1% of international travel.

World Area Trends

Africa and the Middle East experienced the fastest rates of nonstop passenger growth to and from the U.S. for the year-ended June 2000. Europe-to-US passenger traffic grew by 3.6 million passengers between the year-ended June 2000 and 1999, the largest absolute regional increase. All nine regions recorded annual nonstop passenger growth between the two periods.

Over 49 million passengers flew between the U.S. and Europe for the year-ended June 2000, making it the largest U.S. International regional gateway. Europe is followed by the Far East at 22 million passengers, and Central America at 20.3 million.

Country Trends

The top five U.S. International country passenger gateways for the year-ended June 2000 were United Kingdom, Canada, Mexico, Japan, and Germany. Twenty-two of the top twenty-five country markets posted positive passenger growth rates for year-ended June 2000 vs. 1999. Brazil and Hong Kong, and Taiwan reported. U.S. flag share was down in seven of the twentyfive country markets, remained unchanged in seven, and increased in eleven countries.

Gateway Trends

The top domestic scheduled passenger gateway airports for the year-ended June 2000 were New York City-JFK, Los Angeles, Miami, Chicago, and Newark. Load factors were 70% or higher in 24 out of the top 40 domestic gateway airports. Load factors were below 60% in only two of the top 40 -- San Antonio (54%) and San Juan (58%). Ten of 40 domestic gateways posted traffic losses compared to year-ended June 1999.

The top foreign scheduled passenger gateways for the year-ended June 2000 were London-Heathrow, Tokyo, Toronto, Frankfurt, and London-Gatwick. Amsterdam, Frankfurt, Munich, Osaka, Tel Aviv, Zurich, and Manchester, UK, had load factors of 80% or more for the annual period. Montreal, Mexico City, and Toronto had load factors of 63%. Only Caracas, Venezuela had a lower reported load factor of 62%. Four of the top 40 foreign gateways reported traffic losses compared to year-ended June 1999.

The top U.S. – International gateway segments were 1) New York-JFK to London-Heathrow; 2) Honolulu to Narita; 3) Los Angeles to Narita; 4) Los Angeles to London-Heathrow; and 5) Chicago to London-Heathrow.

Departures and Seat Capacity

Departures between the U.S. and the rest of the world for the month of June 2000 increased 4.6% compared to June 1999. Available seats grew by 3.2% over the same period. U.S. airlines provided 51.6% of international seats, and 60.6% of departures. Charter service accounted for 5.6% of international seats and 6.2% of international departures.

For the year-ended June 2000, U.S.- world seats were up 4.0% over the previous year, to 192 million. Departures grew by 4.0%. U.S. airlines provided 49.3% of seats, compared to 48.5% the previous year.

World Area Trends

The Middle East experienced the greatest relative increase in both seats and departures to and from the U.S. for the year-ended June 2000. Europe-to-US capacity grew by over four million seats between the year-ended June 1999 and 2000, the largest absolute regional increase. Eight of nine regions recorded an annual seat capacity increase between the two periods. South America experienced a decline of eight percent.

Nearly 64 million seats were available between the U.S. and Europe for the year-ended June 2000, making it the largest U.S. International regional gateway from a capacity standpoint. Europe is followed by the Far East with 29.1 million seats, Central America with 29.5 million, and Canada with 27.6 million.

Country Trends

The top five U.S.- International country gateways for seat capacity in the year-ended June 2000 were Canada, United Kingdom, Mexico, Japan, and Germany. Nineteen of the top 25 country markets posted positive seat capacity growth rates for year-ended June 2000 vs. 1999. Argentina, Brazil, Colombia, Hong Kong, Taiwan, and Venezuela reported losses. U.S. flag share was down in nine of the 25 country markets, remained unchanged in two, and increased in fourteen countries.

Freight

Airfreight between the U.S. and the rest of the world in June 2000 increased 3.4% over June 1999, to 676,780 tons. U.S. airlines carried 42.9% of freight to and from international destinations. Charter service accounted for 9% of international freight traffic, and suffered a decline of 39.3% month over month.

For the year-ended June 2000, U.S.-world airfreight was up 4.9% over the previous year, to 7.9 million tons. U.S. airlines carried 41.5% of freight, compared to 41.1% the previous year.

World Area Trends

The Middle East experienced the greatest relative increase in nonstop freight shipments to and from the U.S. for the year-ended June 2000. Far East-to-US freight traffic increased by 378,660 tons between the year-ended June 1999 and 2000, the largest absolute regional increase. Five of nine regions recorded a loss of freight traffic between the two periods. Canada and the Carribean experienced the greatest relative declines of 24% and 23%, respectively.

Over 3 million tons of freight were transported between the U.S. and Europe for the year-ended June 2000, making Europe the largest U.S. international regional freight gateway. Europe is followed by the Far East with 2.9 million tons of freight.

Country Trends

The top five U.S.- International country gateways for freight in the year-ended June 2000 were Japan, the United Kingdom, South Korea, Germany, and Taiwan. Eighteen of the top 25 country markets posted positive freight growth rates for year-ended June 2000 vs. 1999. Canada, Chile, Colombia, and Dominican Republic reported losses of 20% or more. U.S. flag share was down in nine of the 25 country markets, remained unchanged in one, and increased in fifteen countries.
