VIOLATION OF THE TERMS AND CONDITIONS MAY RESULT IN MORE RESTRICTIVE SANCTIONS, OR A PRISON TERM OF 6 MONTH(S) AS APPROVED BY LAW.  
THE DEFENDANT IS ORDERED TO PAY A SUPERVISION FEE IN THE SUM OF \$ 200.00.  
DEFENDANT IS TO PAY COURT COSTS.
