Introduction

The U.S. Environmental Protection Agency (EPA) invites fellowship applications for the Culturally Diverse Undergraduate Fellowship Program. This program was initiated in 1982 as a means to strengthen the capacity of Culturally Diverse Institutions to provide quality education to undergraduate students by encouraging and supporting their professional training toward advanced degrees in environmentally related fields. This program, operated by EPA's National Center for Environmental Research and Quality Assurance (NCERQA), provides financial assistance to students majoring in environmental science, physical sciences, biological sciences, computer science, environmental health, social sciences, mathematics, or engineering. EPA expects to support around 25 undergraduate fellows for their final two years of study beginning in 1998. As part of the two-year program, students must complete a 'Summer Internship' at an EPA facility between their junior and senior years.

Background

The mission of the EPA is to provide leadership in the nation's environmental science, research, education, and assessment efforts; make sound regulatory and program decisions; and carry out effective programs and policies to improve and preserve the quality of the national and global environment. Both the public and private sectors will need a steady stream of well-trained environmental scientists and engineers if our society is to meet the environmental challenges of the future. Through its Office of Research and Development, the EPA is anticipating that need by offering financial assistance for undergraduate study in academic disciplines relevant to its mission at Culturally Diverse Institutions.

Eligibility

Undergraduate Students must be enrolled at a Culturally Diverse Institution, with at least two years remaining from the start of the Fall semester (Fall 1998), before receiving a bachelor's degree.

Students must have at least a "B" average overall and major in environmental science, physical sciences, biological sciences, computer science, environmental health, social science, mathematics, or engineering.

Students must be citizens of the United States, its territories, or possessions or lawfully admitted to the United Sates for permanent residence.

Students must be enrolled full-time in a four-year accredited institution in a full-time curriculum, as defined by the institution, for a school year.

Special Requirement

The candidates must agree, in writing, to serve (if requested) for up to 12 weeks at an EPA facility as a Summer Intern in the EPA Culturally Diverse Summer Intern Program after their first year of EPA-supported academic training. Each Intern must complete a summer project that is designed to complement and enhance the training received under the fellowship program. Students receive up to \$600 relocation support and up to \$5,000 stipend to cover living expenses during the summer internship.

Stipend and Allowances

The fellowship covers full tuition, fees, a \$250 book allowance plus a \$1,125 stipend over a nine-month period. Support for tuition and fees will be paid directly to the institution. Awards are subject to availability of funds.

Application

A complete application consists of the following documents:

EPA Form 5770-2 (pages 1 and 2), "Fellowship Application," and "Objective Statement." **The Fellowship Application, page 1, is self explanatory. The Objective Statement, Page 2, is explained in the ''Additional Instructions'' part of the application.**

EPA Form 5770-3, "Fellowship Facilities and Commitment Statement." This form requires two signatures, the student's Sponsor and Head of Department.

EPA Form 5770-4, "Fellowship Applicant Qualifications Inquiry." - **Recommendations** from three faculty members are required.

EPA form 5700-49, "Debarment and Suspension Certification." This form should be signed by the applicant.

Academic records - Official Transcripts for the last five years of academic work, including high school.

Evaluation and Selection

Each applicant will be evaluated in terms of his/her potential for successful undergraduate study, as evidenced by academic records, training and research plans, faculty recommendations, and career goals and objectives.

Applications will be reviewed, on a competitive basis, by a panel convened by EPA. The Panel will include representation from academia, government, and the private sector.

Selections of awardees will be made by EPA based on the panel evaluations and the availability of funds. The written evaluation summarizing the review panel's findings will be made available to the applicant.

Where and When to Submit

Applications must be received by **NCERQA no later than 4:00 p.m., EST on January 15, 1998**. Applications may be submitted by regular mail, express/priority mail or uniformed courier services. If using regular mail, allow sufficient time for delivery since applications MUST be at the contact point by 4:00 p.m. EST on January 15, 1998.

ADDITIONAL INSTRUCTIONS FOR YOUR FELLOWSHIP APPLICATION

Special emphasis for evaluation is being placed on certain components of this application. Therefore, the following additional information should be included where appropriate.

EPA Form 5770-3, Fellowship Facilities and Commitment Statement Item 11

A tailored program of courses in the environmental sciences should be developed for each applicant to identify specifically those courses that relate to the environmental sciences. Special emphasis should be placed on courses which address the student's career objectives in the environmental field.

A second major emphasis should be placed on **OUTLINING AN ACTIVITY OF ENVIRONMENTAL RESEARCH/TRAINING** that relates to the stated objective of the applicant.

EPA Form 5770-2, Objective Statement, Item 16

This item will be of paramount importance in evaluating your request for a fellowship. Your answer, therefore, should be well thought out and expressed in a clear and detailed but concise manner. The statement should be in the following format:

Introduction - Background information and a description of why you want to participate in this program.

<u>**Career Goal</u>** - Describe how you expect to be involved in the environmental field or describe how you will use your environmental training in your chosen career.</u>

Previous Environmentally-Related Experience - Describe how work/volunteer/academic experiences gained relate to career goals.

Environmental Research/Training Project - In your own words, describe the research/training project which you have developed in conjunction with your sponsor.

Conclusion Statement

Items continued on supplemental pages must be numbered to correspond to the appropriate item on the application form. Margins should be at least one-half inch on the sides and one inch at the top and bottom. Forms and diagrams should be drawn in heavy black lines. Do not staple. The applicant's name must be typed at the top of all supplemental pages.

Individuals desiring EPA notification that their application has been received should not the postage requirement on the acknowledgment postcard. Status of Materials Submitted. The Fellowship Application and related documents such as transcripts become the property of EPA and cannot be returned.

Agency fellowships are awarded to present or prospective employees of a regional, State or local environmental pollution control or regulatory agency to provide training for and upgrading of personnel in the areas of pollution abatement and control Applicants for this type of fellowship must also complete the EPA Form 5770-5, Agency Fellowship Certification, enclosed with this application kit.

<u>Special</u> fellowships are awarded to individuals for education and training in pollution control science, engineering, and technology, and in specialty areas which are supportive of pollution abatement and control efforts.

<u>Full-time</u> is defined as a minimum of 12 semester or quarter hours for credit or an academic workload otherwise defined by the institution as a full-time curriculum.

<u>Part-time</u> is defined as being duly enrolled in an educational program with at least three (3) credit hours per academic term.

 This date should indicate the date that applicant desires to begin his fellowship.

- 6. SINGLE/Includes widowed, separated, or divorced) or married.
- 7 AND 8 Self-explanatory.
 - At the time of application a noncitizen must have been lawfully admitted to the United States for permanent residence. No proof of citizenship is required if you are a citizen or noncitizen national of the United States.

If there are any unusual circumstances involved in your training situation or if you are seeking a degree from an institution other than the one in which the training will take place, give a detailed description under Item 16. 15 It is most important that your references be carefully selected.
