#### <> EPA LAUNCHES NEW TRIBAL WEBSITE <>

The Environmental Protection Agency has launched the first-of-its-kind portal website to help the tribal community, its supporters and the public find tribal environmental information and data through a single web-based access point.

Announced today at the National Tribal Operations Committee (NTOC) meeting in Washington, DC, the portal is part of EPA's commitment to strengthen its partnership with Indian tribes and governments to protect human health and the environment. Established in 1994, the NTOC comprises 19 tribal leaders and senior Agency leaders, and meets once a year to discuss implementation of tribal environmental protection programs. Currently, there are approximately 560 separate, federally-recognized tribal governments in the United States.

"For centuries, Native Americans have been respected for their commitment to Mother Earth. At EPA, we share in the obligation to pass down a cleaner, healthier environment to future generations," said EPA Administrator Stephen L. Johnson. "This new Web site reflects EPA's ongoing efforts to reach-out to the tribal community in order to accelerate human health and environmental protection in Indian country."

The new cross-agency website allows EPA to consolidate and share environmental information reflecting the tribal community's perspective and needs into a central, easy-to-navigate structure. Various EPA programs, such as enforcement, waste, underground storage tanks and water, are also consolidating their tribal information through this website. The site will help users save time and resources by making it easier to locate tribal environmental information within EPA and other government agencies.

#### **Pesticide Control Grants**

The purpose of this solicitation is to provide financial assistance to eligible tribal governments, Alaskan native villages, or intertribal consortia for projects to conduct research, development, monitoring, public education, training, demonstrations, and studies related to pesticide control. Examples of the types of projects the Agency will consider include, but are not limited to: Development or implementation of a plan to manage pesticide use on reservation, including reduced use of pesticides or use of alternatives to pesticides; conducting pesticide safety education and outreach; development or implementation of measures to protect water from pesticide contamination; conducting vulnerability assessments to determine potential threats from pesticides to water sources or endangered or threatened species; sampling water, soil or culturally significant plants, wildlife, or objects for pesticide contamination; determining effects of pesticides on cultural activities such as subsistence hunting or fishing; and conducting pesticide disposal days.

This year \$400,000 is available to tribes nation-wide for pesticide projects, with a limit of \$50,000 per project. Project proposals may be submitted by any federally-recognized tribal government, Alaska native village or any tribal consortium eligible to receive federal funds. ### **Particulate Matter & Health**

EPA is requesting proposals for Innovative Approaches to Particulate Matter Health, Composition, and Source Questions. Through this RFP, EPA seeks applications proposing to improve the ability of epidemiologic studies to link health outcomes to sources and components of air pollution. \$5 million is expected to be available and up to 6 awards are anticipated. ### Rural Community Development Initiative (RCDI)

USDA requests proposals for RCDI. This program supports qualified intermediary organizations that will provide financial and technical assistance to recipients to develop their capacity and ability to undertake projects related to housing, community facilities, or community and economic development. Eligible activities include, but are not limited to: Assisting recipients to complete predevelopment requirements for housing and community facilities by providing architectural, engineering, or legal services; improving recipient's organizational capacity by providing training and resource material on developing strategic plans, board operations, management, financial systems, and information technology. \$6.2 million is expected to be available and individual awards will range from \$50K to \$300K. # **Hazardous Waste Management Grant** for Tribes

This notice announces the availability of funds and solicits proposals from Tribal governments and Intertribal Consortia for the development and implementation of hazardous waste programs, and to build tribal capacity to address hazardous waste mismanagement in Indian country.

All hazardous waste management activities that address the RCRA Subtitle C "cradle to grave" approach are eligible. Each of the following hazardous waste management program activities are considered central to a "cradle to grave" program:

- 1. Hazardous Waste Identification,
- Hazardous Waste Generator Siting, Monitoring, & Compliance (Large Quantity, Small Quantity, and Conditionally Exempt Small Quantity Generators),
- 3. Hazardous Waste Recycling, Used Oil, and Universal Wastes,
- 4. Hazardous Waste Transportation,
- Treatment, Storage, and Disposal Facility Siting, Permitting, Monitoring, Corrective Action, & Enforcement,
- 6. Land Disposal Restrictions,
- 7. Combustion.

Applicants may choose to submit applications either in hard copy (paper) format or electronically through http://www.grants.gov. Applications submitted in hard-copy must be postmarked by the U.S. Postal Service or received in the EPA Program Office via hand delivery by August 13, 2007, 5:00 p.m. EDT. Electronic applications must be submitted by August 13, 2007, 5:00 P.M. EDT. EPA anticipates awarding of up to 4 cooperative agreement(s). The total budgets may not exceed \$79,500.

# **STAG Funding for Tribes**

The Office of Enforcement and Compliance Assurance published the 2007 State and Tribal Assistance Grant solicitation. One of the focus areas for this grant solicitation is Tribal Compliance Assurance Training and Workshops.

Grant funding awarded for this focus area will be used to support two types of environmental training in Indian country:

- (1) improving the ability of tribal environmental professionals to properly and safely conduct inspectionspursuant to applicable environmental laws; and
- (2) increasing understanding of the roles and responsibilities of EPA and federally-recognized Indian tribes in ensuring environmental compliance in Indian Country and other tribal areas.

Due to limited resources, priority will go to proposals that will improve the capabilities of multiple tribes. The funds must be used for building the capacity and expertise of tribes to implement compliance assurance and enforcement programs. These funds cannot be used for the actual implementation of compliance monitoring and enforcement programs.

The deadline for submitting applications (proposal and partial grant application) is **August 23**, **2007**. Applicants will be notified of the funding recommendations **by September 28**, **2007**. For information:

### **HUD CodeTalk Website**

HUD has a website, CodeTalk, which is a federal, interagency, Native American website designed specifically to deliver relevant electronic information to Native American communities. There are at least three programs that may be of interest to Tribal Communities. They include: The Indian Housing Block Grant Program, The Rural Housing and Economic Development Program, and The Indian Community Development Block Grant Program. Most Tribes receive funds through the Indian Housing Block Grant Program which has \$624 million available in FY 2007. This may be the best potential source of funds to help change-out inefficient wood stoves in cleaner burning hearth appliances for those who are eligible, i.e., low income people (80% of the median income=low income).

# Report Says Tap Better Than Bottle Water

A consumer rights organization published a report Jun 29 that said tap water is generally healthier, less expensive, and better for the environment than bottled water. The report also recommends U.S. consumers choose tap over bottled water. The EPA regulates all public drinking water systems, while the Food and Drug Administration regulates bottled water. The report said, however, that FDA regulates only 30 percent to 40 percent of water sold across state lines. The full report is available at:

### **Wood Stoves**

Residential wood smoke from wood stoves and fireplaces contributes 6 percent (420,000 tons) of the total amount of fine particle pollution (PM2.5) directly emitted in the United States each year. That contribution can be significantly greater in areas where wood stove use is high. In addition, about 22 percent of total U.S. polycyclic aromatic hydrocarbon (PAH) emissions come from residential wood smoke.

EPA is conducting a national campaign to help state, local and tribal agencies reduce emissions of fine particles and air toxics by replacing old, inefficient wood stoves with cleaner-burning technologies. EPA estimates that for every 20 wood stoves replaced, PM2.5 emissions will be reduced by 1 ton per year. This cost-effective program (less than \$2,000 per ton for every old stove replaced) may help you bring your area into attainment with the national fine particle standards. # Agriculture Website and Pesticide Screening
