Multi-Media Project Grants for Alaska

Multi-media project grants provide an opportunity to improve environmental protection for tribes in rural Alaska. Projects will be selected based on their potential to ameliorate conditions adverse to tribal health and tribal environment.

To be considered a *demonstration*, a project must be innovative and show new, largely untested processes or products, or tried-and-true processes adapted for a new use. Well-known or widely used processes will not qualify.

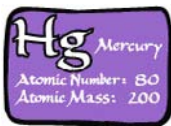

Safe Water for Kids

Offered as part of Purdue University's Safe Water for the Future program, the Safe Water for Kids activities have been designed as a tool for teachers, educators, and water company operators. According to Purdue's website, the materials clearly show the balance between our actions and the environment. Each activity can be used to clarify issues and explore hypothetical situations.

The activities can be used indoors, in a classroom, or outdoors. They are hands-on activities that can illustrate a specific topic. They are "attention getters" that keep students interested. The featured activities provide answers to questions such as how water moves through the earth and where contamination goes. More than 20 million Americans have privately owned wells, but very few regulations exist to govern the quality of private well supplies. Climate Change Website

To provide the public with current information on climate change, EPA is updating its climate change website. The site provides the latest scientific information and highlights a wide range of U.S. Government programs actively addressing climate change at local, state, national and international levels.

EPA developed the climate change site in collaboration with other federal agencies. The scientific information it contains reflects consensus findings from U.S. and international organizations.

The updated website still contains the information that was on EPA's global warming website but organizes it for easier access and adds new information.

Site visitors will find educational tools and information to help understand their personal impact on climate change, including a list of 30 practical steps people can take to reduce their emissions. Visitors will also find a calculator to help estimate their "carbon footprint" — the greenhouse gas emissions produced in the course of everyday activities. <http://www.epa.gov/climatechange/>

EPA has released a new brochure that provides health and safety information for professional and do-it-yourself mechanics who may work with asbestos-containing automotive components. *Current Best Practices for Preventing Asbestos Exposure Among Brake and Clutch Repair Workers* emphasizes the need to prevent asbestos fibers from escaping into the air during repair work.

presence of asbestos. The booklet warns against blowing dust from brakes and clutches with compressed air. It details three recognized methods for containing asbestos dust in a professional automotive shop.

While it is impossible to tell if clutch and brake components contain asbestos, mechanics should automatically assume the possible

The booklet also provides guidelines for do-it-yourself mechanics. They include using pre-ground, ready-to-install parts and not taking work clothes into the house, to prevent exposing family members to asbestos dust. EPA Issues Guidance for Diesel

Tens of millions of tons of diesel fuel pollution, including nitrogen oxides (NOx) and particulate matter, could be reduced under new EPA guidance that allows automakers to install Selective Catalytic Reduction (SCR) technology on diesel-powered cars and trucks. The guidance was issued to automakers in a memo from Karl J. Simon, Acting Director of EPA's Compliance and Innovative Strategies program and will help manufacturers comply with tough new emissions standards for NOx emitted from diesel engines.

Environmental Violations

You can help protect human health and the environment. If you see signs of an environmental violation, please report it at <http://www.epa.gov/compliance/complaints/index.html>. Signs of violation may include: corroded, leaking or abandoned waste containers or signs of illegal dumping; dead animals; staining or stressed vegetation on the ground or staining around wastewater outlets; foul smelling or unsightly discharges or visible sheens on the ground or on water bodies; pipes or valves to allow the by-pass of wastewater treatment systems; or demolition that may involve illegal removal of asbestos or other hazardous materials. EPA to Revise Definition of Solid Waste

EPA has proposed to modify the Definition of Solid Waste to streamline the regulation of hazardous secondary materials. The proposed rule would provide for the recycling of such materials as solvents, metals, and certain other chemicals. EPA estimates about 4,600 facilities, handling more than half a million tons of hazardous secondary materials annually, may be affected by the revision.

"This proposal recognizes that recycling secondary materials can both help the environment and reduce costs," said Susan Bodine, Assistant Administrator for EPA's Office of Solid Waste and Emergency Response. "By encouraging legitimate recycling practices that are environmentally protective, this proposal presents a win-win for the environment and for the economy."

EPA estimates that streamlining the management of secondary materials can result in an average cost savings of \$107 million a year.

The proposal provides exclusions for: materials that are generated and reclaimed under the control of the generator; materials that are generated and transferred to another person or company for reclamation under specific conditions; and materials that EPA deems non-waste through a case-by-case petition process. It also defines legitimate recycling to ensure that only legitimate activity benefits from the streamlined requirements.



EPA is accepting comments on the proposal. **The comment period**, published in the Federal Register on March 26, 2007, **has been extended through June 25th**. The docket number, which must be included with comments, is EPA-HQ-RCRA-2002-0031. The document is available for public viewing. School Chemicals



EPA has announced its Schools Chemical Cleanout Campaign (SC3) to help schools prevent chemical accidents. This program aims to ensure that all schools are free from hazards due to mismanaged chemicals. SC3 gives K-12 schools information and tools to responsibly handle chemicals.

SC3 is an effort to help schools safely manage their chemicals. EPA and the U.S. Department of Education are working with industry on the project. Through the campaign, schools are connected with local chemical management experts and a Web-based toolkit.

Across the country, EPA estimates that about 33,000 middle and high schools have laboratory and other chemicals that could cause accidents and injure students.

“Our schools must provide safe, healthy environments for students to learn and fully reach their potential,” said Deborah Price, Assistant Deputy Secretary for the Office of Safe and Drug-Free Schools.

“We’re ready to help schools take practical steps to prevent accidents, spills, and fires,” said Susan Bodine, Assistant Administrator for EPA’s Office of Solid Waste and Emergency Response.

Compact Fluorescent Light Bulbs

Energy efficient choices can save families about a third on their energy bill with similar savings of greenhouse gas emissions, without sacrificing features, style or comfort. ENERGY STAR helps you make the energy efficient choice. If looking for new household products, look for ones that have earned the ENERGY STAR. They meet strict energy efficiency guidelines set by the EPA and U.S. Department of Energy.

ENERGY STAR qualified CFLs:

- Use at least 2/3 less energy than standard incandescent bulbs to provide the same amount of light and last up to 10 times longer.

- Save \$30 or more in energy costs over each bulb's lifetime.
- Generate 70 percent less heat, so they're safer to operate and can cut energy costs associated with home cooling.

Where to Use CFLs: To get the most energy savings, replace bulbs where lights are on the most, such as your family and living rooms, kitchen, dining room and porch. Some CFLs have trouble operating in enclosed fixtures. Check the CFL's packaging for any restrictions on use.

How to Choose the Right Light: Matching the right CFL to the right kind of fixture helps ensure that it will perform properly and last a long time. Read the packaging to be sure that the type you choose works for the fixture you have in mind.

Call for Presenters

Central Council of Tlingit and Haida Indian Tribes of Alaska received funding from the Environmental Protection Agency and is soliciting presentation proposals for its 2007 **GIS User Conference**. The Conference will focus on an individual tribal showcase of GIS applications and projects from communities in Southeast Alaska, Region 10, and other interested parties.

Ideally, this will be a time for tribes to build capacity as a region, develop regional maps, and cooperative mapping projects for themselves and for neighboring communities. This will also be a trouble-shooting conference,

where users will have access to GIS applications and other GIS uses. It will be based on "What's New" in Southeast Alaska and around other Region 10 Tribal GIS Communities. The conference is expected to last 3 days, **September 19 — 21**, in Juneau, at the Westmark Baranoff. **All presentation proposals are due by close of business May 15th, 2007.**
