National Wildlife Refuges Hunting and Fishing Regulations 2008-2009

This brochure is designed to provide the public with information and a summary of regulations pertaining to hunting and fishing on Theodore Roosevelt NWR Complex. These regulations supplement regulations governing hunting and fishing on National Wildlife Refuges as set forth in Title 50, Code of Federal Regulations and applicable state regulations. Violation of Refuge or State regulations may result in confiscation of Refuge Permit in addition to prosecution.

Permit, Stamp and License Requirements

Persons utilizing the refuge are required to have appropriate licenses, stamps, and permits. All persons hunting on this refuge must have the following in their possession:

1. Applicable State hunting license(s), permit(s) and stamp(s). Consult current Mississippi Department of Wildlife, Fisheries, and Parks Regulations for details.
2. **Stand Decal:** If you plan to use a stand, platform or blind, you are required to obtain a decal from the Yazoo NWR Office. You may request this decal at the same time you purchase your annual Public Use Permit or separately.
3. **Special Buck Tags:** In order to more effectively manage harvest and population numbers, the Mississippi Deer Management Assistance Program (DMAP) is authorized for Hillside, Morgan Brake, Panther Swamp and Yazoo NWRs. A limited number of Special Buck Tags, allowing the hunter to harvest a buck with at least one unforked antler, will be available for each refuge designated hunt. These tags do not count toward daily or seasonal bag limits. Hunter participation and data collection is crucial for success of this program. Unlimited Hunt Special Buck tags will be on a first come, first serve basis, Limited Hunt Special Buck tags will be by random draw as indicated on your application. If interested please indicate on permit application for unlimited hunts and limited hunts.
4. Each day before hunting or fishing, all participants must obtain a pink User Information Card available at the Visitor Information Stations (see maps) and follow the printed instructions on the card. All harvested game must be recorded and cards submitted daily. Self service check stations have been provided. For each antlerless deer, please record weight, lactation, and date harvested. For each buck, please record weight, main beam length for each antler, basal circumference for each antler, inside spread, and date harvested. Also record hoof sloughing, if present.
5. **Refuge Annual Public Use Permit (\$12.50):** Each person 16 years of age and older hunting during an unlimited hunt or fishing on the refuge(s) must have with them a valid Refuge Annual Public Use Permit which certifies that they understand and will comply with the regulations contained in this brochure.

This permit is not transferable nor refundable and is valid for all lands open to hunting and fishing within the Theodore Roosevelt NWR Complex. Consult individual refuge regulations in this brochure.

6. **Refuge Limited Hunt Permit (\$12.50):** Panther Swamp NWR Deer Firearm and Yazoo NWR Deer Senior Citizen, Youth, Muzzleloader, and January First Week Archery Hunts require a Limited Hunt Permit which is assigned by random computer drawing. If drawn, this permit is required to be on your person while hunting during the designated hunt. These Permits are not transferable nor refundable. Consult individual refuge regulations in this brochure. Possession of the Refuge Annual Public Use Permit is not required for Limited Hunts.

Refuge Annual Public Use Permit Application Procedures

Mail the complete name, address, and telephone number for each applicant on a plain sheet of paper (8 1/2 x 11) to the address on cover. **Enclose a money order or check payable to USFWS (NO CASH)** which includes \$12.50 for each permit requested. Permits are available at Yazoo NWR Mon - Fri, 7:30 am - 4 pm. Permits will be available beginning August 1, 2008. There is no deadline for obtaining Refuge Annual Public Use Permits. Refuge Annual Public Use Permits expire on July 31.

Refuge Limited Hunt Permit Application Procedures

To apply provide the following information on a plain sheet (8 1/2 x 11) of paper:

1. Complete name, address and telephone number for each applicant.
2. Specify refuge name and the type and dates of hunt for which you are applying. Consult individual refuge regulations in this brochure.
3. Sign application and mail to the address on cover. Group application must be signed by at least one applicant.

Limited hunt drawings will be conducted in mid-October. Only successful applicants will be notified of procedures to submit the \$12.50 fee for the limited hunt permit. Duplicate applications will be rejected.

Bag and Possession Limits

Unless further restricted by refuge regulations, State bag and possession limits apply. Consult current Mississippi Department of Wildlife, Fisheries, and Parks Regulations for details.

General Area Regulations

The following are prohibited:

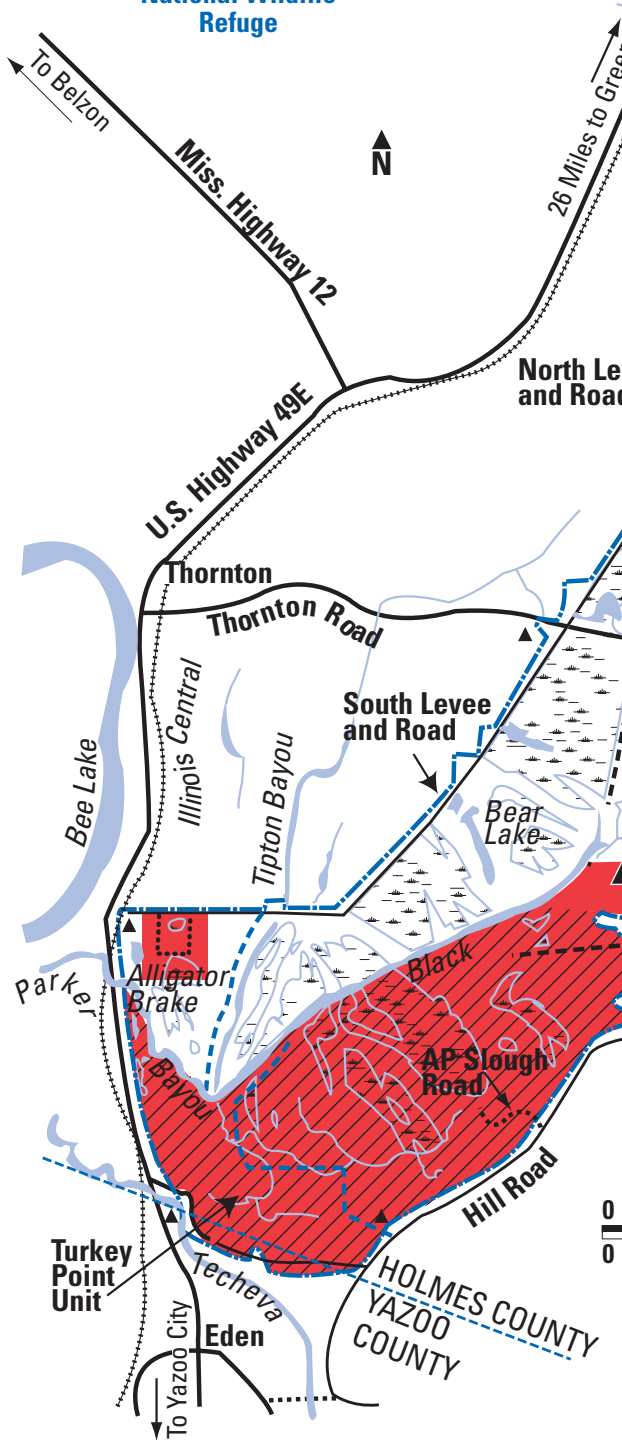
- operation of vehicles on "Closed" roads;
- all commercial activities including guiding or participating in a paid guided hunt;
- hunting from utility poles and in designated closed areas;

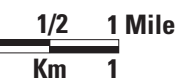
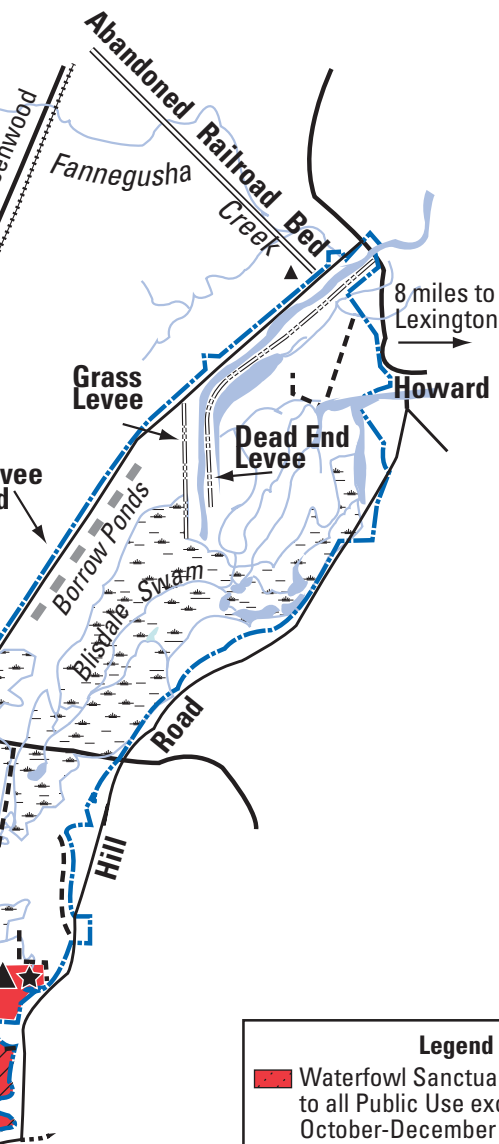
- the use of artificial light, including vehicle headlights, to locate or take any animal except as authorized in these regulations;
 - use or possession of .22 magnum and .17 caliber guns;
 - use or possession of toxic (lead) shot, buckshot and slugs;
 - driving or screwing a metal object into any tree or hunting from such a tree with existing metal objects;
 - the use or possession of climbing spikes;
 - use or possession of any drug or device for employing such drug for hunting;
 - use or possession of plastic flagging tape;
 - man drives;
 - handguns;
 - use or possession of alcohol;
 - camping;
 - fires;
 - horses and mules.
2. During all designated firearm seasons for deer, all other public use activities on that refuge are prohibited.
 3. Each person must wear at least 500 square inches of solid unbroken fluorescent orange material visible above the waistline during the rabbit with dog, quail, and refuge designated firearm seasons for deer [including archery on Farmers Home Administration Tracts (FmHA) during State deer season].
 4. No person shall cut or destroy any tree, shrub or bush on the refuge.
 5. By state law non-residents may not take antlerless deer.
 6. Deer must be field dressed prior to removal from refuge.
 7. Dogs are permitted for the squirrel, waterfowl, raccoon, quail and February rabbit hunts only.
 8. Valid permit holders may take hogs during refuge hunts with archery equipment and firearms as authorized for the specific hunt. Hogs may not be taken with the aid of dogs. Raccoon, opossum, coyote, beaver, bobcat and nutria may be taken during refuge hunts in accordance with State season.
 9. Crossbows are permitted only in accordance with State law.
 10. All hunters using shotguns must use approved non-toxic shot during refuge hunts. Squirrel and rabbit may be hunted with shotgun and .22 rimfire.

11. Firearms are allowed only during designated hunting seasons.
12. A loaded firearm is defined as shells in the gun or percussion caps on muzzleloaders.
13. During designated deer muzzleloader hunts, archery equipment and muzzleloaders loaded with a single ball are allowed. **Breech loading firearms, including 45-70s, are not allowed.**
14. It is unlawful to hunt from or shoot into a 100' zone along each side of pipeline and power line rights of way, designated roads, trails, levees or around parking lots. A person is considered hunting if they possess a loaded firearm, occupy a stand or blind, or have an arrow nocked in a bow (see maps).
15. Firearms transported in or on vehicles, ATVs, and boats under power must be unloaded and cased.
16. ATVs are permitted only on designated roads and ATV trails for hunting purposes and will not be allowed off trails to retrieve deer (see maps).
17. Vehicles should not obstruct roads, gates, turnrows, field access ramps, or firelanes and should be operated only on designated roads (see maps).
18. Boats left unattended for more than 72 hours will be considered abandoned and will be confiscated.
19. During designated deer firearm seasons, hunting from or shooting across open fields from ground level, or free-standing platforms or stands in open fields and tree plantations is prohibited. Stands adjacent to fields and tree plantations must be a minimum of 10 feet above ground.
20. Valid permit holders are allowed to possess and hunt from only one stand or blind, which must be visibly marked with a decal obtained from the Complex Headquarters. Non-permit holders and non consumptive users must also obtain a decal. A stand or blind left on the area does not reserve a hunting location. Any unmarked stand or blind will be confiscated. A stand or blind may be placed 48 hours prior to a hunt and must be removed within 48 hours after each designated deer hunt. A stand or blind remaining after 48 hours will be confiscated.
21. A youth hunter is defined as anyone under 16 years of age, must possess a Hunter Safety Course Card or Certificate and be in the immediate presence of an adult 21 years of age or older at all times. An adult may supervise only one youth. Youth hunters are not required to possess a Refuge Annual Public Use Permit.

Hillside NWR Unlimited Hunts

ATVs are permitted only on designated trails (see map) from September 15, 2008 - February 28, 2009.

Deer Archery Hunt

October 1 - November 21, 2008 and

December 13, 2008 - January 31, 2009

Beginning December 13, hunting is only allowed in the designated waterfowl hunt area (see map). The possession of firearms is prohibited. Legal to take: deer of either sex.

Raccoon with Dogs Hunt

October 1 - November 21, 2008 and

December 13, 2008 - January 31, 2009

Dogs are required. Beginning December 13, hunting is allowed only in the designated waterfowl hunt area (see map).

Squirrel with Dogs Hunt

October 18 - November 21, 2008 and

December 13, 2008 - February 28, 2009

Beginning December 16, hunting is allowed only in the designated waterfowl hunt area (see map).

Rabbit without Dogs Hunt

October 18 - November 21, 2008 and

December 13, 2008 - February 11, 2009

Beginning December 16, hunting is allowed only in the designated waterfowl hunt area (see map).

Deer Muzzleloader Hunt

November 26 - December 4, 2008

Either sex deer.

Rabbit with Dogs Hunt

February 12 - 28, 2009

Waterfowl Closed Area is open.

Duck, Merganser, and Coot Hunt

State season except during firearm deer hunts. Hunting is allowed only in the designated waterfowl hunt area (see map). There is no early teal season. Legal shooting hours are one-half hour before sunrise until 12 noon. Hunters must remove all decoys, blind material, and harvested waterfowl from the area no later than 1 pm each day.

Turkey: Closed

Trapping: Closed

Fishing

Fishing is permitted in the borrow ponds along the north levee (see map) throughout the year except during the firearm deer hunt. Fishing is permitted in the rest of the refuge with the exception of the waterfowl sanctuary March 1 through November 15. Trot lines, limb lines, jugs, seines, and traps are prohibited. Fishing from bridges is prohibited. State creel limits apply.

Frogging

Frogging is permitted during State bullfrog season. State limit.

Holt Collier NWR Unlimited Hunts

Deer Archery Hunt

October 1, 2008 - January 31, 2009

The possession of guns is prohibited. Either sex deer.

Rabbit with Dogs Hunt

February 1-28, 2009

Mathews Brake NWR Unlimited Hunts

Deer Archery Hunt

October 1, 2008 - January 31, 2009

From one day prior to the opening day of duck season thru March 1, hunting is allowed only in the designated waterfowl hunt area (see map). The possession of firearms is prohibited. Either sex deer.

Raccoon with Dogs Hunt

October 1 - November 21, 2008 and

December 13, 2008 - January 31, 2009

Dogs are required. Beginning December 13, hunting is allowed only in the designated waterfowl hunt area (see map).

Squirrel with Dogs Hunt

October 18, 2008 - February 28, 2009

Beginning December 1, hunting is allowed only in the designated waterfowl hunt area (see map).

Rabbit without Dogs Hunt

October 18, 2008 - February 11, 2009

Beginning December 1, hunting is allowed only in the designated waterfowl hunt area (see map).

Rabbit with Dogs Hunt

February 12-28, 2009

Duck, Merganser, and Coot Hunt

State season. **First two weekends in January 2009 are reserved for youth hunting.** Hunting is allowed only in designated waterfowl hunt area (see map). There is no early teal season. Legal shooting hours are one-half hour before sunrise until 12 noon. Hunters may not leave their equipment unattended at any time and must remove all decoys, blind material, and harvested waterfowl from the area no later than 1 pm each day. Hunters may enter the refuge after 12 noon the day before the first day of the State duck season and will be allowed to remain there until 1 pm the first day of duck season. After the first day of duck season, entry time will remain at 12 midnight.

Youth Hunt - Duck, Merganser and Coot

January 2-3 and 9-10, 2009 are reserved for youth hunting. Youth under the age of sixteen may hunt. Each youth is required to have documentation of completed Hunter Safety Course and be accompanied by an adult 21 years of age or older. Both youth and accompanying adult may hunt. Only one adult may accompany each youth.

Turkey: Closed

Trapping: Closed

Fishing

Fishing is permitted in all refuge waters throughout the year except for the waterfowl sanctuary which is closed from December 1 through March 15 (see map). **One day prior to opening day of duck season to closing day of duck season, refuge waters will be closed to all public use from 1 pm until 12 midnight.** Trot lines, limb lines, jugs, seines, and traps are prohibited. State creel limits apply.

Frogging

Frogging is permitted during State bullfrog season. State limit.

Morgan Brake NWR Unlimited Hunts

ATVs are permitted only on designated trails (see map) from September 15, 2008 - February 28, 2009.

Deer Archery Hunt

*October 1 - November 21, 2008 and
December 13, 2008 - January 31, 2009*

Beginning December 13, hunting is allowed only north of Providence Road and in the area west and south of Spring Branch (see map). The possession of guns is prohibited. Either sex deer.

Raccoon with Dogs Hunt

*October 1 - November 21, 2008 and
December 13, 2008 - January 31, 2009*

Dogs are required. Beginning December 13, hunting is allowed only in the designated waterfowl hunt area (see map).

Squirrel with Dogs Hunt

*October 18 - November 21, 2008 and
December 13, 2008 - February 28, 2009*

Beginning December 13, hunting is allowed only in the designated waterfowl hunt area (see map).

Rabbit without Dogs Hunt

*October 18 - November 21, 2008 and
December 13, 2008 - February 11, 2009*

Beginning December 13, hunting is allowed only in the designated waterfowl hunt area (see map).

Deer Muzzleloader Hunt
November 26 - December 4, 2008

Either sex deer.

Rabbit with Dogs Hunt
February 12 - 28, 2009

Hunting is allowed only in the designated waterfowl hunt area (see map).

Duck, Merganser, and Coot Hunt

State season except closed during muzzleloading gun deer hunt. Hunting is allowed only in the designated waterfowl hunt area (see map). There is no early teal season. Legal shooting hours are one-half hour before sunrise until 12 noon. Hunters must remove all decoys, blind material, and harvested waterfowl from the area no later than 1 pm each day.

Turkey: Closed

Trapping: Closed

Fishing

Fishing is permitted in refuge waters north of Providence Road throughout the year except during the firearm deer hunt. Trot lines, limb lines, jugs, seines, and traps are prohibited. State creel limits apply.

Frogging

Frogging is permitted only in refuge waters open to fishing during State bullfrog season. State limit.

Panther Swamp NWR

ATVs are permitted from September 15, 2008 through February 28, 2009, on designated trails only. Designated trails will be signed "All-Terrain Vehicle Trail" at the trails point of origin. All ATV's are required to enter and exit trails from the associated parking lot. *Example: ATV access to Gumbo Trail will be allowed only from Gumbo Acres parking lot.*

Panther Swamp NWR Limited Hunts

During limited hunts all harvested deer and turkeys must be tagged immediately and prior to being moved.

Applications for the Limited Firearm Hunts will be accepted only from **August 15 through September 30, 2008**. (See Permit, Stamp and License Requirements #4.) No more than 5 people may apply per application. Hunters may apply for only one Limited Deer Hunt at Panther Swamp NWR.

Deer Gun Hunt

November 22-24, 2008

Legal to take: one buck and one doe.

Deer Muzzleloader Hunt

December 2-7 or 9-14, 2008

Legal to take: One buck and one doe.

Panther Swamp NWR Unlimited Hunts

Deer Archery Hunt

October 1 - November 21, 2008 and

December 15, 2008 - January 31, 2009

Beginning December 15, hunting is allowed only in the designated waterfowl hunt area (see map). Either sex deer.

Raccoon with Dogs Hunt

October 1 - November 21, 2008, December 18-28, 2008 and

February 12-28, 2009

Beginning December 18, hunting is allowed only in the designated waterfowl hunt area (see map). Dogs are required.

Squirrel with Dogs Hunt

October 15 - November 21, 2008,

November 25 - December 1, 2008,

December 15, 2008 - January 25, 2009

February 12-28, 2009

Beginning December 15, hunting is allowed only in the designated waterfowl hunt area (see map).

Rabbit without Dogs Hunt

October 15 - November 21, 2008,

November 25 - December 1, 2008,

December 15, 2008 - January 25, 2009

Beginning December 15, hunting is allowed only in the designated waterfowl hunt area (see map).

Rabbit with Dogs Hunt

February 12 - 28, 2009

Quail with Dogs Hunt

February 12 - March 7, 2009

The Big Twist Hunting area and all refuge areas east of the Auxiliary Channel are open to walk-in only (see map).

Duck, Merganser, and Coot Hunt

State season except closed during all limited firearm deer hunts. **December 27-28, 2008, is restricted to youth hunting.** There is no early teal season. Legal shooting hours are 1/2 hour before sunrise until 12 noon. Hunters must remove all decoys, blind material and harvested waterfowl from the area no later than 1 pm each day.

Youth Hunt - Duck, Merganser, and Coot

December 27-28, 2008

Youth under the age of sixteen may hunt. Youth is required to have documentation of completed Hunter Safety Course and be accompanied by an adult 21 years of age or older. Both youth and accompanying adult may hunt. Only one adult may accompany each youth.

Spring Turkey Hunt

April 1 - May 1, 2009

Shotgun and archery only. No dogs allowed. Contact Complex Headquarters to obtain turkey tags prior to

March 1, 2009. Legal to take: two legal gobblers.

Trapping: Closed

Fishing

Waters between the East and West levees, the Landside Ditch, and the portion of Panther Creek adjacent to the West Levee, are open year-round except that all fishing is closed during firearm deer hunts. All other refuge waters are open from March 1 - November 15. Trot lines, limb lines, jugs, seines, and traps are prohibited. State creel limits apply.

Frogging

Frogging is permitted during State bullfrog season. State limit.

Yazoo NWR

All deer must be checked at Refuge Headquarters.

Motorized boats authorized in Silver Lake Bayou only.

Electronic gates are open 4 am - 8 pm.

Yazoo NWR Limited Hunts

Applications for the Limited Youth and Senior Citizen Deer Gun, Deer Muzzleloader, and January First Week Archery Hunts will be accepted **August 15 through September 30, 2008**. (See Permit, Stamp and License requirements.) Only one youth per application for the Youth Deer Gun Hunt. No more than 2 people may apply per application for the Senior Citizen Deer Gun, Deer Muzzleloader, and January First Week Archery Hunts.

Youth are permitted to apply for the Deer Youth Gun, January First Week Archery and the Deer Muzzleloader Hunts.

Senior citizens are permitted to apply for the Deer Senior Citizen Gun, January First Week Archery and the Deer Muzzleloader Hunt.

Deer Youth Gun Hunt

November 28 or 29, 2008

Youth age 11-15 may apply for only one day of the hunt. Each application must include the name and signature of an adult, 21 years of age or older, who will accompany the youth on the hunt. Youth is required to have documentation of completed Hunter Safety Course and only the youth may handle or discharge firearms. Each adult may supervise only one youth per day, is responsible for any violations by the youth they accompany and must possess a refuge brochure. All hunters and supervisors must check-in and check-out at refuge headquarters.

Legal to take: One deer of either sex.

Deer Senior Citizen Gun Hunt

December 17-18, 2008

Senior citizens, 65 years of age and older, may apply for this hunt. Legal to take: one buck and one doe.

Deer Muzzleloader Hunt

December 2-3, 5-6, or 12-13, 2008

You may apply for only one of the two day muzzleloader hunts. Legal to take: one buck and one doe.

Limited Deer Archery Hunt

January 2-8, 2009

Limited Draw Permit. Either sex deer.

Yazoo NWR Unlimited Hunts

Dove Hunt

State September Season

Open refugewide except permanent closed area.

Bucks only.

November 1 - 21, 2008

Either sex deer.

January 9 - 17, 2009

Either sex deer.

Farmers Home Administration (FmHA) Tracts

Only the Herron Tract and Brown Tract (east of the Sunflower River) may be hunted for deer archery and rabbit. The Carter Tract may be hunted for rabbit only. Public Use Permit required. Contact Complex Headquarters for maps and additional information.

All hunters and scouters must wear a minimum of 500 square inches of solid unbroken fluorescent orange material visible above the waistline at all times during the rabbit with dog and archers during all State firearm deer hunts.
