Dear Applicant:

Thank you for your interest in applying for a grant under the Teachers for a Competitive Tomorrow: Programs for Master's Degrees in Science, Technology, Engineering, Mathematics, or Critical Foreign Language Education (TCT-M program). We are pleased to provide the application booklet for the FY 2008 TCT-M competition. Included in this application booklet are the program statute and the instructions and forms needed to submit a complete application package to the U.S. Department of Education.

The TCT-M program provides up to five years of support for training teachers to become highly skilled in the areas of science, technology, engineering, mathematics, and/or critical foreign language, and for training professionals in these fields to earn Master's degrees in teaching that result in teacher certification. FY 2008 is the first year of this grant competition.

This letter highlights some items in the Fiscal Year (FY) 2008 application package that will be important to you in applying for grants under this program. You should review the entire application package thoroughly before preparing and submitting your application. Information on the TCT-M program is also accessible at the U.S. Department of Education (Department) Web site at:

For the FY 2008 grant competition, the Secretary has established an absolute priority and two invitational priorities. The Department requires all applicants to address the absolute priority and encourages applicants to address the invitational priorities. For additional information about the priorities, refer to the <u>Federal Register</u> Notice (Notice) inviting applications for new awards.

Applicants are also urged to carefully review the Statute and the Notice for important information concerning the critical terms used in this program. These include definitions for "high-need local educational agency" and for "children from low-income families," since it is necessary to document your compliance with these requirements.

Please be sure to review the entire application booklet for information concerning the TCT-M program.

The Department of Education is requiring that applications for FY 2008 grants under the TCT-M program be submitted electronically using Grants.gov. You are urged to acquaint yourself with the requirements of Grants.gov early. A more thorough discussion is included in this application package. Grants.gov is accessible through its portal page at:

We also urge you to consider the following three extremely important administrative factors if you are planning to apply for this program:

1. We strongly encourage you to register in Grants.gov early. The registration procedures may require 5 or more days to complete.

2. We strongly recommend that you <u>submit your application 2-3 days prior to the</u> <u>closing date</u>. The time it takes to upload an application will vary depending on your application and the speed of your Internet connection. The application submission process must be completed prior to the deadline for transmittal of applications.

3. In order to submit successfully, you must remember to provide the DUNS number on your application that was used when your organization registered with the CCR (Central Contractor Registry).

After you electronically submit your application, <u>you will first receive an e-mail from</u> <u>Grants.gov</u> acknowledging the date and time at which your application was received. You will receive a <u>second e-mail from Grants.gov</u> that will state that your application has been validated OR that your application was rejected with errors. If your application is validated, you will receive a <u>third e-mail</u> from the Department of Education with an assigned PR/ Award number, which is an ED-specified identifying number that is unique to your application. This third confirmation by e-mail, with a PR/Award number assigned, is the e-mail that verifies that your application was submitted on time by the closing date. This may take several days.

For information (including the dates and times) about how to submit your application electronically, please refer to the official Notice Inviting Applications for New Awards for FY 2008 published in the <u>Federal Register</u>.

You are reminded that the document published in the <u>Federal Register</u> (the Closing Date Notice) is the official document, and that you should not rely upon any information that is inconsistent with the guidance contained within the official document.

Finally, we would like to share with you the importance of ensuring that your application includes a strong evaluation plan. The peer reviewers will be instructed to look closely at the potential of applicants to successfully reach their individual project goals, which are driven by the program's performance indicators. The independent evaluation should include formative and summative measures, and the use of appropriate controls and appropriate evaluation methodologies. The evaluation plan should shape the development of the project from the beginning of the grant period and provide benchmarks for the monitoring of progress and measurement of that progress throughout the grant award period. The evaluation should also provide evidence that enables the differentiation between promising and seemingly ineffective practices. You should pay close attention to the information provided in the "Instructions for Project Narrative" section of this application regarding the development of your evaluation activity.

GRANT COMPETITION HIGHLIGHTS

1. Purpose of the TCT-M Program

The purpose of this program is to develop and implement 2- or 3-year part-time master's degree programs in science, technology, engineering, mathematics, or critical foreign language education for teachers in order to enhance the teachers' content knowledge and pedagogical skills, **or** develop and implement programs for professionals in science, technology, engineering, mathematics, or critical foreign language education that lead to a one-year master's degree in teaching that results in teacher certification.

2. Eligible Entities to Receive a TCT-M Program Grant

Institutions of higher education (IHEs) (as defined under section 101(a) of the Higher Education Act of 1965, as amended) that apply on behalf of a department of science, technology, engineering, mathematics, or a critical foreign language, or on behalf of a department or school that offers a competency-based degree program (in those content areas) that includes teacher certification.

Eligible applicants must enter into a "partnership" that <u>shall</u> include:

- 1. An eligible recipient
- 2. Either of the following:

(a) A department within the eligible recipient that provides a program of study in science, technology, engineering, mathematics, or a critical foreign language; **and** (b) a school, department, or program of education within the eligible recipient, **or** a 2-year institution of higher education that has a teacher preparation program offering or a dual enrollment program with the eligible recipient;

or

(c) A department or school within the eligible recipient with a competency-based degree program (in science, technology, engineering, mathematics, or a critical foreign language) that includes teacher certification;

3. Not less than one high-need local educational agency (LEA) and a public school or a consortium of public schools served by the agency.

A partnership <u>may</u> include a nonprofit organization that has a demonstrated record of providing expertise or support to meet the purposes of this initiative.

3. Definition of a High-Need Local Educational Agency

The term "high-need local educational agency" means a local educational agency or educational service agency—

1. (a) That serves not fewer than 10,000 children from low-income families; or

(b) For which not less than 20 percent of the children served by the agency are children from low-income families; or

(c) With a total of less than 600 students in average daily attendance at the schools that are served by the agency and all of whose schools are designated with a school locale code of 41, 42, or 43, as determined by the Secretary; and

2. (a) For which there is a high percentage of teachers providing instruction in academic subject areas or grade levels for which the teachers are not highly qualified; or

(b) For which there is a high teacher turnover rate or a high percentage of teachers with emergency, provisional, or temporary certification or licensure.

NOTE: See Section III, Number 3 Other, Eligibility Information, of the <u>Federal</u> <u>Register</u> Notice for further information on interpreting and documenting this requirement.

4. Definition of "children from low-income families"

The term ''children from low-income families'' means children described in section 1124(c)(1)(A) of the Elementary and Secondary Education Act of 1965 (20 U.S.C. 6333(c)(1)(A)).

NOTE: See Section III, Number 3 Other, Eligibility Information, of the <u>Federal</u> <u>Register</u> Notice for further information on interpreting and documenting this requirement.

5. Foreign Languages the Secretary Designated as "Critical"

The Secretary has designated the following foreign languages as critical: Arabic, Chinese, Japanese, Korean, Russian, Hindi, Urdu, Persian, and Turkish.

6. Program Activities Authorized under the TCT-M Program

Recipients may use federal funds for the activities and expenses outlined in the program statute – sections 6111 - 6116. Applicants are strongly urged to carefully review the content of the statute (Sec. 6114), which sets forth the authorized program activities. These activities are also reflected in the program's Selection Criteria and may be found on the Web at www.ed.gov/programs/tct.

NOTE: Under Sec. 6114(c)(8), tuition assistance <u>can</u> be provided to students in the TCT-M program, based on need, as appropriate.

Recipients may use federal funds for the activities and expenses outlined in the program statute – sections 6111 - 6116. Overall, required uses of grant funds as addressed in section 6114 include:

- Promote effective teaching skills so that program participants become more effective science, technology, engineering, mathematics, or critical foreign language teachers;
- Prepare teachers to assume leadership roles in their schools such as mentoring, teachers to develop curricula in science, technology, engineering, mathematics, or critical foreign language;
- Use high-quality research, laboratory, or internship experiences that are integrated with coursework;
- Provide student teaching or clinical classroom experience;
- Provide strategies for improving student literacy, if implementing a program in which participants are prepared to teach science, technology, engineering, mathematics, or critical foreign language courses;
- Align the content knowledge in the master's degree program with challenging student academic achievement standards and challenging academic content standards established by the State in which the program is conducted;
- Encourage participation of individuals who are members of groups underrepresented in teaching of science, technology, engineering, mathematics, or critical foreign languages; members of the Armed Forces transitioning to civilian life; and teachers in schools determined by the partnership to be most in need;
- Offer tuition assistance, based on need, as appropriate;
- Create opportunities for enhanced and ongoing professional development for teachers that improves their science, technology, engineering, mathematics and critical foreign language content knowledge and teaching skills; and
- Evaluate and report on the impact of your TCT-M project.

Applicants are strongly urged to carefully review the content of the statute (Sec. 6114), which sets forth the authorized program activities. These activities are also reflected in the program's Selection Criteria and may be found on the Web at: http://www.ed.gov/programs/tct.

7. Master's Program for Current Teachers

The master's program for current teachers (as described in Sections. 6111(2) and 6114(a)(1)) is expected to be complete in a 2-3 year period, on a part-time basis. This requirement is to ensure teachers keep teaching (at least on a part-time basis) while pursing graduate school. The master's degree is to be in a science, technology, engineering, mathematics, or critical foreign language education program rather than in teaching.

8. Master's Program for Professionals

As described in Sec. 6111(3) and Sec. 6114(a)(2), the master's program in teaching for professionals is expected to be completed in one year on a full-time basis. The degree must result in teacher certification. The degree would not be in a science, technology, engineering, mathematics, or a critical foreign language field.

9. Absolute Priority

Projects that propose programs in which the primary focus is on placing participants in high-need local educational agencies.

The Secretary shall reject any application that does not address this priority.

10. Invitational Priorities

Projects that propose to design specialized master's degree programs that enable native speakers of critical foreign languages to become credentialed teachers, or that directly engage native speakers in the preparation of teachers, or programs that are uniquely designed to train science, technology, engineering or mathematics professionals to become credentialed teachers.

Projects that propose to train prospective teachers in psychometrics, including training in developing, interpreting and using assessment results to improve classroom instruction and student achievement, or that provide teachers with experiences in rigorous research.

11. Restriction on the Amount of Indirect Costs that May be Charged to a TCT-M Program Grant

By rule, the Department requires that the maximum indirect cost rate that may be applied to grants with a "supplement not supplant" provision is 8 percent or the recipient's negotiated indirect cost rate (whichever is less). See section 75.563 of Education Department General Administrative Regulations (EDGAR) for information on the negotiated indirect cost rate. 12. Matching Requirement for the TCT-M Grant

Applicants must match TCT-M grant funds at 50 percent of the federal dollar amount awarded. The match may be in cash or in kind, but under no circumstances may it be made with federal funds nor can unrecovered indirect cost be used as match.

Applicants whose approved applications/budgets identified an amount of match that exceeds the statutory minimum for any project period must meet that higher amount.

We will reject your application if you do not include information about your proposed match.

13. Restriction on the Amount of Funding that Can Be Requested in Any Single Budget Period

Awards are limited to no more than \$250,000 in any single budget period for which funding is requested.

We will reject any application that proposes a budget exceeding \$250,000 for any single 12-month budget period over the five-year grant.

14. TCT-M Program's Reporting Requirements

As noted in Sec. 6114(d) of the program statute: Applicants who are awarded grants are required to submit annual performance reports indicating that they have made substantial progress in meeting project goals and objectives, and report other progress in addressing the GPRA indicator and additional performance measures (addressed below).

As required by the statute, recipients of a grant under this program shall evaluate, using measurable objectives and benchmarks, the extent to which the program succeeded in the following:

1. Increasing the number and percentage of science, technology, engineering, mathematics, or critical foreign language teachers who have a master's degree and meet one or more of the following criteria:

(a) are teaching in schools determined by the partnership to be "most in need", and taught in such schools prior to participation in the program;

(b) are teaching in schools determined by the partnership to be "most in need",

- and did not teach in such schools prior to participation in the program;
- (c) are members of a groups underrepresented in the teaching of science,
- technology, engineering, mathematics, or a critical foreign language.

2. Bringing professionals in science, technology, engineering, mathematics, or a critical foreign language into the field of teaching.

3. Retaining teachers who participate in the program.

Please review carefully the above referenced sections of the statute, which is included in this booklet.

Grant projects must report evidence of sufficient progress toward achieving program goals and annual project objectives to be on track to merit receipt of federal funds for the following year of the grant period. Should the Department determine that a grantee has not made substantial progress, it may withhold any payment to be made for the following year of the grant period and not make any further payment for the remaining years. Or, the Department may decrease the grant award for the following year.

It is the expectation of the Department that grant recipients will seek to continue to collect data on outcomes for student participants in their projects as long as possible, through the end of grant funding and into their teaching careers. Programs such as Teachers for a Competitive Tomorrow have long-term outcomes that extend beyond the life of their grant, and assessment of a program's success may lag behind the timespan of the Department's financial support. The only way to know the actual success or failure of

a project supported by this program is by following participant outcomes and those of the students taught by participants well into their teaching careers.

3. Estimated Funding And Project Period

Estimated Available Funds for FY 2008:	\$900,000

Estimated Average Size of Awards:	\$225,000
Estimated Number of Awards:	4
Project Period:	Up to 60 months

The U.S. Department of Education is not bound by these estimates.

4. Applicant Funding

The Department is sometimes unable to award the full amount of funds requested. Applicants should pay close attention to the "Award Information" section of the <u>Federal</u> <u>Register</u> Notice. The Department will not fund any application at an amount exceeding the applicable maximum award level. **The Secretary shall reject any application requesting in excess of \$250,000 in any year budget of period.**

5. Evaluation of Applications for Awards

A three-member panel of non-federal reviewers evaluates each application. Each reviewer assigns points for each selection criterion and prepares evaluation comments.

6. Selection Criteria

The Secretary evaluates an application on the basis of the criteria drawn from Section 6114 of the authorizing statute and from the broad criteria in 34 CFR Part 75, sections 75.209(a) and 75.210 of the Education Department General Administrative Regulations (EDGAR).

7. Notice to Successful Applicants

The Department's Office of Legislation and Congressional Affairs will inform the Congress regarding applications approved for TCT-M program grants. Successful applicants will receive award notices by mail shortly after the Congress is notified. No funding information will be released before the Congress is notified.

8. Notice to Unsuccessful Applicants

Unsuccessful applicants will be notified in writing following the notice to successful applicants.

9. Reasons that the Secretary Shall Reject an Application

Among the reasons that the Secretary shall reject an application are:

- Exceeding the page limits set forth in the <u>Federal Register</u> Notice;
- Submitting after the 4:30 p.m. Washington, DC time on the designated closing date;
- Failing to include information on the proposed match;
- Requesting more than \$250,000 in any budget period for which funding is sought; and/or
- Failing to provide documentation that the partnering LEA meets the "highneed" criteria as defined in the Notice; and/or
- Failing to address the absolute priority.

10. Appendices To Applications

Please limit the appendices to the following:

- Curricula vitae of key personnel
- Position descriptions for positions proposed for the project
- Letters of Support
- Documentation that the partner LEA meets the statutory requirement for a high-need LEA that serves children from low-income families.

<u>NOTE</u>: These appendices must be attached to the "Other Attachments Form" in the Grants.gov application package.

11. Annual Performance Report Requirements

If you receive a FY 2008 award, you will be required to submit annual and final performance reports during the funding cycle using the Department's reporting system. This Web-based system collects narratives and data about funded projects to enable program officers to determine if a grantee is making substantial progress toward meeting approved project objectives. The reporting system will be accessible approximately eight

weeks prior to the report due date. Your program officer will assist you in completing this report.

To facilitate your use of Grants.gov, this document includes important submission procedures you need to be aware of to ensure your application is received in a timely manner and accepted by the Department of Education.

ATTENTION

Applications submitted to Grants.gov for the Department of Education will be posted using Adobe forms. Therefore, applicants will need to download the latest version of Adobe reader (at least Adobe Reader 8.1.2). Information on computer and operating system compatibility with Adobe and links to download the latest version is available on Grants.gov. We strongly recommend that you review these details on <u>www.Grants.gov</u> before completing and submitting your application. In addition, applicants should submit their application a day or two in advance of the closing date as detailed below. Applicants will no longer need to use the PureEdge software to create or submit an application. If you have any questions regarding this matter please email the Grants.gov Contact Center at <u>support@grants.gov</u> or call 1-800-518-4726.

- REGISTER EARLY Grants.gov registration may take five or more business days to complete. You may begin working on your application while completing the registration process, but you cannot submit an application until all of the Registration steps are complete. For detailed information on the Registration Steps, please go to: <u>http://www.grants.gov/applicants/get_registered.jsp</u>. [Note: Your organization will need to update its Central Contractor Registry (CCR) registration annually.]
- 2) SUBMIT EARLY We strongly recommend that you do not wait until the last day to submit your application. Grants.gov will put a date/time stamp on your application and then process it after it is fully uploaded. The time it takes to upload an application will vary depending on a number of factors including the size of the application and the speed of your Internet connection, and the time it takes Grants.gov to process the application will vary as well. If Grants.gov rejects your application (see step three below), you will need to resubmit successfully before 4:30:00 p.m. Washington, DC time on the deadline date.

Note: To submit successfully, you must provide the DUNS number on your application that was used when your organization registered with the CCR (Central Contractor Registry).

3) VERIFY SUBMISSION IS OK – You will want to verify that Grants.gov and the Department of Education receive your Grants.gov submission timely and that it was validated successfully. Dial-Up Internet Connections

When using a dial up connection to upload and submit your application, it can take significantly longer than when you are connected to the Internet with a high-speed connection, e.g. cable modem/DSL/T1. While times will vary depending upon the size of your application, it can take a few minutes to a few hours to complete your grant submission using a dial up connection. Attaching Files – Additional Tips

Please note the following tips related to attaching files to your application:

1. Ensure that you only attach the Education approved file types detailed in the Federal Register application notice (.doc, .pdf or .rtf). Also, do not upload any password protected files to your application.

- 2. Grants.gov cannot process an application that includes two or more files that have the same name within a grant submission. Therefore, each file uploaded to your application package should have a unique file name.
- 3. When attaching files, applicants should limit the size of their file names. Lengthy file names could result in difficulties with opening and processing your application. We recommend you keep your file names to less than 50 characters. I. Funding Opportunity Description

<u>Purpose of Program</u>: The purpose of the program is to develop and implement 2- or 3-year part-time master's degree programs in science, technology, engineering, mathematics, or critical foreign language education for teachers in order to enhance the teachers' content knowledge and pedagogical skills; and to develop programs

for professionals in science, technology, engineering, mathematics, or critical foreign language that lead to a master's degree in teaching that results in teacher certification.

<u>Priorities</u>: We are establishing this priority for the FY 2008 grant competition and any subsequent year in which we make awards from the list of unfunded applicants from this competition, in accordance with section 437(d)(1) of the General Education Provisions Act (GEPA), 20 U.S.C.

1232(d)(1).

<u>Absolute Priority</u>: This priority is an absolute priority. Under 34 CFR 75.105(c)(3), we consider only applications that meet this priority.

This priority is:

Projects whose primary focus is on placing participants in high-need local educational agencies (LEAs). The definition of high-need LEA can be found in 20 U.S.C. 9812(3), and is described below.

Invitational Priorities:

Under this competition we are particularly interested in applications that address the following priorities.

For FY 2008 and any subsequent year in which we make awards from the list of unfunded applicants from this competition, these priorities are invitational priorities.

Under 34 CFR 75.105(c)(1) we do not give an application that meets these invitational priorities a competitive or absolute preference over other applications.

These priorities are:

Invitational Priority 1

Projects that propose to design specialized master's degree programs that enable native speakers of critical foreign languages to become credentialed teachers, or that directly engage native speakers in the preparation of teachers, or programs that are uniquely designed to train science, technology, engineering, or mathematics professionals to become credentialed teachers.

Invitational Priority 2

For purposes of this competition and any subsequent year in which we make awards from the list of unfunded applicants from this competition, critical foreign languages are defined as Arabic, Chinese, Japanese, Korean, Russian, Hindi, Urdu, Persian, and Turkish.

Waiver of Proposed Rulemaking: Under the Administrative Procedure Act (5 U.S.C. 553) the Department generally offers interested parties the opportunity to comment on proposed priorities and definitions. Section 437(d)(1) of GEPA, however, allows the Secretary to exempt from rulemaking requirements, regulations governing the first grant competition under a new or substantially revised program authority. This is the first grant competition for this program under 20 U.S.C. 9811, et seq. and therefore qualifies for this exemption. In order to ensure timely grant awards, the Secretary has decided to forego public comment on the absolute priority and the definition of critical foreign languages under section 437(d)(1) of GEPA. 1. <u>Eligible Applicants</u>: An institution of higher education on behalf of a department of science, technology, engineering, mathematics, or a critical foreign language, or on behalf of a department or school with a competencybased degree program (in science, technology, engineering, mathematics, or a critical foreign language) that includes

teacher certification. Eligible applicants must enter into a partnership that shall include:

i. An eligible applicant;

ii. (a) A department within the eligible applicant that provides a program of study in science, technology, engineering, mathematics, or a critical foreign language; and (b) A school, department, or program of education within the eligible applicant, or a two-year institution of higher education that has a teacher preparation offering or a dual enrollment program with the eligible applicant; or

iii. A department or school within the eligible applicant with a competency-based degree program (in science, technology, engineering, mathematics, or a critical foreign language) that includes teacher certification; and

iv. Not less than one high-need LEA and a public school or a consortium of public schools served by the agency.

A partnership may include a nonprofit organization that has a demonstrated record of providing expertise or support to meet the purposes of this initiative.

2 a. <u>Cost Sharing or Matching</u>: Under 20 U.S.C. 9815(b), each grant recipient must provide, from non-Federal sources, an amount equal to 50 percent of the

amount of the grant to carry out the activities supported by the grant.

b. <u>Supplement-Not-Supplant</u>: Under 20 U.S.C. 9815(c), grant funds provided under this program must be used to supplement, and not supplant, other Federal or State funds.

3. <u>Other</u>: Definition of "high-need LEA" and other eligibility information. An eligible applicant must propose a project performed by a partnership that includes one or more "high-need LEAs." As defined in 20 U.S.C. 9812(3), the term "high-need LEA" is an LEA--

(A)(1) That serves not fewer than 10,000 children from low-income families, or (2) for which not less than 20 percent of the children served by the LEA are from lowincome families, or (3) with a total of less than 600 students in average daily attendance at the schools that are served by the agency and all of whose schools are designated with a school locale code of 41, 42, or 43, as determined by the Secretary; and

(B)(1) for which there is a high percentage of teachers providing instruction in academic subject areas or grade levels for which the teachers are not highly qualified; or
(2) for which there is a high teacher turnover rate or a high percentage of teachers with emergency, provisional, or temporary certification or licensure.

So that the Department may be able to confirm the eligibility of the LEAs participating in the project, applicants are expected to include information in their applications that demonstrates that each participating LEA in the partnership is a high-need LEA, as defined in 20 U.S.C. 9812(3). Generally, this information should be based on the most recent available data on the number of children from low-income families that the LEA serves. Under components (A)(1) and (A)(2) of the statutory definition of high-need LEA, an LEA must show that it serves not fewer than 10,000 children from low-income families or that not less than 20 percent of the children served by the agency are children from low-income families. Under 20 U.S.C 9812(1), the term "children from low-income families" means children described in section 1124(c)(1)(A) of the Elementary and Secondary Education Act of 1965 (ESEA), 20 U.S.C. 6333(c)(1)(A). The eligibility of an LEA as a "high-need LEA" under component (A)(1) or (A)(2) will be determined on the basis of the most recent U.S. Census Bureau data. The school locale codes referenced in component (A)(3) of the definition of "high-need LEA" are part of a classification system designed to describe a geographic area in which a school is located. With regard to component (B)(1) of the definition of "high-need LEA," for purposes of this program, an LEA has "a high percentage of teachers providing instruction in the academic subject areas or grade levels for which the teachers are not highly qualified" if the percentage of its classes taught by teachers who are not highly qualified

exceeds the percentage for the State. The Department expects that LEAs that rely on component (B)(1) of the definition will demonstrate their eligibility with information regarding the percentage of teachers providing instruction in the academic subject areas or grade levels for which the teachers are not highly qualified in the LEA and the State.

For component (B)(2) of the definition of "high-need LEA," the data that LEAs likely will find most readily available on the percentage of teachers with emergency, provisional, or temporary certification or licensing are the data they provide to their States for inclusion in the reports on the quality of teacher preparation that the States provide to the Department in October of each year as required by Section 207 of the Higher Education Act of 1965, as amended (HEA). In these reports, States provide the percentage of teachers in their LEAs teaching on waivers of State certification, both on a statewide basis and in high-poverty LEAs. The "provisional" HEA Title II accountability data for the national percentage of teachers on waivers to full State certification is 1.5 percent for the 2006-2007 reporting year.

Because the Department is in the process of certifying all data received in the October 2007 State HEA Section 207

reports, the data in these reports, including the national average of teachers on waivers of State certification, are still provisional. However, to provide adequate time for the preparation and review of project applications and award of new grants, the Department will use the 1.5 percent national average for the purpose of this competition. Accordingly, an LEA will be considered to have met component (B)(2) of the definition if the data that it provided to the State for the purpose of the State's October 2007 HEA Section 207 report demonstrate that at least 1.5 percent of its teachers were on waivers of State certification requirements.

Consistent with the methodology the Department uses in the Transition to Teaching Program, in which participating LEAs were required to be "high-need LEAs" (as defined in Section 2102(3) of the ESEA), the Department will determine that an LEA with over 1.5 percent of its teachers having emergency, provisional, or temporary certification or licensing (i.e., teachers on waivers), as reflected in data the State uses to compile its October 2007 State report, has a "high percentage" of its teachers in this category. We expect that an LEA that chooses not to rely on the data provided to the State for purposes of October 2007 reporting required by Section 207 of the HEA will provide

other evidence that demonstrates that it meets the eligibility requirement under component (B)(2) of the statutory definition of "high-need LEA." Moreover, should an LEA with a percentage of teachers on waivers of less than 1.5 percent believe it, too, has a "high percentage" of its teachers with emergency, provisional, or temporary certification or licensing, the Department will determine whether that LEA meets element (B)(2) of the definition of high-need LEA on a case-by-case basis.

Under element (B)(2), an LEA may also demonstrate that it is "high-need" by demonstrating that it has a high teacher turnover rate. For this program, we adopt the standard used in the Teacher Quality Enhancement Grants Program, under which the Department considers "high teacher turnover" to be an attrition rate among classroom teachers of 15 percent or more over the last three school years. AUTHORIZING LEGISLATION

PUBLIC LAW 110-69 – AMERICA COMPETES ACT OF 2007 TITLE VI—EDUCATION Subtitle A—Teacher Assistance PART I—TEACHERS FOR A COMPETITIVE TOMORROW

SEC. 6111. PURPOSE.

The purpose of this part is—

(1) to develop and implement programs to provide integrated courses of study in science, technology, engineering, mathematics, or critical foreign languages, and teacher education, that lead to a baccalaureate degree in science, technology, engineering, mathematics, or a critical foreign language, with concurrent teacher certification;

(2) to develop and implement 2- or 3-year part-time master's degree programs in science, technology, engineering, mathematics, or critical foreign language education for teachers in order to enhance the teachers' content knowledge and pedagogical skills; and

(3) to develop programs for professionals in science, technology, engineering, mathematics, or critical foreign language education that lead to a master's degree in teaching that results in teacher certification.

SEC. 6112. DEFINITIONS.

In this part:

(1) CHILDREN FROM LOW-INCOME FAMILIES.—The term "children from low-income families" means children described in section 1124(c)(1)(A) of the Elementary and Secondary Education Act of 1965 (20 U.S.C. 6333(c)(1)(A)).

(2) ELIGIBLE RECIPIENT.—The term "eligible recipient" means an institution of higher education that receives grant funds under this part on behalf of a department of science, technology, engineering, mathematics, or a critical foreign language, or on behalf of a department or school with a competency-based degree program (in science, technology, engineering, mathematics, or a critical foreign language) that includes teacher certification, for use in carrying out activities assisted under this part.

(3) HIGH-NEED LOCAL EDUCATIONAL AGENCY.—The term "high-need local educational agency" means a local educational agency or educational service agency—(A)(i) that serves not fewer than 10,000 children from low-income families;

- (ii) for which not less than 20 percent of the children served by the agency are children from low-income families;
 or
- (iii)with a total of less than 600 students in average daily attendance at the schools

that are served by the agency and all of whose schools are designated with a school locale code of 41, 42, or 43, as determined by the Secretary; and

- (B)(i) for which there is a high percentage of teachers providing instruction in academic subject areas or grade levels for which the teachers are not highly qualified; **or**
 - (ii) for which there is a high teacher turnover rate or a high percentage of teachers with emergency, provisional, or temporary certification or licensure.

(4) HIGHLY QUALIFIED.—The term "highly qualified" has the meaning given such term in section 9101 of the Elementary and Secondary Education Act of 1965 (20 U.S.C. 7801) and, with respect to special education teachers, in section 602 of the Individuals with Disabilities Education Act (20 U.S.C.1401).

(5) PARTNERSHIP.—The term "partnership" means a partnership that—

(A) shall include—

(i) an eligible recipient;

(a) a department within the eligible recipient that provides a program of study in science, technology, engineering, mathematics, or a critical foreign language; and

(b) a school, department, or program of education within the eligible recipient, or a 2-year institution of higher education that has a teacher preparation offering or a dual enrollment program with the eligible recipient; or

(ii)

a department or school within the eligible recipient with a competencybased degree program (in science, technology, engineering, mathematics, or a critical foreign language) that includes teacher certification; and

- (iii) not less than 1 high-need local educational agency and a public school or a consortium of public schools served by the agency; and
- (B) may include a nonprofit organization that has a demonstrated record of providing expertise or support to meet the purposes of this part.

(6) TEACHING SKILLS.—The term "teaching skills" means the ability to—

(A) increase student achievement and learning and increase a student's ability to apply knowledge;

- (B) effectively convey and explain academic subject matter;
- (C) employ strategies grounded in the disciplines of teaching and learning that-
 - (i) are based on scientifically valid research;
 - (ii) are specific to academic subject matter; and
 - (iii) focus on the identification of students' specific learning needs, particularly students with disabilities, students who are limited English proficient, students who are gifted and talented, and students with low literacy levels, and the tailoring of academic instruction to such needs;

(D) conduct ongoing assessment of student learning;(E) effectively manage a classroom; and(F) communicate and work with parents and guardians, and involve parents and guardians in their children's education.

SEC. 6113. PROGRAMS FOR BACCALAUREATE DEGREES IN SCIENCE, TECHNOLOGY, ENGINEERING, MATHEMATICS, OR CRITICAL FOREIGN LANGUAGES, WITH CONCURRENT TEACHER CERTIFICATION.

(Not Applicable to this competition)

SEC. 6114. PROGRAMS FOR MASTER'S DEGREES IN SCIENCE, TECHNOLOGY, ENGINEERING, MATHEMATICS, OR CRITICAL FOREIGN LANGUAGE EDUCATION.

(a) PROGRAM AUTHORIZED.—From the amounts made available to carry out this section under section 6116(2) and not reserved under section 6115(d) for a fiscal year, the Secretary is authorized to award grants, on a competitive basis, to eligible recipients to enable the partnerships served by the eligible recipients to develop and implement—

(1) 2- or 3-year part-time master's degree programs in science, technology, engineering, mathematics, or critical foreign language education for teachers in order to enhance the teacher's content knowledge and teaching skills; or

(2) programs for professionals in science, technology, engineering, mathematics, or a critical foreign language that lead to a 1-year master's degree in teaching that results in teacher certification.

(b) APPLICATION.—Each eligible recipient desiring a grant under this section shall submit an application to the Secretary at such time and in such manner as the Secretary may require. Each application shall describe—

(1) how a department of science, technology, engineering, mathematics, or a critical foreign language will ensure significant collaboration with a school, department, or program of education in the development of the master's degree programs authorized under subsection (a), or how a department or school with a competency-based degree program has ensured, in the development of a master's degree program, the provision of rigorous studies in science, technology, engineering, mathematics, or a critical foreign language that enhance the teachers' content knowledge and teaching skills;

(2) the role of the local educational agency in the partnership in developing and administering the program and how feedback from the local educational agency, school, and participants will be used to improve the program;

(3) how the program will help increase the percentage of highly qualified mathematics, science, or critical foreign language teachers, including increasing the percentage of such teachers teaching in schools determined by the partnership to be most in need;

(4) how the program will—

(A) improve student academic achievement in mathematics, science, and, where applicable, technology and engineering and increase the number of students taking upper-level courses in such subjects; or(B) increase the numbers of elementary school and secondary school students

enrolled and continuing in critical foreign language courses;

(5) how the program will prepare participants to become more effective science, technology, engineering, mathematics, or critical foreign language teachers;

(6) how the program will prepare participants to assume leadership roles in their schools;

(7) how teachers (or science, technology, engineering, mathematics, or critical foreign language professionals) who are members of groups that are underrepresented in the teaching of science, technology, engineering, mathematics, or critical foreign languages and teachers from schools determined by the partnership to be most in need will be encouraged to apply for and participate in the program;

(8) the ongoing activities and services that will be provided to graduates of the program;

(9) how the partnership will continue the activities assisted under the grant when the grant period ends;

(10) how the partnership will assess, during the program, the content knowledge and teaching skills of the program participants; and

(11) methods to ensure applicants to the master's degree program for professionals in science, technology, engineering, mathematics, or a critical foreign language demonstrate advanced knowledge in the relevant subject.

(c) AUTHORIZED ACTIVITIES.—Each eligible recipient receiving a grant under this section shall use the grant funds to develop and implement a 2- or 3-year part-time master's degree program in science, technology, engineering, mathematics, or critical foreign language education for teachers in order to enhance the teachers' content knowledge and teaching skills, or programs for professionals in science, technology, engineering, mathematics, or a critical foreign language that lead to a 1-year master's degree in teaching that results in teacher certification. The program shall—

(1) promote effective teaching skills so that program participants become more effective science, technology, engineering, mathematics, or critical foreign language teachers;

(2) prepare teachers to assume leadership roles in their schools by participating in activities such as teacher mentoring, development of curricula that integrate state of the art applications of science, technology, engineering, mathematics, or critical foreign language into the classroom, working with school administrators in establishing in-service professional development of teachers, and assisting in evaluating data and assessments to improve student academic achievement;

(3) use high-quality research, laboratory, or internship experiences for program participants that are integrated with coursework;

(4) provide student teaching or clinical classroom experience;

(5) if implementing a program in which participants are prepared to teach science, technology, engineering, mathematics, or critical foreign language courses, provide strategies for improving student literacy;

(6) align the content knowledge in the master's degree program with challenging student academic achievement standards and challenging academic content standards established by the State in which the program is conducted;

(7) encourage the participation of—

(A) individuals who are members of groups that are underrepresented in the teaching of science, technology, engineering, mathematics, or critical foreign languages;

(B) members of the Armed Forces who are transitioning to civilian life; and(C) teachers teaching in schools determined by the partnership to be most in need;

(8) offer tuition assistance, based on need, as appropriate;

(9) create opportunities for enhanced and ongoing professional development for teachers that improves the science, technology, engineering, mathematics, and critical foreign language content knowledge and teaching skills of such teachers; and

(10) evaluate and report on the impact of the program, in accordance with subsection (d).

(d) EVALUATION AND REPORT.—Each eligible recipient receiving a grant under this section shall evaluate, using measurable objectives and benchmarks, and provide an annual report to the Secretary regarding, the extent to which the program assisted under this section succeeded in the following:

(1) Increasing the number and percentage of science, technology, engineering, mathematics, or critical foreign language teachers who have a master's degree and meet 1 or more of the following requirements:

(A) Are teaching in schools determined by the partnership to be most in need, and taught in such schools prior to participation in the program.

(B) Are teaching in schools determined by the partnership to be most in need, and did not teach in such schools prior to participation in the program.

(C) Are members of a group underrepresented in the teaching of science,

technology, engineering, mathematics, or a critical foreign language.

(2) Bringing professionals in science, technology, engineering, mathematics, or a critical foreign language into the field of teaching.

(3) Retaining teachers who participate in the program.

SEC. 6115. GENERAL PROVISIONS.

(a) DURATION OF GRANTS.—The Secretary shall award each grant under this part for a period of not more than 5 years.

(b) MATCHING REQUIREMENT.—Each eligible recipient that receives a grant under this part shall provide, from non-Federal sources, an amount equal to 50 percent of the amount of the grant (which may be provided in cash or in kind) to carry out the activities supported by the grant.

(c) SUPPLEMENT, NOT SUPPLANT.—Grant funds provided under this part shall be used to supplement, and not supplant, other Federal or State funds.

(d) EVALUATION.—From amounts made available for any fiscal year under section 6116, the Secretary shall reserve such sums as may be necessary—

(1) to provide for the conduct of an annual independent evaluation, by grant or by contract, of the activities assisted under this part, which shall include an assessment of the impact of the activities on student academic achievement; and

(2) to prepare and submit an annual report on the results of the evaluation described in paragraph (1) to the Committee on Health, Education, Labor, and Pensions of the Senate, the Committee on Education and Labor of the House of Representatives, and the Committees on Appropriations of the Senate and House of Representatives.

INTERGOVERNMENTAL REVIEW OF FEDERAL PROGRAMS

This appendix applies to each program that is subject to the requirements of Executive Order 12372 (Intergovernmental Review of Federal Programs) and the regulations in 34 CFR Part 79.

The objective of the Executive order is to foster an intergovernmental partnership and to strengthen federalism by relying on State and local processes for State and local government coordination and review of proposed Federal financial assistance.

GENERAL EDUCATION PROVISIONS ACT (GEPA) SECTION 427

Section 427 of GEPA requires all applicants for new awards to include in their applications a description of the steps the applicant proposes to take to ensure equitable access to, and participation in, its federally-assisted programs for students, teachers, and other program beneficiaries with special needs. The provision allows applicants discretion in developing the required description. The statute highlights six types of barriers that can impede equitable access or participation: *gender, race, national origin, color, disability, or age.*

A general statement of an applicant's nondiscriminatory hiring policy is not sufficient to meet this requirement. Applicants must identify potential barriers and explain steps they will take to overcome these barriers.

NOTES:

- Applicants for new awards must include information in their applications to address this provision in order to receive funding under this program.

GOVERNMENT PERFORMANCE AND RESULTS ACT (GPRA)

What is GPRA?

The Government Performance and Results Act of 1993 (GPRA) is a straightforward statute that requires all federal agencies to manage their activities with attention to the consequences of those activities. Each agency is to clearly state what it intends to accomplish, identify the resources required, and periodically report their progress to the Congress. In so doing, it is expected that the GPRA will contribute to improvements in accountability for the expenditures of public funds, improve Congressional decision-making through more objective information on the effectiveness of federal programs, and promote a new government focus on results, service delivery, and customer satisfaction.

How has the Department of Education Responded to the GPRA Requirements?

As required by GPRA, the Department of Education has prepared a strategic plan for **2007-2012**. This plan reflects the Department's priorities and integrates them with its mission and program authorities and describes how the Department will work to improve education for all children and adults in the U.S. The Department's goals, as listed in the plan, are:

What are the Performance Indicators for the Teachers for a Competitive Tomorrow: Programs for Master's Degrees in Science, Technology, Engineering, Mathematics, or Critical Foreign Language Education (TCT-M program)?

The TCT-M Program is part of the Department's plan for meeting Goals 2 and 3: "Increase the Academic Achievement of All High School Students" and "...Better Prepare Students and Adults for Employment and Future Learning."

Among the Department's objectives for Goal 2 is that we "promote advanced proficiency in science and mathematics for all students" and that we "increase proficiency in criticalneed foreign languages." Among the Department's objectives for Goal 3 is to "increase success in and completion of quality postsecondary education;" among the implementation strategies for this objective is to "prepare more graduates for employment in areas of vital interest to the United States, especially in critical-need languages, mathematics, and the sciences."

The Department's specific goal for the TCT-M Program "is to place program completers in high-need local educational agencies." The performance indicators are as follows:

1. The percentage of program participants who earn a Master's degree and certification or licensure in a science, technology, engineering, mathematics, or critical foreign language area (includes previously licensed teachers who receive a Master's degree).

3. The percentage of program participants who remain teaching in the science, technology, engineering, mathematics/ critical foreign language area in a high-need school for two or more years.

4. The cost per program participant who remains in teaching in the science, technology, engineering, mathematics/ critical foreign language area in a high-need school for two or more years.

How does the Department of Education determine whether performance goals have been met?

An applicant that receives a grant award will be required to submit annual progress reports and a final report as a condition of the award. The reports will document the extent to which project goals and objectives are met.

The Department of Education Abstract Form is where you attach your project abstract.

The <u>Project Narrative Attachment Form</u> is where you address the selection criteria that reviewers use to evaluate your application. As a guide for reviewers, applicants are encouraged to label each section in the narrative by its associated criterion. You must limit the project narrative to no more than 50 double-spaced pages. Applications that exceed this page limit will not be considered for funding and will be returned to the applicant. A page is 8.5 inches by 11 inches, on one side only, with 1-inch margins at the top, bottom, and both sides. Double space all text in the application narrative, including titles, headings, footnotes, quotations, references, and captions, as well as all text in charts, tables, figures and graphs. Use a font that is 12 point or larger.

You must use one of the following fonts: Times New Roman, Courier, Courier New, or Arial. Applications submitted in any other font, (including Times Roman and Arial Narrow) will not be accepted. The page limits do not apply to the Budget Summary Form and Narrative, the one-page abstract, other application forms attached in the "Other Attachments Form" section, or the assurances and certifications. We will reject your application if you do not apply these standards and exceed the page limit.

The <u>Budget Narrative Attachment Form</u> is where you describe your proposed multiyear project activities and present a multiyear budget. Section 75.112(b) of the Education Department General Administrative Regulations (EDGAR) requires that applications include "a narrative that describes how and when, in each budget period of the project, the applicant plans to meet each objective of the project." In addition, projects must complete form SF-524A and SF 524-B for all budget years of the proposed project, and <u>you must include proposed annual spending for cost share/match for each project year</u>. Further instructions are available in the budget form found in this package.

The match on TCT-M grants is 50 percent of the federal award. Applications that do not include a proposed cost share budget and narrative will be rejected.

SELECTION CRITERIA

(7 points)

B. The role of the local educational agency in the partnership in developing and administering the program and how feedback from the local educational agency, school, and participants will be used to improve the program. (4 points)

C. How the program will help increase the percentage of highly qualified mathematics, science, or critical foreign language teachers, including increasing the percentage of such teachers teaching in schools determined by the partnership to be most in need. (4 points)

D. How the program will improve student academic achievement in mathematics, science, and, where applicable, technology and engineering and increase the number of students taking upper-level courses in such subjects; **or**

How the program will increase the numbers of elementary school and secondary school students enrolled and continuing in critical foreign language courses. (4 points)

E. How the program will prepare participants to become more effective science, technology, engineering, mathematics, or critical foreign language teachers. (4 points)

F. How the program will encourage the participation of:

- (a) individuals who are members of groups that are underrepresented in the teaching of science, technology, engineering, mathematics, or critical foreign languages;

The Secretary considers the adequacy of resources for the proposed project. In determining the adequacy of resources for the proposed project the Secretary considers the following factors—

A. The adequacy of support, including facilities, equipment, supplies, and other resources, from the applicant organization or the lead applicant organization. (**3 points**)

B. The extent to which the costs are reasonable in relation to the objectives, design, and potential significance of the proposed project. (**7 points**)

V. QUALITY OF THE MANAGEMENT PLAN (5 points)

The Secretary considers the quality of the management plan for the proposed project. In determining the quality of the management plan for the proposed project, the Secretary considers the following factors—

A. The adequacy of the management plan to achieve the objectives of the proposed project on time and within budget, including clearly defined responsibilities, timelines, and milestones for accomplishing project tasks. (**3 points**)

B. The extent to which the time commitments of the project director and principal investigator and other key project personnel are appropriate and adequate to meet the objectives of the proposed project. (2 points)

VI. QUALITY OF THE PROJECT EVALUATION (25 Points)

The Secretary considers the quality of evaluation to be conducted of the proposed project. In determining the quality of the evaluation, the Secretary considers the following factors—

A. The extent to which the methods of evaluation include the use of objective performance measures that are clearly related to the intended outcomes of the project and will produce quantitative and qualitative data to the extent possible. (13 points)

B. The extent to which the methods of evaluation will provide performance feedback and permit periodic assessment of progress toward achieving intended outcomes. (12 points)

VII. ABSOLUTE PRIORITY (No Points)

Priority shall be given to applications whose primary focus is on placing participants in highneed local educational agencies.

Applicants should discuss how they will address this priority. While no points will be awarded, applications that fail to address this priority shall be rejected.

(1) Research conducted in established or commonly accepted educational settings, involving normal educational practices, such as (a) research on regular and special education instructional strategies, or (b) research on the effectiveness of or the comparison among instructional techniques, curricula, or classroom management methods.

(2) Research involving the use of educational tests (cognitive, diagnostic, aptitude, achievement), survey procedures, interview procedures or observation of public behavior, unless: (a) information obtained is recorded in such a manner that human subjects can be identified, directly or through identifiers linked to the subjects; and (b) any disclosure of the human subjects' responses outside the research could reasonably place the subjects at risk of criminal or civil liability or be damaging to the subjects' financial standing, employability, or reputation. If the subjects are children, exemption 2 applies only to research involving educational tests and observations of public behavior when the investigator(s) do not participate in the activities being observed. Exemption 2 does not apply if children are surveyed or interviewed or if the research involves observation of public behavior and the investigator(s) participate in the activities being observed. [Children are defined as persons who have not attained the legal age for consent to treatments or procedures involved in the research, under the applicable law or jurisdiction in which the research will be conducted.]

(3) Research involving the use of educational tests (cognitive, diagnostic, aptitude, achievement), survey procedures, interview procedures or observation of public behavior that is not exempt

under section (2) above, if the human subjects are elected or appointed public officials or candidates for public office; or federal statute(s) require(s) without exception that the confidentiality of the personally identifiable information will be maintained throughout the research and thereafter.

(4) Research involving the collection or study of existing data, documents, records, pathological specimens, or diagnostic specimens, if these sources are publicly available or if the information is recorded by the investigator in a manner that subjects cannot be identified, directly or through identifiers linked to the subjects.

(5) Research and demonstration projects which are conducted by or subject to the approval of department or agency heads, and which are designed to study, evaluate, or otherwise examine: (a) public benefit or service programs; (b) procedures for obtaining benefits or services under those programs; (c) possible changes in or alternatives to those programs or procedures; or (d) possible changes in methods or levels of payment for benefits or services under those programs.

(6) Taste and food quality evaluation and consumer acceptance studies, (a) if wholesome foods without additives are consumed or (b) if a food is consumed that contains a food ingredient at or below the level and for a use found to be safe, or agricultural chemical or environmental contaminant at or below the level found to be safe, by the Food and Drug Administration or approved by the Environmental Protection Agency or the Food Safety and Inspection Service of the U.S. Department of Agriculture.
