REA SPECIFICATIONS FOR RURAL TELEPHONE FACILITIES

Proposed Revisions in REA Specifications for Plastic-Insulated Wires and Cables

Notice is hereby given that, pursuant to the Rural Electrification Act, as amended (7 U.S.C. 901 et seq.), including the amendment thereto enacted by Pub. L. 93-32, REA proposes to issue Bulletins 345-13, -14, -20, -29, -67, and -48 to announce revisions in REA Specifications PE-22, -23, -28, -38, -39, and -50, respectively for plastic-insulated wires and cables. On issuance of these bulletins, Appendix A to Part 1701 will be modified accordingly.

Persons interested in these revisions may submit written data, views or comments to the Director, Telephone Operations and Standards Division, Rural Electrification Administration, Room 1355, South Building, U.S. Department of Agriculture, Washington, D.C. 20250, not later than January 7, 1974. All written submissions made pursuant to this notice will be made available for public inspection at the Office of the Director, Telephone Operations and Standards Division during regular business hours.

A copy of the revision of each of these specifications may be secured in person or by written request from the Director, Telephone Operations and Standards Division.

The text of REA Bulletin 345-13 announcing the revision of REA Specifica-

tion PE-22 is as follows (the changes described will also apply to the other specifications mentioned herein):

REA BULLETIN 345-13

SUBJECT: REA Specification for Telephone Cable for Aerial and Underground Duct Applications.

REA Specification PE-22 has been modified relative to the melt flow rate requirements on the finished cable jacket material.

With the introduction on the market of newer resins for cable jacketing applications, it has been necessary to revise the melt flow rate requirement in the specification. The melt flow rate requirement in Paragraph 11.5 is hereby revised to read as follows:

Melt flow rate	Copolymer (appendix E)	
	Melt index	Percent increase
Percent increase from raw material, maximum-----	0.1700-0.2099	90
	0.2100-0.3099	85
	0.3100-0.5000	50

TRANSITION AREA

Proposed Alteration

The Federal Aviation Administration is considering an amendment to Part 71

of the Federal Aviation Regulations which would alter the transition area at Kalispell, Mont.

Interested person may participate in the proposed rule making by submitting such written data, views, or arguments as they may desire. Communications should be submitted in triplicate to the Chief, Air Traffic Division, Federal Aviation Administration, Park Hill Station P.O. Box 7213, Denver, Colorado 80207. All communications received on or before January 2, 1974, will be considered before action is taken on the proposed amendment. No public hearing is contemplated at this time, but arrangements for informal conferences with Federal Aviation Administration officials may be made by contacting the Regional Air Traffic Division Chief. Any data, views, or arguments presented during such conferences must also be submitted in writing in accordance with this notice in order to become part of the record for consideration. The proposal contained in this notice may be changed in the light of comments received.

A public docket will be available for examination by interested persons in the office of the Regional Counsel, Federal Aviation Administration, 10455 E. 25th Avenue, Aurora, Colorado 80010.

On October 15, 1973, a rule was published in the FEDERAL REGISTER (38 FR 28555) which altered the transition area at Kalispell, Mont. The amendment was effective December 6, 1973. Flight Standards has now authorized transition routes to the Smith Lake NDB used in association with the ILS Rwy 1 approach procedure. Therefore, it is necessary to further amend the 1200-foot transition area to provide controlled airspace for approved transition routes.

In consideration of the foregoing, the FAA proposes the following airspace action:

In § 71.181 (38 FR 510) the description of the 1200-foot transition area at Kalispell, Mont., as designated by 38 FR 28555 is further amended to read:

That airspace extending upward from 1200 feet above the surface within 5.5 miles east and 15.5 miles west of the Kalispell VOR 166° radial extending from the 700-foot transition area to 18.5 miles south of the VOR; within 5.5 miles southeast and 9.5 miles southwest of the 035° and 215° bearings from the Smith Lake NDB extending from 7.5 miles northeast of the NDB to 18.5 miles southwest of the NDB excluding the 700-foot transition area.

This amendment is proposed under authority of section 307(a) of the Federal Aviation Act of 1958, as amended (49 U.S.C. 1348(a)), and of section 6(c) of the Department of Transportation Act (49 U.S.C. 1655(c)).
