# Proposed Decision to Re-Issue Hazardous Waste Permit Black Hawk County Landfill, Waterloo, Iowa

#### INTRODUCTION

The U.S. Environmental Protection Agency (EPA) Region 7 invites the public to review and comment on the proposed decision to reissue a post-closure permit for storing hazardous wastes at the Black Hawk County Landfill. Hazardous wastes were disposed in the landfill from the time it was opened in July 1975 until 1985. The wastes included hazardous wastewater treatment sludges, baghouse dust, solvents, and wastes containing heavy metals. The landfill is located at 1509 East Washburn Road, Waterloo, lowa, in the southern portion of Black Hawk County, lowa.

#### **BACKGROUND**

The landfill originally opened as a state permitted sanitary landfill on July 1, 1975. The landfill was owned and operated by Landfill Services Corporation (LSC) until December 1984. LSC operated the landfill for the County until August 6, 1985.

The landfill received the following hazardous wastes from firms in Iowa and Minnesota from 1980 through August 6, 1985: sludges containing heavy metals, solvents, and plating bath solutions. The facility has two regulated hazardous wastes management units: the Neutral Trench and the Co-disposal Area.

In the summer of 1982, Envirosafe, a subsidiary of IU Conversion System and IU International, proposed purchasing the landfill. The proposed purchase generated public concern about the

landfill's operation and the way the landfill was inspected and regulated. The Black Hawk County Solid Waste Management Commission held multiple public hearings on the proposed purchase and operation of the landfill. Eventually,

the Commission purchased the landfill to prevent expansion of hazardous waste activities and maintain it as a municipal solid waste landfill.

The Commission closed the hazardous waste portions of the landfill on August 6. 1985 and did not accept further hazardous wastes. Also, the Commission closed the Neutral Trench in 1988 and closed the Co-Disposal area in 1989. The site has remained an active municipal solid waste landfill under a permit issued by the Iowa Department of Natural Resources (IDNR).

# PERMIT BACKGROUND

#### Then. . .

In March 1990, the Black Hawk County Solid Waste Management Commission submitted an application for a postclosure permit for the Neutral Trench and the Co-Disposal Area. EPA tentatively approved the draft post-closure permit, and it was made available to the public for comment from July 25, 1990 through September 10, 1990. EPA issued the final post-closure permit on March 29. 1991

#### Now. . .

The Black Hawk County Solid Waste Management Commission has applied for renewal of the post-closure permit and requested modification of the groundwater monitoring plan. EPA has included conditions for monitoring the groundwater to detect movement of hazardous contaminants from the landfill and actions that must be taken if these contaminants are detected in the groundwater. The permit also includes requirements to inspect and maintain the cap covering the wastes in the landfill. The draft permit includes EPA's proposed changes to the groundwater monitoring plan.

#### PUBLIC INVOLVEMENT
