Environmental Work in Baxter Springs Nears Completion

INTRODUCTION

The U.S. Environmental Protection Agency (EPA) Region 7 continues to oversee work at the Tri-State Mining District site in Baxter Springs, Kansas. The first phase of the residential cleanup work in Baxter Springs started in 2000 and was completed in 2001. The second phase of residential cleanups and the rural mining wastes cleanup, west of town, started in 2002 and will be completed in 2003.

BACKGROUND

The Tri-State Mining District is an inactive lead and zinc mining area that includes the Cherokee County Superfund site in Kansas. The Cherokee County site is listed on EPA's National Priorities List (NPL). The NPL is a list of the most serious hazardous waste sites in the country. These sites have been identified for remedial action under the Superfund program.

EPA signed a Record of Decision or ROD for the Baxter Springs subsite in August 1997. The ROD formally selected a cleanup plan. The cleanup plan addresses residential yard soils in Baxter Springs and surface mining wastes in former mining areas west of town.

Hattie Thomas Office of External Programs Toll-free 1-800-223-0425 1-913-551-7003 The ROD called for stabilizing and revegetating the mining wastes, removing wastes from drainages, and excavating and disposing of mining impacted residential soils. A health education program and institutional controls, such as local zoning or building ordinances for land use controls, were also put in place or planned.

SITE UPDATE

The responsible parties are completing the work in Baxter Springs under EPA's and the Kansas Department of Health and Environment's oversight. The work includes cleaning up the surface mining wastes and the mining impacted residential yard soils. The cleanup work west of town is ongoing and the last phase of the residential yard cleanup work is nearly complete. A total of 45 properties have been remediated and over 430 have been sampled. Nearly 150 acres of mining wastes in the Ballard, Spring Branch, and Willow Creek areas have been addressed. All of the work is anticipated to be done in 2003.

NEXT STEPS

Less than ten residential properties still need to be sampled. There is also a limited amount of mine waste work, west of town, that remains to be completed.

EPA will hold an informal public meeting on Wednesday, February 26, 2003, from 4 p.m. to 7 p.m at the Baxter Springs Community Center, 4th and West Avenue, in Baxter Springs, Kansas.

The meeting is scheduled for the public to attend in the afternoon or early evening, after work. People can attend the meeting, at their convenience between 4 p.m. and 7 p.m.
