

HON Rule
Significant Implementation Dates Table

In response to requests at the HON Satellite Workshop (July 27-28, 1994), the following table highlights the significant implementation dates for compliance with the HON final rule as published in the April 22, 1994 Federal Register notice. Related reference citations are provided in the right hand column of the table.

We have received many questions and expressions of concern regarding potential to emit issues that affect applicability and the upcoming compliance dates for equipment leaks. We are currently reviewing our options for how to deal with these issues. Since any course of action we may decide to take would likely affect the early compliance dates, people should be alert to any changes, which we will announce promptly on the TTN.

a) Dates in this table reflect existing sources requirements. New source requirements are typically required earlier, or upon startup.

b) For phase I, II and III dates, in regard to §63.163 (for pumps in light liquid service), or §63.168 (for valves in gas/vapor service and in light liquid service):

- 1) phase I begins no later than the compliance date shown for each respective group;
- 2) phase II begins no later than 1 year after the compliance date shown for each respective group; and
- 3) phase III begins no later than 2½ years after the compliance date shown for each respective group.

For example, at the latest, group III phase I begins 04-24-95 (at group III compliance date), the group III phase II begins 04-24-96 (1 year later), and the group III phase III begins 10-24-97 (1½ years later).

c) For subpart G, semiannual (or quarterly as required) reporting periods begin upon this date and will continue every six months (or three months, respectively) there after. Reports for these periods are due to the permit authority no later than 60 days after the end of that six month (three month, if quarterly) reporting period. So, at the latest, the first semiannual reporting period ends 03-19-98 and the first quarterly reporting period ends 12-19-97. Thus, at the latest, the first semiannual report is due by 05-19-98, and the first quarterly report is due by 02-19-98.
