I. Introduction:

... And Aloha, and welcome to "<u>This Week With Hawaii's Law Enforcement</u>." Today is Monday, August 28th, 2006. I'm Ed Kubo, the United States Attorney for Hawaii, and I'm your host for this show.

The purpose of this show is to educate the public on how the law enforcement community is protecting the citizens of our state, and to update you on cases that is before the federal courts of Hawaii.

We will also give you an idea of how the U.S. Attorney's Office is playing a part in making this state a safer place to live and visit.

This show will also provide the public with important anti-drug, anti-gang, and anti-gun information in hopes of decreasing crime in Hawaii through awareness and prevention.

III. Crimestoppers Segment:

Now, lets turn to the first part of our show --- the CrimeStoppers Segment. As you know, crime happens everyday in our world, and we need everyone to report any suspicious activity or crimes.

The police cannot do this alone, and so they need your help to solve many of the crimes in our neighborhoods. Here are a couple of instances where you can help:

IV. Brief Facts About The Crime:

In the first case:

Police Are On The Lookout For Shayanne KIM:

On December 12, 2005, Honolulu Police Officers responded to a call about suspicious suspects in a stolen vehicle, located in the parking lot of Pearlridge Shopping Center.

Upon arriving at the scene the officer was flagged down by the shopping center security. The suspect, later identified as Shayanne KIM, was seen by security climbing into the trunk of the car. KIM was thereafter seen pushing down the back seat and then

opening the doors to let two males in. All three stayed in the vehicle for about 15 minutes.

Security cameras watched their actions and one of the guards went to check on them. The security officer stopped KIM and another male, and questioned them about the car. Meanwhile, a license plate check determined that the car was stolen, and KIM and his friend were then arrested for Unauthorized Entry into a Motor Vehicle.

During the investigation, it was also learned that KIM had gone to the Pearlridge Sears Store and had purchased \$2,000.00 worth of gift cards using a stolen credit card. As a result, KIM was also arrested for Fraudulent Use of a Credit Card and for Theft in the 2nd Degree.

On July 21th, a bench warrant was issued for KIM's arrest, with bail set at \$20,000.00. He is described as a 26-year old male, 5 feet -1 inch, weighing approximately 110 lbs., with black hair, and brown eyes.

In the second case:

Police Are On The Lookout For Travis E. Watkins:

On August 27, 2004, officers responded to a burglary call at a residence on Tantalus Drive. Upon arriving at the scene, the officers were met by a female who was house sitting for the owner of the home.

The lady had gone to the home to feed the pets and water the plants. But, when she got there, she found the family's two outside cats inside the house.

Upon checking the house, she found Watkins asleep upstairs in one of the bedrooms. She then called the homeowner (who was in Arizona). He told her that he had not given anyone permission to be in his home. The police were then called.

Officers confronted the male, Travis Watkins, who admitted to breaking into the house and spending the night. Watkins stated that he wanted to get out of the rain and needed to take a shower. As a result, Watkins was arrested for Burglary in the First Degree.

Watkins failed to appear for his trial on July 31, 2006 and a warrant for his arrest was issued — with bail set at \$20,000.00.

Watkins is described as a 30-year old male, standing 5 feet - 8 inches, weighing 235 lbs. He has Brown hair, and brown eyes, with a Tribal tattoo on his back.
