Today, Pahoa's drug dealers have been run out of town, their crime rate is down, neighborhood watch groups are active, and the community is receiving recognition for its beautification projects. This is a good thing for Pahoa and it is a tribute to the concept of community prosecution.

Accordingly, Mitchell Roth is this week's "Helping Our Communities - Person of the Week," and he will be notified of this recognition - with our thanks and praise.
