On Friday, I attended the Fifth Anniversary Ceremony for the Federal Detention Center in Honolulu. The FDC – Honolulu, is located out by the Honolulu International Airport and is near our inter-island terminal.

This federal facility is very important to our state because it holds our federal detainees pending their trial. It also houses other inmates who are serving their federal sentences. Because

virtually all of the inmates were prosecuted by the U.S. Attorney's Office, the Federal Detention Center has been nicknamed "Camp Kubo."

In attendance were the heads of the various federal and military agencies in Hawaii. Hawaii's U.S. District Court Chief Judge Helen Gillmor, Former Chief Judge David Ezra, the Detention Center's First Warden, Joe Booker, and myself were asked to say a few words to the attendees.
