## ENFORCEMENT PROCEEDINGS

---

### DEREK VAUGHN STATES AND RICHARD KEVIN GERSON ENJOINED

The Commission announced today that Final Consent Judgments of Permanent Injunctive and Other Relief were entered on June 7, 1995, and May 31, 1995, against Derek Vaughn States and Richard Kevin Gerson. The Commission's complaint, filed September 30, 1994, alleges that States, Gerson and others made false statements and omitted to disclose material information in the offer, purchase and sale of three penny stocks, Omnet, Corp., Performance Nutrition, Inc. and Remington Financial Group, Inc. The complaint further alleges that the defendants engaged in fraudulent conduct in order to artificially inflate the price of the stocks and personally profit by selling shares they controlled at inflated prices.

Under the terms of the Final Judgments, States and Gerson are enjoined from committing or causing future violations of the securities registration, broker-dealer registration and antifraud provision of the federal securities laws. Additionally, States is ordered to disgorge \$302,456.92, and Gerson is ordered to disgorge \$79,747.79, representing their gains from the conduct alleged in the Commission's complaint, plus prejudgment interest. However, payment of disgorgement, prejudgment interest and imposition of a civil monetary penalty are waived based upon States' and Gerson's demonstrated financial inability to pay. [SEC v. ### PRELIMINARY INJUNCTION ORDERED AND ASSET FREEZE AGAINST JOHN BENNETT, JR., FOUNDER OF THE FOUNDATION FOR NEW ERA PHILANTHROPY

The Commission announced that on June 12 Judge Anita B. Brody of the United States District Court for the Eastern District of Pennsylvania issued a Preliminary Injunction enjoining John G. Bennett, Jr., the founder and president of the Foundation For New Era Philanthropy, from

violating the antifraud and registration provisions of the federal securities laws. In addition, Judge Brody's order freezes Bennett's assets and directs Bennett to provide a complete accounting of assets to the Commission. Judge Brody issued the Preliminary Injunction after first holding a hearing on the issue of whether the Court has subject matter jurisdiction. Based on the brief, affidavits and exhibits submitted by the Commission, the Court held that subject matter jurisdiction exists. [SEC v. John G. ## INVESTMENT COMPANY ACT RELEASES

### SENTRY INVESTORS VARIABLE ACCOUNT II

An order has been issued under Section 8(f) of the Investment Company Act declaring that Sentry Investors Variable Account II has ceased to be an investment company. (Rel. IC-21136 - June 14)

### WESTERN NATIONAL LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until July 10 to request a hearing on an application filed by Western National Life Insurance Company (Western National), WNL Separate Account A (Separate Account), and WNL Brokerage Services, Inc. (collectively, Applicants). Applicants seek an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions Sections 26(a)(2)(C) and 27(c)(2) of the Act, to the extent necessary to permit the deduction of mortality and expense risk and enhanced death benefit charges from the assets of the Separate Account; and Sections 2(a)(32), 22(c), 26(a)(2)(C), 27(c)(1), 27(c)(2) and 27(d) of the Act, and from Rule 22c-1 promulgated thereunder, to the extent necessary to permit Western National to provide a recapturable bonus equivalent to one percent of the initial purchase payment in connection with certain variable annuity contracts. Exemptive relief also is requested to the extent necessary to permit the deduction of mortality and expense risk and enhanced death benefit charges from, and the provision of the recapturable bonus in connection with, any other separate account established in the future by Western National, in connection with the issuance and sale of certain variable annuity contracts. ### THE AMERICAN EXPRESS FUNDS

A notice has been issued giving interested persons until July 10 to request a hearing on an application filed by The American Express Funds for an order pursuant to Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-21138 - June 15)

## NORTHERN LIFE INSURANCE COMPANY, ET AL.

An order has been issued under Section 6(c) of the Investment Company Act exempting Northern Life Insurance Company, Separate Account One, and Washington Square Securities from Sections 26(a)(2)(C) and 27(c)(2) of the Act to permit Northern Life Insurance Company to deduct a mortality and expense risk charge from the assets of Separate Account One. (Rel. IC-21139 - June 15)
