## INVESTMENT COMPANY ACT RELEASES

---

### THE ALGER AMERICAN FUND, ET AL.

A notice has been issued giving interested persons until September 12 to request a hearing on an application filed by The Alger American Fund (Fund) and Fred Alger Management, Inc. Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from Sections 9(a), 13(a), 15(a) and 15(b) of the Act, and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder, to the extent necessary to amend an existing order issued by the Commission on February 17, 1989 (Investment Company Release No. IC-16822), permitting Applicants to engage in mixed and shared funding. The proposed relief would amend the prior order to permit the Fund to sell its shares directly to qualified pension and retirement plans outside of the separate account context. (Rel. ## HOLDING COMPANY ACT RELEASES

---

### NEW ENGLAND ELECTRIC SYSTEM, ET AL.

A notice has been issued giving interested persons until September 11 to request a hearing on a proposal by New England Electric System (NEES), a registered holding company, and Narragansett Energy Resources

Company (NERC), a wholly-owned subsidiary of NEES. NERC proposes to issue and sell one or more long-term notes to third parties on or before December 31, 1996 in an aggregate principal amount of \$33 million (Note). Proceeds from the Note would be used to refund obligations owed by NERC to NEES in connection with the acquisition by NERC of equity interests in partnerships owning certain electric generating facilities. NEES proposes to pledge its stock in NERC as partial security for NERC's obligations under the Note. (Rel. 35-26357)

**SYSTEM ENERGY RESOURCES, INC., ET AL.**

An order has been issued authorizing a proposal by Entergy Corporation, a registered holding company, and its wholly owned subsidiary companies System Energy Resources, Inc. (SERI), Arkansas Power & Light Company, Louisiana Power & Light Company, Mississippi Power & Light Company, and New Orleans Public Service Inc. SERI has been authorized from time to time through December 31, 1996 to issue and sell one or more series of debentures in an aggregate principal amount, in combination with one or more series of its first mortgage bonds, not to exceed \$265 million. (Rel. 35-26358)

**NORTHEAST UTILITIES SERVICE CO., ET AL.**

An order has been issued authorizing Northeast Utilities, a registered holding company, Northeast Utilities Service Company, its service company subsidiary, and Western Massachusetts Electric Company, Holyoke Water Power Company, The Connecticut Light and Power Company, and Public Service Company of New Hampshire, its electric utility subsidiary companies, to engage in electric power brokering and marketing transactions in the northeastern United States. ## IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-CBOE-95-31) filed by the Chicago Board Options Exchange on July 3 to amend its Fee Reduction Program for Market-Maker Transaction Fees, Floor Broker Fees, and Member Dues; its Fee Discount Program for Customer "Block" Transactions; its Fee Discount Program for SPX and OEX Transaction Fees charged to Chicago Mercantile Exchange Members; and certain Exchange fees, has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the notice is expected in the Federal Register during the week of August 21. (Rel. 34-36119)
