CANCELLATION OF BROKER-DEALER REGISTRATIONS

SELF-REGULATORY ORGANIZATIONS

CORRECTION TO PROPOSED RULE CHANGE

On October 26, the Commission published a proposed rule change filed by the Pacific Stock Exchange to reduce its option transaction charges for certain customer block trades (SR-PSE-95-26). The Commission is presently publishing a correction to this rule change. Publication of the proposal is expected in the Federal Register during the week of November 6. (Rel. 34-36424A)

PROPOSED RULE CHANGES

The Pacific Stock Exchange filed a proposed rule change (SR-PSE-95-24) relating to the listing of flexible exchange options (FLEX Options) on specified equity securities. Publication of the notice is expected in the Federal Register during the week of November 6. (Rel. 34-36452)

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-95-63) to adopt a new rule concerning telephone solicitation and record-keeping. Publication of the notice is expected in the Federal Register during the week of November 6. (Rel. 34-36455)

The Philadelphia Stock Exchange filed a proposal (SR-PHLX-95-67) to implement a six-month pilot program that increases from 25 to 50 the maximum number of public customer market and marketable limit orders in options on Placer Dome, Inc. (PDG) that are eligible for execution through AUTO-X, the automatic execution feature of the PHLX's Automated Options Market (AUTOM) system. Publication of the notice is expected in the Federal Register during the week of November 8. (Rel. 34-36456)

The Philadelphia Stock Exchange filed a proposed rule change (SR-Phlx-95-60) relating to alternate specialists. Publication of the proposal is expected in the Federal Register during the week of November 8. (Rel. 34-36457)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change (SR-OCC-95-16) filed by The Options Clearing Corporation to accommodate within OCC's by-laws and rules the Philadelphia Stock Exchange's (PHLX) proposal to permit market participants to select customized expiration dates for flexibly structured currency option contracts listed in PHLX's customized currency options program. Publication of the proposal is expected in the Federal Register during the week of November 6. (Rel. 34-36453)
