ENFORCEMENT PROCEEDINGS

COMPLAINT FILED AGAINST WILLIAM TRAINOR, ET AL.

On June 18, the Commission filed a complaint in the United States District Court for the District of Columbia against William P. Trainor, Vincent D. Celentano, Medical Diagnostic Products, Inc. (f/k/a Novatek International, Inc. "Novatek"), and Karen Losordo, Diane M. Trainor, Daniel J. Trainor, Geraldine Trainor and Mary N. Celentano as relief defendants. The Commission's complaint alleges that the defendants violated the antifraud and reporting provisions of the federal securities laws and seeks to permanently enjoin them from future violations of the federal securities laws as well as seek civil penalties against them.

The complaint alleges that Trainor and Celentano orchestrated a scheme to artificially increase the price of Novatek's common stock by knowingly or recklessly causing Novatek to, among other things: a) issue fraudulent press releases announcing contracts, purportedly worth \$400 million, that did not exist and b) overstate Novatek's assets at \$52 million when, in reality, Novatek's assets were approximately \$2 million. Further, the complaint alleges that the relief defendants illegally received proceeds of Trainor's and Celentano's scheme. [SEC v. William P. Trainor, Vincent D. CIVIL ACTION FILED AND ASSET FREEZE ORDERED AGAINST ALBERT CARTER, KELLY POLATIS AND EUNICE POLATIS

On June 18, a civil complaint was filed against Albert E. Carter, Kelly Polatis and Eunice Polatis alleging the defendants have, since at least March 1997, been perpetrating a securities fraud by selling over \$3.5 million of nineteenth century state and railroad bonds, which have only nominal value as collectibles, to investors as investment vehicles capable of generating extraordinary returns to those investors. It is also alleged that Carter has sold interests in an offshore investment program into which he claims the

nineteenth century bonds can be placed, generating annual returns of 100% to 500%. As part of the complaint, the Commission seeks a preliminary injunction, a freeze of the defendants' assets and a freeze of the assets of three relief defendants which received proceeds of sales by the Polatisses.

Also on June 18, the Honorable Dee V. Benson, United States District Judge, issued an order freezing the assets of Carter, Kelly Polatis and Eunice Polatis and the three relief defendants. [SEC v. Albert E. Carter et al., Civil Action No. 2:98CV-0440B, USDC D. Ut.] (LR-15787)

TERRY SHILLING ENJOINED FOR UNLAWFUL INSIDER TRADING

The Commission announced the entry of a judgment enjoining Terry S. Shilling (Shilling), a former Healthsource, Inc. (Healthsource) executive and a resident of Marietta, Georgia, from violating the antifraud provisions of the Exchange Act and ordering him to pay disgorgement of \$10,761.78, prejudgment interest, and a \$10,761.78 penalty. The Commission's complaint, filed in the United States District Court for the District of New Hampshire, alleged that Shilling engaged in unlawful insider trading in the securities of Healthsource. The complaint alleged that, on February 20, 1997, Shilling bought 1,900 shares of Healthsource after being informed by a Healthsource executive, in a confidential briefing, that Healthsource was engaged in merger negotiations with CIGNA Corporation (CIGNA). According to the complaint, Shilling, by trading ahead of the February 28, 1997 announcement that CIGNA would acquire Healthsource, realized unlawful trading profits of \$10,761.78. Shilling consented to the entry of the judgment, which was issued on June 1. [SEC v. Terry S. Shilling, Civ. No. 98-CV-329-B, D. NH] (LR-15788)
