COMMISSION ANNOUNCEMENTS

COLLEEN MAHONEY TO LEAVE COMMISSION AFTER 15 YEARS OF SERVICE

Colleen P. Mahoney, the Acting General Counsel since May and former Deputy Enforcement Director, today announced that she will leave the Commission on July 17, 1998, to become a partner in the Washington, D.C. office of the law firm of Skadden, Arps, Slate, Meagher & Flom, LLP. She will join the firm's securities and litigation practice.

Prior to serving as the Acting General Counsel, Ms. Mahoney was the Deputy Director of the Commission's Division of Enforcement since 1994. Ms. Mahoney also has served as Executive Assistant to SEC Chairman Arthur Levitt; Chief Counsel of the Division of Enforcement; and as an Assistant General Counsel. From 1981 to 1983, Ms. Mahoney was a litigation attorney at Steptoe & Johnson in Washington, D.C.

In 1996, Ms. Mahoney received the Presidential Rank Award for Distinguished Service, and the SEC Chairman's Award for Excellence in 1991. Ms. Mahoney is a summa cum laude graduate of the American University Law School and a magna cum laude graduate of the American University School of Government and Public Administration. TRADEPOINT FINANCIAL NETWORKS, PLC

TradePoint Financial Networks, plc (TradePoint) has filed an Application (File No. 10-101) for Limited Volume Exemption from Registration as an Exchange under Section 5 of the Exchange Act. INVESTMENT COMPANY ACT RELEASES

ALLMERICA INVESTMENT TRUST, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Allmerica Investment Trust (Trust) and Allmerica Investment Management Company, Inc. (Adviser) from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act, and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder, to the extent necessary to permit shares of any current or future series of the Trust and shares of any other investment company that is offered as a funding medium for insurance products and for which the Adviser, or any of its affiliates, or their successors or assigns, may now or in the future serve as manager, investment adviser, administrator, principal underwriter or sponsor to be sold to and held by variable annuity and variable life insurance separate accounts of both affiliated and unaffiliated life insurance companies and qualified pension and retirement plans outside of the separate account context. PAINWEBBER INCORPORATED

An order has been issued on an application filed by PaineWebber Incorporated (PaineWebber) under Section 12(d)(1)(J) of the Investment Company Act exempting Exchangeable Securities Trusts for which PaineWebber will serve as a principal underwriter (Trusts) from Section 12(d)(1) of the Act, under Section 6(c) of the Act exempting the Trusts from Section 14(a) of the Act, and under Section 17(b) of the Act exempting PaineWebber and the Trusts from Section 17(a) of the Act. The order would (i) permit other registered investment companies, and companies excepted from the definition of investment company under Sections 3(c)(1) and (c)(7) of the Act, to own a greater percentage of the total outstanding voting stock (Securities) of the Trusts than that permitted by Section 12(d)(1) of the Act, (ii) exempt the Trusts from the initial net worth requirements of Section 14(a) of the Act, and (iii) permit the Trusts to purchase U.S. Government securities from PaineWebber at the time of a Trust's initial issuance of Securities. SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to a proposed rule change (SR-CHX-98-17) submitted by the Chicago Stock Exchange to extend the Exchange's clearing the post policy for cabinet securities. Publication of the order is expected in the Federal Register during the week of July 6. (Rel. 34-40144)

The Commission granted accelerated approval, on a pilot basis, to a proposed rule filed by the Chicago Stock Exchange (SR-CHX-98-16) relating to the trading of Nasdaq/NM securities on the Exchange.

The proposal has been approved through December 31, 1998. Publication of the order is expected in the Federal Register the week of July 6. (Rel. 34-40150)

JOINT INDUSTRY PLAN; SOLICITATION OF COMMENTS AND ORDER APPROVING REQUEST TO EXTEND TEMPORARY EFFECTIVENESS OF REPORTING PLAN

The Commission received a request for a six-month extension and permanent approval of the Reporting Plan for Nasdaq/National Market System Traded on an Exchange on an Unlisted or Listed Basis by the National Association of Securities Dealers, the Boston Stock Exchange, the Chicago Stock Exchange, and the Philadelphia Stock Exchange on June 30, 1998. Publication of the extension order is expected in the Federal Register during the week of July 6. (Rel. 34-40151)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the Chicago Stock Exchange (SR-CHX-98-14) relating to exempt credit by market makers has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the order is expected in the Federal Register during the week of July 6. (Rel. 34-40152)

PROPOSED RULE CHANGES

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-98-25) to increase the position and exercise limits on equity options traded on CBOE to three times their current levels. Publication of the proposal is expected in the Federal Register during the week of July 6. (Rel. 34-40160)
