# COMMISSION ANNOUNCEMENTS

# CHIEF ACCOUNTANT IS SEEKING CANDIDATES FOR TWO PROFESSIONAL ACCOUNTING FELLOW POSITIONS

The Commission's Office of the Chief Accountant announced that it is now accepting applications for two Professional Accounting Fellow positions in the Office of the Chief Accountant. This highly successful program, begun in 1972, is designed to provide outstanding opportunities for personal development and career enhancement. During their two year term, Fellows work directly with the Chief Accountant, and are involved in the study and development of rule proposals under the Federal securities laws, liaison with professional accounting standard-setting bodies, and consultation with registrants on accounting and reporting matters. Of the two Fellows who will be selected in early 1999, the Chief Accountant would like to select one individual with both a background in accounting for financial instruments and experience with financial In addition, familiarity with accounting for institutions. consolidations, business combinations, and other forms of business alliances enhances an applicant's qualifications.

Applicants should have a minimum of nine to ten years' experience in public accounting or its equivalent, with at least three to four years as a manager. They should be thoroughly familiar with technical accounting and auditing literature as well as with current issues confronting the profession. (Press Rel. 98-97)

#### ENFORCEMENT PROCEEDINGS

# CIVIL ACTION AGAINST FRIENDLY POWER CO., LLC, ET AL.

The Commission announced that on Friday, July 17, 1998, it filed a complaint in the United States District Court for the Southern District of Florida and obtained an temporary restraining order against three Florida based boiler-rooms and a group of Florida companies. On July 23 and 30, 1998, the Court entered orders of preliminary injunctions against all named defendants, upon their consents (without admitting or denying the SEC's allegations), or without opposition.

The SEC's complaint alleges that Friendly Power Company LLC, Friendly Power Company, Inc., and Friendly Power Franchise Company (collectively Friendly Power), a newly-formed group of companies run by Scott J. and Sabrina Levine, which purports to sell electricity in California's electrical market, sold at least \$4.2 million of unregistered securities in violation of the Securities Act of 1933. The SEC's complaint also alleges that defendants Rich Management Corp., Packard Energy Corp., and Cyber-Tech Marketing & Consulting, Inc. and its President, Dwight H. Stephens, violated the federal securities laws by acting as unregistered broker-dealers and selling the Friendly Power unregistered securities by means of egregious misrepresentations to investors regarding, among other things, Friendly Power's risk, profitability, capitalization, the need to invest quickly and investors' returns.
