INVESTMENT COMPANY ACT RELEASES

AETNA LIFE INSURANCE AND ANNUITY COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act granting exemptive relief from Sections 2(a)(32), 22(c) and 27(i)(2)(A) of the Act and Rule 22c-1 thereunder to Aetna Life Insurance and Annuity Company (ALIAC) and its Variable Annuity Account B (VA B), Aetna Insurance Company of America (AICA), and any other separate accounts of ALIAC or AICA that support in the future deferred variable annuity contracts and certificates that are substantially similar in all material respects to the VA B contracts described in the application to permit the recapture of certain bonuses applied to purchase payments made under certain deferred variable annuity contracts and certificates. The order also extends to any other National Association of Securities Dealers, Inc. member broker-dealer controlling or controlled by, or under common control with, ALIAC or AICA that serves as a distributor or principal underwriter of such contracts.
