### SWINK & COMPANY, INC. PRELIMINARILY ENJOINED

The Fort Worth Regional Office announced that on March 23 the Honorable Henry Woods, Judge of the U.S. District Court for the District of Arkansas, Eastern Division, entered an Order of Preliminary Injunction against Swink & Company, Inc., a registered broker-dealer located in Little Rock, Arkansas. The Order preliminarily enjoins Swink & Company from further violations of the net capital, customer protection, recordkeeping and notification provisions of the Securities Exchange Act of 1934. Swink & Company consented to the entry of the Order without admitting or denying the allegations in the Commission's complaint which was filed on February 23, 1983. (SEC v. Swink & Company, Inc., et al., E.D. Ark., Civil Action No. LR-C-83-167). (LR-9946)

## INVESTMENT COMPANY ACT RELEASES

### KUPARUK TRANSPORTATION CAPITAL CORPORATION

### ORDER EXTENDING PARTIAL APPROVAL OF PROPOSED RULE CHANGE

The Commission has extended for 90 days its summary and temporary approval of portions of a rule change proposed by the Chicago Board Options Exchange, Incorporated filed pursuant to Rule 19b-4 under the Securities Exchange Act of 1934 (SR-CBOE-80-16). The provisions of the rule being approved relate to appointment and oversight of market makers while the remainder requires that a minimum portion of a market maker's options transactions be executed in person. The Commission is extending the public comment period on the proposed rule until May 2, 1983. Publication of the order and notice is expected to be made in the Federal Register during the week of April 4. (Rel. 34-19641)

### NOTICE OF PROPOSED RULE CHANGE
