## ENFORCEMENT PROCEEDINGS

---

### IN THE MATTER OF LEEB INVESTMENT ADVISORS, ET AL.

The Commission announced today the issuance of an Order in settlement of administrative proceedings previously instituted against Leeb Investment Advisors (Advisor), PF Funds Group, Inc. (Funds Group), KCI Communications, Inc. (KCI), Allie P. Ash, Stephen L. Leeb and Marianne Parrish. The proceedings concerned the respondents' participation in a strategy for marketing investments in a mutual fund, the Leeb Personal Finance Fund (Fund), that defrauded or operated as a fraud on actual and potential Fund investors. The strategy involved false and misleading statements made in advertisements for KCI newsletters and in advertisements for the Fund regarding a market timing model developed by Leeb.

The Commission found that Funds Group violated Section 10(b) of the Exchange Act and Rule 10b-5, Section 17(a) of the Securities Act and Section 34(b) of the Investment Company Act. Each of the other respondents was found to have caused and to have aided and abetted certain of the violations. The respondents were ordered to pay civil money penalties totalling \$300,000, with the Advisor, Funds Group, KCI, Ash and Leeb each ordered to pay \$60,000. Each of the respondents was censured and ordered to cease and desist from committing or causing further violations. Respondents consented to the entry of the Order without admitting or denying the matters set forth therein. (Rel. Nos. 33-7255; 34-36712; IC-21671; IA-1545)

### JONATHAN MAYHEW ENJOINED AND ORDERED TO DISGORGE PROFITS AND INTEREST FOR INSIDER TRADING

The Commission today announced that on December 27 the Honorable Janet Bond Arterton of the United States District Court for the District of Connecticut issued an Opinion and Order in SEC v. Jonathan Mayhew, No. 3:94cv1322 (JBA). In that Opinion and Order,

which followed an August 1995 trial, the Court found that defendant Mayhew had violated Section 14(e) of the Securities Exchange Act of 1934 and Rule 14e-3 thereunder in connection with his trading in the stock and options of Rorer Group, Inc. during 1989 and 1990. The Court's Order enjoins defendant Mayhew from further violations of Section 14(e) and Rule 14e-3 and orders payment of \$255,550.01 in disgorgement, with prejudgment interest through September 30, 1995, in the amount of \$160,031.58 (to be updated through the date of the judgment). Judge Arterton found for defendant Mayhew on the Commission's claims under Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. For further information see LR-14189. #### INVESTMENT COMPANY ACT RELEASES

---

##### THE 231 FUNDS

A notice has been issued giving interested persons until January 2 to request a hearing on an application filed by The 231 Funds for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-21649 - January 3)

##### FUNDS IV TRUST, ET AL.

A notice has been issued giving interested persons until January 30 to request a hearing on an application filed by Funds IV Trust, et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of the Act. Fourth Financial Corporation, the parent of the investment adviser (Adviser) to Funds IV Trust (Trust), will merge with and into Acquisition Sub, Inc., a wholly-owned subsidiary of Boatmen's Bancshares, Inc. The merger will result in the assignment, and thus the termination, of the existing investment advisory contract between the Trust and the Adviser. The order would permit the implementation, without shareholder approval, of a new advisory contract for a period of up to 120 days following the date of the merger (but in no event later than May 30, 1996). The order also would permit the Adviser to receive from the Trust fees earned under the new investment advisory contract following approval by the investment company's shareholders. (Rel. ## BRINSON RELATIONSHIP FUNDS AND BRINSON PARTNERS, INC.

A notice has been issued giving interested persons until January 30 to request a hearing on an application filed by Brinson Relationship Funds (Trust) and Brinson Partners, Inc. for an order under Sections 6(c) and 17(b) of the Investment Company Act granting an exemption from Section 17(a) of the Act. The requested order would permit series of the Trust to invest in other series of the Trust. (Rel. IC-21662 - January 5)
