COMMISSION ANNOUNCEMENTS

CHAIRMAN LEVITT APPOINTS BRIAN LANE DIRECTOR OF CORPORATION FINANCE

Chairman Levitt today announced that he has appointed Brian J. Lane as Director of the Division of Corporation Finance. Mr. Lane has served as Acting Director of the Division since February.

Mr. Lane has been with the Securities and Exchange Commission since 1983, working for the past year as a Counselor to Chairman Arthur Levitt. Prior to that, he spent three years as Counsel to Commissioner Richard Y. Roberts, six years in the Division of Corporation Finance, and approximately three years in Division of Market Regulation. He received his B.A. from Washburn University in Topeka, Kansas in 1980, and his J.D. from the Washington College of Law of the American University in 1983. For the past two years, he has been an Adjunct Professor at the Georgetown University Law Center co-teaching a graduate class in Mergers, Takeovers, and Acquisitions. Mr. Lane has twice been awarded the Commission's Regulatory Simplification Award. (Press Rel. 96-54)

PUBLIC COMMENT SOUGHT ON THE NEED FOR GREATER PROTECTION FOR SENIOR CITIZENS AND QUALIFIED RETIREMENT PLANS FROM SECURITIES FRAUD AND FRIVOLOUS LITIGATION

The Commission announced that it was seeking public comment to determine whether investors that are senior citizens or qualified retirement plans require greater protection against securities fraud than is currently provided under the federal securities laws; and whether investors that are senior citizens or qualified retirement plans have been adversely impacted by abusive or unnecessary securities fraud litigation, and whether the current provisions of the federal securities laws are sufficient to protect them from such litigation. The Commission is also soliciting comment on the more general question of the role of senior citizens and qualified retirement plans in our securities markets.

The request for comments is made in connection with the requirements of Section 106 on the Private Securities Litigation Reform Act of 1995, which directs the Commission to make these determinations and, if it determines that greater protections are necessary, submit a report to the Congress containing its recommendations by June 19, 1996.

ENFORCEMENT PROCEEDINGS

RALPH MCKITTRICK, FORMER OWNER OF BROKER-DEALER ENJOINED

The Commission announced that on February 5 the Honorable John G. Hargrove of the United States District Court for the District of Maryland entered a Final Judgment and Order against Ralph E. McKittrick, director, chairman and fifty-percent shareholder of McKittrick & Briggs Securities, Inc. Between June 1981 and March 1991, McKittrick & Briggs was registered with the Commission as a broker-dealer. The Final Judgment permanently enjoins McKittrick from future violations of the antifraud provisions of the federal securities laws, and requires him to disgorge \$1,933,372, together with prejudgment interest thereon. The payment of disgorgement is waived, however, based upon McKittrick's demonstrated inability to pay. McKittrick consented to the Final Judgment and Order without admitting or denying the allegations in the Commission's complaint.

The complaint, which was filed on September 11, 1990, alleged that, from May 1983 through November 1987, McKittrick participated in a fraudulent offering of over \$50 million of unregistered securities issued by Governmental Financial Services, Inc. (GFS). The securities, which were offered through different investment programs, represented interests in equipment leases serviced by GFS. [SEC v. Ralph E.
