## ENFORCEMENT PROCEEDINGS

---

### COMMISSION BARS JAMES D'ANGELO

The Commission announced the entry of an Order barring James L. D'Angelo (D'Angelo), a former stockbroker at the Andover, Massachusetts branch office of PaineWebber Incorporated, from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. The Order was based on the entry of a permanent injunction for violations of the antifraud provisions. D'Angelo consented to the Order.

On March 25, the Commission filed a complaint in the U.S. District Court for the District of Massachusetts against D'Angelo (SEC v. John C. Larrabee and James L. D'Angelo, Civil Action No. 97-10652WGY, D. Mass). In its complaint, the Commission alleged that on or before December 12, 1995, D'Angelo received misappropriated material nonpublic information concerning the merger between Bank of Boston Corporation and Baybanks, Inc. (Baybanks). The complaint further alleged that on December 12, 1995, while knowing that such information was material and nonpublic, D'Angelo purchased 10,200 shares of Baybanks common stock. The complaint also alleged that on December 13, 1995, D'Angelo sold all of the Baybanks stock for a gross profit of \$86,750. On March 18, 1997, without admitting or denying the Commission's allegations, D'Angelo consented to the entry of a final judgment of permanent injunction. On March 28, 1997, the District Court permanently enjoined D'Angelo from future violations of Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder; and ordered D'Angelo to pay disgorgement of \$86,750, plus prejudgment interest of \$8,552, plus a civil penalty of \$86,750. ## INVESTMENT COMPANY ACT RELEASES

---

### DREYFUS/LAUREL FUNDS TRUST AND DREYFUS GROWTH AND VALUE FUNDS, INC.

An order has been issued on an application filed by Dreyfus/Laurel Funds Trust (Trust) and Dreyfus Growth and Value Funds, Inc. (Company) under Section 17(b) of the Investment Company Act granting an exemption from Section 17(a) of the Act. The order permits a series of the Company to acquire all of the assets and assume all of the stated liabilities of a series of the Trust. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-22623 - April 17)

## HOLDING COMPANY ACT RELEASES

---

### SOUTHERN CALIFORNIA WATER COMPANY

An order has been issued approving a request by Southern California Water Company (SCWC), an electric utility company. The order grants an exemption under Section 3(a)(1) of the Act to a holding company (Newco) that will result from a planned reorganization of SCWC's operations. (Rel. 35-26707)

### NEW CENTURY ENERGIES, INC., ET AL.

A notice has been issued giving interested persons until May 12 to request a hearing on a proposal by New Century Energies, Inc., a corporation not currently subject to the Act, and its utility and non-utility subsidiaries (Applicants). Applicants propose to engage in various financing and related transactions through December 31, 1999, subject to certain conditions. (Rel. 35-26708)

### AMERICAN ELECTRIC POWER CO., INC., ET AL.

A notice has been issued giving interested persons until May 12 to request a hearing on a proposal by American Electric Power Company, Inc. (AEP), a registered holding company, and AEP Resources, Inc., a nonutility subsidiary company of AEP, to issue securities for the purpose of financing the acquisition, directly or indirectly, of interests in Exempt Wholesale Generators and Foreign Utility Companies, and to issue guarantees relative to the obligations of such entities, in an aggregate amount of up to 100% of it AEP's consolidated retained earnings. ## AMENDMENT TO PROPOSED RULE CHANGE

The Philadelphia Stock Exchange filed with the Commission Amendment No. 1 to the proposed rule change (SR-Phlx-96-38) relating to the listing of flexible exchange-traded options on specified indexes and equity securities. ## PROPOSED AMENDMENT

The Intermarket Trading System (ITS) filed a proposed amendment to the ITS Plan (4-208) under Rule 11Aa3-2 of the Exchange Act to amend the Pre-Opening Application, to delete text that, by its terms, it no longer applicable, and to make technical amendments. Publication of the proposal is expected in the Federal Register during the week of April 21. (Rel. 34-38520)

## PROPOSED RULE CHANGES

The Philadelphia Stock Exchange has filed a proposed rule change (SR-PHLX-97-07) regarding 3D foreign currency option holiday expirations. Publication of the proposal is expected in the Federal Register during the week of April 21. (Rel. 34-38527)

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-97-11) to increase the OEX position and exercise limits, to increase the OEX firm facilitation exemption, and to increase the OEX index hedge exemption. Publication of the notice is expected in the Federal Register during the week of April 21. (Rel. 34-38525)

The American Stock Exchange filed a proposed rule change (SR-AMEX-97-15) to authorize Options on the NatWest Energy Index. Publication of the proposal is expected in the Federal Register during the week of April 21. (Rel. 34-38526; IS-1074)
