## ENFORCEMENT PROCEEDINGS

---

### ADMINISTRATIVE PROCEEDING INSTITUTED AGAINST B.J. THOMAS, C.P.A.

The Commission has instituted a public administrative proceeding pursuant to Rule 102(e)(3) of the Commission's Rules of Practice against B. J. Thomas, C.P.A.

The Order for Proceedings alleges as follows: B.J. Thomas, as chief financial officer of Technology International, Ltd. from March 1993 until February 1994, prepared the June 30, 1993 financial statements for TIL and knew or was reckless in not knowing that these financial statements had not been prepared in accordance with Generally Accepted Accounting Principles in violation of Section 17(a) of the Securities Act and Section 10(b) of the Exchange Act and Rule 10b-5 thereunder. On March 11, 1997, Thomas consented to the entry of final judgment in a federal district court action against him and others arising out of the facts that form the basis of this proceeding. Based on the permanent injunction, the Commission has temporarily suspended and may, after a thirty-day period, permanently suspend Thomas from practice under Rule 102(e)(3). ## HOLDING COMPANY ACT RELEASES

---

### UNITIL CORPORATION, ET AL.

A notice has been issued giving interested persons until June 27 to request a hearing on a proposal by UNITIL Corporation (UNITIL), a registered holding company, and its subsidiaries, Concord Electric Company, Exeter & Hampton Electric Company, Fitchburg Gas and Electric Light Company (Fitchburg), UNITIL Power Corp., UNITIL Realty Corp., UNITIL Resources, Inc. and UNITIL Service Corp. UNITIL and Fitchburg request authority through June 30, 2000 to incur short term borrowings from banks. The aggregate amount of short term borrowings by UNITIL would not exceed \$25 million. Also, Fitchburg requests authority to incur short term borrowings from UNITIL and the other Subsidiaries, and UNITIL and the other Subsidiaries request authority to lend funds to Fitchburg under the UNITIL system money pool, through June 30, 2000. Borrowings by Fitchburg under the system money pool and its short-term borrowings from banks would not exceed \$12 million. (Rel. 35-26726)

### ALABAMA POWER COMPANY, ET AL.

A supplemental order has been issued authorizing a proposal by Alabama Power Company (Alabama), Georgia Power Company (Georgia), Gulf Power Company (Gulf), Mississippi Power Company (Mississippi), and Savannah Electric and Power Company (Savannah) (together, Operating Companies), electric public utility subsidiary companies of The Southern Company, a registered holding company. The Operating Companies propose, among other things, to borrow money from and make equity capital contributions to new special purpose subsidiaries, organized as trusts and formed solely to issue and sell preferred securities, in aggregate amounts, of up to \$500 million, \$500 million, \$50 million, \$75 million and \$40 million for Alabama, Georgia, Gulf, Mississippi and Savannah, respectively, through December 31, 2005. Georgia has been authorized to effect the issuance and sale of up to \$189.25 million aggregate liquidation amount of preferred securities. (Rel. 35-26727)
