ENFORCEMENT PROCEEDINGS

WALTER CUSHMAN III AND RODNEY HOLLOWAN GUILTY OF CRIMINAL CONTEMPT

The Commission and the United States Attorney for the Northern District of Texas announced that on January 24 Walter Humbert Cushman III (Cushman) and Rodney Lee Holloman (Holloman) were found guilty on five counts of criminal contempt. Cushman and Holloman were charged with willfully disobeying an order of permanent injunction entered by the United States District Court for the Northern District of Texas April 1, 1992, in a civil action brought by the Commission on December 19, 1991 (SEC v. Great Southwest Energy, Inc., et al., USDC ND/TX, CA 4-91-0862). The two defendants were permanently enjoined for violations of the securities registration, antifraud and broker-dealer registration provisions of the federal securities laws.

The defendants were indicted on charges arising from the sale of interests in an oil and gas venture while failing to disclose their ownership interest or the history of previous enforcement proceedings brought against them. Sentencing has not been scheduled as yet. Cushman and Holloman are currently awaiting sentencing from their convictions on January 9, 1993 on 31 counts and 29 counts respectively of criminal conspiracy to commit mail fraud, wire fraud and money laundering. INVESTMENT COMPANY ACT RELEASES

ABT MONEY MARKET SERIES, INC.

The order would permit applicants to issue multiple classes of shares representing interests in the same portfolio of securities, assess a contingent deferred sales charge (CDSC) on certain redemptions of shares, and waive the CDSC in certain instances. HEBER GRANT & COMPANY

A notice has been issued giving interested persons until February 22, 1994 to request a hearing on an application filed by Heber J. Grant & Company for a conditional order under Section 6(c) of the Investment Company Act that would exempt a privately held company from all provisions of the Act. The company is substantially owned and controlled by one family and by certain persons and entities employed by, controlled by, affiliated with, or otherwise related to members of that family. (Rel. CROWN AMERICA SEPARATE ACCOUNT B

An order has been issued under Section 8(f) of the Investment Company Act declaring that Crown America Separate Account B has ceased to be an investment company. (Rel. IC-20041 - January 27)
