COMMISSION ANNOUNCEMENTS

CHAIRMAN LEVITT ANNOUNCES TWO APPOINTMENTS IN THE OFFICE OF THE CHAIRMAN

Chairman Levitt today announced that he has appointed Lori A. Richards as Executive Assistant to the Chairman and Carrie E. Dwyer as Senior Counselor to the Chairman.

Ms. Richards has served as the Associate Regional Director for Enforcement for the Pacific Region, Los Angeles Office, and was responsible for coordinating the Commission's overall enforcement program in the Region. She has also served as the Acting District Administrator of the Commission's San Francisco District Office since February 1993. Ms. Richards started her career with the Commission in 1985 in the enforcement program in Los Angeles. She received a B.A. from Northern Illinois University and later graduated from American University Washington College of Law.

Ms. Dwyer has served as Counsellor to Chairman Levitt since September 1993. She previously served as Senior Vice-President and General Counsel at the American Stock Exchange. She also was associated with the law firm of Milbank, Tweed, Hadley & McCloy in New York. Ms. Dwyer graduated from college and law school at Santa Clara University. (Press Rel. 94-26)

RULES AND RELATED MATTERS

MODIFICATION OF CLASS EXEMPTION REGARDING APPLICATION OF COOLING-OFF PERIODS UNDER RULE 10B-6 TO DISTRIBUTIONS OF FOREIGN SECURITIES IN THE UNITED STATES

On April 4, the Division of Market Regulation, pursuant to delegated authority, issued a class exemption from Rule 10b-6 under the Securities Exchange Act of 1934 clarifying the rule's application during distributions of foreign securities. This exemption supersedes a previous exemption. See Securities Exchange Act Release No. 31943 (March 4, 1993), 58 FR 13288 (March 10, 1993). FOR FURTHER INFORMATION CONTACT: David A. ORDER APPROVING A PROPOSED RULE CHANGE

On April 7, the Commission approved a proposed rule change (SR-MSRB-94-2) filed by the Municipal Securities Rulemaking Board pursuant to Section 19(b)(1) of the Securities Exchange Act of 1934. The Commission also noticed and approved, on an accelerated basis, Amendment No. 1 to the proposed rule change. The MSRB filed the proposal to adopt rules relating to political contributions and prohibitions on municipal securities business. Amendment No. 1 relates to the effective and contribution date of the proposal. The proposed rule change will be effective ten days after publication of the approval order in the Federal Register. Publication of the order in the Federal Register is expected during the week of April 11. (Rel. 34-33868)

APPROVAL OF PROPOSED RULE CHANGE BY THE MUNICIPAL SECURITIES RULEMAKING BOARD RELATING TO SUITABILITY OF RECOMMENDATIONS

The Commission approved a proposed rule change (SR-MSRB-94-01) filed by the Municipal Securities Rulemaking Board to strengthen the MSRB's rules governing customer suitability. Publication of the order is expected in the Federal Register during the week of April 11. (Rel. 34-33869)

ORDER CONSIDERING WHETHER TO STAY SUA SPONTE RULE CHANGE ON POLITICAL CONTRIBUTIONS AND ESTABLISHING GUIDELINES FOR STAY APPLICATIONS

On April 7, the Commission issued an order preliminarily considering whether to issue a stay of a rule change by the Municipal Securities Rulemaking Board (SR-MSRB-94-2) relating to contributions to the political campaigns of state and local officials by municipal securities dealers and certain of their employees, in light of constitutional concerns raised during the comment process. The Commission determined that a sua sponte stay of the rule change was not warranted. However, the Commission's order establishes guidelines for stay applications relating to the rule change. INVESTMENT COMPANY ACT RELEASES

STATE BOND EQUITY FUNDS, INC., ET AL.

An order has been issued on an application filed by State Bond Equity Funds, Inc., et al. under Section 6(c) of the Investment Company Act for an exemption from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits the Funds to issue and sell multiple classes of shares representing interests in the same portfolios of securities, assess a contingent deferred sales charge (CDSC) on certain redemptions, and waive the CDSC in certain instances. (Rel. IC-20198 - April 6)

THE ONE® GROUPSM, ET AL.

An order has been issued on an application filed by The One® GroupSM, et al. for a conditional order under Section 6(c) of the Investment Company Act for an exemption from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits the applicants to issue multiple classes of shares representing interests in the same portfolio of securities, assess a contingent deferred sales charge (CDSC) on certain redemptions of shares, and waive the CDSC in certain instances. (Rel. IC-20199 - April 6)

NUVEEN EQUITYBUILDER MUNICIPAL UNIT INVESTMENT TRUST

An order has been issued under Section 8(f) of the Investment Company Act declaring that Nuveen EquityBuilder Municipal Unit Investment Trust has ceased to be an investment company. (Rel. IC-20200 - April 6)

TCW INVESTMENT FUNDS, INC., ET AL.

An order has been issued on an application filed by TCW Investment Funds, Inc., et al. under Section 17(b) of the Investment Company Act for an exemption from Section 17(a) of the Act. The order permits TCW Investment Funds, Inc. to transfer substantially all its assets and liabilities to TCW Funds, Inc. (Galileo Company) in exchange for shares of Galileo Company's common stock. HOLDING COMPANY ACT RELEASES

CENTRAL POWER AND LIGHT COMPANY

An order has been issued authorizing Central Power and Light Company, an electric utility subsidiary company of Central and South West Corporation, a registered holding company, to issue and sell in one or more series, through December 31, 1996, up to one million shares of its preferred stock, par value \$100 per share. (Rel. 35-26019)

GULF POWER COMPANY, ET AL.

A supplemental order has been issued authorizing Gulf Power Company and Mississippi Power Company, electric utility subsidiary companies of The Southern Company, a registered holding company, to issue, sell, acquire, redeem and secure notes, sell utility assets and extend credit to an associate company, on or before December 31, 1994, in connection with the refinancing of outstanding notes in the approximate principal amount of \$36 million. (Rel. 35-26020)

SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved on an accelerated basis a proposed rule change filed by the National Securities Clearing Corporation (SR-NSCC-94-03) amending NSCC's by-laws to provide for an additional member of the board of directors. (Rel. 34-33852)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the Boston Stock Exchange to modify its fee structure (SR-BSE-94-02) has become effective upon filing. Publication of the proposal is expected in the Federal Register during the week of April 11. (Rel. 34-33867)

ACQUISITIONS OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.

Below is a list of recent filings of Schedules 13D and 14D, which includes the following information: Column 1 - the company purchased (top), and the name of the purchaser; Column 2 - the type of security purchased; Column - 3 - the type of form filed; Column 4 - the date the transaction occurred; Column 5 - the current number of shares (in 000's) owned (top) and the current percent owned; Column 6 - the CUSIP number (top) and the percent owned; and Column 7 - the status of the filing, i.e., new, update or revision.
