## RULES AND RELATED MATTERS

---

### TRANSFER OF DELEGATION OF AUTHORITY FOR ADVICE AND ACTIVITIES CONCERNING CERTAIN PROCEEDINGS CONDUCTED PURSUANT TO THE PROVISIONS OF RULE 2(e) OF THE COMMISSION'S RULES OF PRACTICE TO THE OFFICE OF THE GENERAL COUNSEL

The Commission has transferred its delegation of authority for advice and activities concerning certain proceedings conducted pursuant to the provisions of Rule 2(e) of the Commission's Rules of Practice to the Office of the General Counsel from the Executive Assistant to the Chairman. The Office of the General Counsel will assume the responsibility to advise the Commission, make certain procedural decisions, and take certain actions in connection with Rule 2(e) proceedings. This delegation will permit the Commission to employ in its 2(e) proceedings the staff that reviews and prepares the balance of opinions and orders in other proceedings decided by the Commission.

The Commission had previously transferred responsibility for the prosecution of Rule 2(e) proceedings involving professionals, other than attorneys, to the Division of Enforcement. The delegation provides that, in a case in which the involvement of the General Counsel is deemed inappropriate for any reason, the Executive Assistant to the Chairman, or other staff outside the Office of the General Counsel, will assume responsibility for the matter. In light of the fact that the General Counsel retains responsibility for prosecuting Rule 2(e) proceedings against attorneys, the Commission intends that persons other than staff in the Office of the General Counsel will provide advice concerning any such matters so long as the Office of the General Counsel prosecutes such cases. ## INVESTMENT ADVISERS ACT RELEASES

---

### VALMORA PARTNERS, L.P.

A notice has been issued giving interested persons until August 23 to request a hearing on an application filed by Valmora Partners, L.P. for an order under Section 206A of the Investment Advisers Act that would exempt applicant from Section 205(a)(1) of the Act. Applicant is a limited partnership that a family formed to facilitate investments of family trusts and custodianships. The order would permit registered investment advisers to charge applicant performance-based advisory fees. (Rel. IA-1430 - July 29)

## HOLDING COMPANY ACT RELEASES

---

### NORTHEAST UTILITIES

A supplemental order has been issued authorizing Northeast Utilities, a registered holding company, to amend its dividend reinvestment plan (Plan) to allow the Plan to charge participants for brokerage and administrative fees and to change the Plan's pricing and partial share formulas. (Rel. 35-26092)

### NATIONAL FUEL GAS COMPANY, ET AL.

An order has been issued authorizing a proposal by National Fuel Gas Company (NFG), a registered holding company, and Leidy Hub, Inc. (Leidy Hub), a non-utility subsidiary of NFG. NFG and Leidy Hub propose that Leidy Hub acquire, for \$500,000, an interest in a partnership (Partnership) with Hub Services, Inc. (Hub Services), an unaffiliated company and subsidiary of Natural Gas Clearinghouse; and NFG guarantee certain present and future obligations of Leidy Hub and the Partnership. Leidy Hub and Hub Services plan to form the Partnership in order to operate a natural gas market area hub to offer customers services relating to the transportation, storage, purchase, sale, exchange and lending of natural gas in the hub area. ### GEORGIA POWER COMPANY

A notice has been issued giving interested persons until August 22 to request a hearing on a proposal by Georgia Power Company (Georgia Power), a wholly owned electric public-utility subsidiary company of The Southern Company, a registered holding company. Georgia Power proposes to refinance certain pollution control equipment on or before December

31, 1997, in connection with the issuance and sale by the Development Authority of Burke County, Georgia of \$60 million aggregate principal amount of its Pollution Control Revenue Bonds (Georgia Power Company Plant Vogtle Project), Sixth Series 1994. In order to secure the obligations incurred by the refinancing of the equipment, Georgia Power proposes to issue a series of its first mortgage bonds. (Rel. 35-26094)

## SELF-REGULATORY ORGANIZATIONS

---

### APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-NASD-94-28) filed by the National Association of Securities Dealers that amends the requirements applicable to Nasdaq and OTC Bulletin Board (OTCBB) market makers with respect to the utilization of registered clearing agency facilities as set forth in Part V, Section 7 of Schedule D to the By-Laws and Section 4 of the OTCBB Service Rules. (Rel. 34-34457)

The Commission approved a proposed rule change (SR-Phlx-92-12) filed by the Philadelphia Stock Exchange relating to restrictions on orders in multiply traded options entered by specialists and registered options traders for execution on other exchanges. Publication of the notice and order is expected in the Federal Register during the week of August 1. (Rel. 34-34463)

The Commission approved a proposed rule change (SR-CBOE-93-30) filed by the Chicago Board Options Exchange that implements a method for executing stopped transactions on the Exchange. Publication of the Order is expected in the Federal Register during the week of August 1. (Rel. 34-34465)

### PROPOSED RULE CHANGE

The Chicago Stock Exchange filed a proposed rule change (SR-CHX-94-18) relating to changes in the Chicago Basket. Publication of the proposal is expected in the Federal Register during the week of August 1. (Rel. 34-34462)

### AMENDMENT TO PROPOSED RULE CHANGE

The Chicago Stock Exchange filed an amendment to proposed rule change (SR-CHX-93-19) to adopt proposed rules relating to the creation of the Chicago Match facility. Publication of the proposal is expected in the Federal Register during the week of August 1. (Rel. 34-34469)

### ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the American Stock Exchange (SR-Amex-94-22) to amend Exchange Rule 103. (Rel. 34-34471)
