OPEN MEETING - WEDNESDAY, AUGUST 10, 1994 - 2:00 P.M.

The subject matter of the open meeting scheduled for Wednesday, August 10, 1994, at 2:00 p.m., will be:

1. Consideration of whether to propose for public comment amendments to the rules and forms regarding the filing of ownership reports by officers, directors, and ten percent shareholders, and the exemption by those persons from the short-swing profit recovery provisions of Section 16 of the Securities Exchange Act of 1934 and related provisions of the Investment Company Act of 1940 and the Public Utility Holding Company Act of 1935. The proposed rules are intended to streamline the Section 16 regulatory scheme, particularly with respect to employee benefit plans, and codify several staff interpretive positions.

The Commission also will consider whether to extend the phase-in date for compliance with current Rule 16b-3.

2. Consideration of whether to propose for public comment amendments to Regulation S-X and investment company registration forms that would require an investment company to reflect in its financial statements, fee table, and financial highlights table and in the calculation of its yield the cost of fund services paid for by brokers in exchange for the direction of fund commissions to the broker.

ENFORCEMENT PROCEEDINGS

NYSE ACTION AGAINST TIMOLEON NICHOLAOU SUSTAINED

The Commission has sustained NYSE disciplinary action against Timoleon Nicholaou of Rochester, Michigan, a former salesman for Merrill Lynch, Pierce, Fenner & Smith, Inc. The Exchange censured Nicholaou; suspended him for one year from membership, allied membership, approved person status, and employment or association with any member or member organization; and placed him under heightened supervision by his branch office manager for one year following his suspension.

The Commission found that, during the period from about July 1984 through January 1988, Nicholaou recommended unsuitable investments, effected inappropriate margin transactions in customer accounts, and effected unauthorized margin transactions. In affirming the sanctions assessed by the Exchange, the Commission stated that "over an extended period of time, Nicholaou exhibited a disturbing lack of understanding of a registered representative's fiduciary duty to his customers." SEABOARD INVESTMENT ADVISERS ORDERED TO PAY \$1.0 MILLION PENALTY

The Commission announced that it has entered an Order against Seaboard Investment Advisers, Inc. (Seaboard), an investment adviser in Norfolk, Virginia, Eugene W. Hansen (Hansen), Seaboard's Chairman and CEO, and Stewart M. Powers, Jr. (Powers), Seaboard's President and Chief Operating Officer. Seaboard, Hansen and Powers consented to the issuance of the Order without admitting or denying the findings therein.

The Order finds that from at least 1990, Seaboard willfully violated the antifraud provisions of the Advisers Act by publishing advertisements which contained false or misleading performance figures covering the period from 1984 through at least the third quarter of 1991. In addition, the Order finds that Seaboard willfully violated certain books and records provisions of the Advisers Act. The Order further finds that both Hansen and Powers willfully aided and abetted Seaboard's violations.

The Commission ordered Seaboard to pay a \$1 million civil money penalty. The Commission also ordered Seaboard, Hansen, and Powers to cease and desist from violating the above-referenced provisions of the Advisers Act. Furthermore, the Commission ordered Seaboard, Hansen, and Powers to comply with various undertakings, including the retention of both a public accounting firm to audit Seaboard's performance figures and a special review person to review and to make recommendations concerning Seaboard's policies and procedures regarding advertising. INVESTMENT COMPANY ACT RELEASES

THORNBURG INCOME TRUST, ET AL.

An order has been issued under Section 6(c) of the Investment Company Act exempting Thornburg Income Trust, et al. from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act, and Rule 22c-1 thereunder. The order permits certain open-end investment companies to issue multiple classes of shares representing interests in the same portfolio of securities, and assess a contingent deferred sales charge on certain redemptions of shares. (Rel. IC-20438 - August 3)

NUVEEN MUNICIPAL BOND FUND, INC., ET AL.

A notice has been issued giving interested persons until August 29 to request a hearing on an application filed by Nuveen Municipal Bond Fund, Inc., et al. for an order under Section 6(c) of the Investment Company

Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act, and Rule 22c-1 thereunder. The order would permit applicants to issue multiple classes of shares representing interests in the same portfolio of securities, assess a contingent deferred sales charge (CDSC) on certain redemptions of shares, and waive the CDSC in certain instances. AMENDMENT TO PROPOSED RULE CHANGE

The Chicago Stock Exchange filed an amendment to a proposed rule change (SR-CHX-93-19) to adopt proposed rules relating to the creation of the Chicago Match facility. Publication of the proposal is expected in the Federal Register during the week of August 8. (Rel. 34-34469)
