HOLDING COMPANY ACT RELEASES

CENTRAL AND SOUTH WEST CORPORATION, ET AL.

An order has been issued authorizing a proposal by Central and South West Corporation (CSW), a registered holding company, and its nonutility subsidiary company, CSW Energy, Inc. (Energy) and Energy's proposed nonutility subsidiary company, Energy Sub (Energy Sub), whereby Energy will form Energy Sub by acquiring all of its 1,000 shares of authorized common stock for a subscription price of \$1.00 per share; CSW and Energy will provide acquisition and development costs for Energy Sub in respective amounts of \$11 million and \$5 million through capital contributions, loans and/or open account advances; and Energy Sub will acquire certain generating assets located in Wharton County, Texas from Texasgulf, Inc., a nonassociate company, to develop as an exempt wholesale generator or as a qualifying facility. SELF-REGULATORY ORGANIZATIONS

UNLISTED TRADING PRIVILEGES GRANTED

Orders have been issued granting the applications of three exchanges for unlisted trading privileges in the common stock of issues which are listed and registered on one or more other national securities exchange and reported in the consolidated transaction reporting system. The exchanges and number of issues are: Boston Stock Exchange - 6 issues (Rel. 34-34543); Philadelphia Stock Exchange - 16 issues (Rel. 34-34544); and Chicago Stock Exchange - 43 issues (Rel. 34-34548).

APPROVAL OF PROPOSED RULE CHANGES AND ACCELERATED APPROVAL OF AMENDMENTS

The Commission granted accelerated approval to a proposed rule change (SR-NYSE-94-04) and Amendment No. 1 to the proposed rule change by the New York Stock Exchange relating to Equity Linked Debt Securities. Publication of the notice and order is expected in the Federal Register during the week of August 22. (Rel. 34-34545)

The Commission approved a proposed rule change (SR-Amex-93-46) and granted accelerated approval to Amendment No. 6 of the proposed rule change filed by the American Stock Exchange relating to Equity Linked Term Notes. Publication of the notice and approval order is expected in the Federal Register during the week of August 22. (Rel. 34-34549)

APPROVAL OF PROPOSED RULE CHANGE

The Commission granted approval of a proposed rule change (SR-Phlx-94-02) filed by the Philadelphia Stock Exchange relating to the listing and trading of options and long-term options on the Phlx Semiconductor Index. Publication of the order is expected in the Federal Register during the week of August 22. (Rel. 34-34546)

PROPOSED RULE CHANGE

The National Securities Clearing Corporation filed a proposed rule change (SR-NSCC-94-13) to modify the Automated Customer Account Transfer Service. Publication of the proposal is expected in the Federal Register during the week of August 22. (Rel. 34-34550)

EDGAR PHASE-IN LIST UPDATES AVAILABLE TO PUBLIC

Pursuant to Rule 901 of Regulation S-T, registrants whose filings are processed by the Division of Corporation Finance may request a change in the date they become subject to mandated electronic filing on the Electronic Data Gathering, Analysis, and Retrieval ("EDGAR") system. The Division publishes from time to time changes and corrections to the phase-in list published in the Federal Register on March 18, 1993 (Release No. 33-6977 (February 23, 1993) [58 FR 14628]). A change to a company's phase-in date is of particular importance to persons or entities filing documents with respect to that company, since generally such persons must file electronically when the company becomes subject to electronic filing.

The updates will be published in the SEC News Digest and copies of the phase-in list updates will be available through the Commission's public reference room. They also will be posted on the EDGAR electronic bulletin board.

In addition, the Division has placed in the public reference room a copy of the phase-in list as of February 23, 1993, with companies sorted by group number. This information was published in the Federal Register on March 18, 1993, with all companies being listed in alphabetical order rather than sorted by group number.
