INVESTMENT COMPANY ACT RELEASES

NATIONAL HOME LIFE ASSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until May 11 to request a hearing on an application filed by National Home Life Assurance Company, National Home Life Assurance Company Separate Account V (Separate Account) and Capital Holding Securities Corporation. The application is for an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account under certain flexible premium variable annuity contracts. HOLDING COMPANY ACT RELEASES

CSW ENERGY, INC.

An order has been issued authorizing a proposal by CSW Energy, Inc. (Energy), a wholly owned subsidiary of Central and South West Corporation, a registered holding company. Energy proposes to invest up to \$10 million in a joint venture to be formed with EnerTran Technology Company to develop and consult with respect to qualifying small power production facilities and qualifying cogeneration facilities (as defined by the Public Utility Regulatory Policies Act of 1978) and independent power production facilities. Energy also proposes to organize a subsidiary company through which its investments in the joint venture will be made. (Rel. 35-25516)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The National Securities Clearing Corporation filed a proposed rule change (SR-NSCC-92-03) to increase certain NSCC archival microfiche fees. The proposed rule change became effective immediately upon filing with the Commission. Publication of the proposal is expected in the Federal Register during the week of April 20. (Rel. 34-30585)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-NASD-91-19) submitted by the National Association of Securities Dealers that adopts a new Rule of Fair Practice (Corporate Financing Rule) to replace in its entirety the current Interpretation of the Board of Governors -- Review of Corporate Financing. The proposal also codifies the NASD's practice related to procedures governing requests for review of NASD Corporate Financing Department determinations in new Article XII of the NASD Code of Procedure. In addition, the proposal also makes conforming changes to Schedule A of the NASD By-Laws to reflect the revised description of the calculation of the corporation financing filing fee that is set forth in the Corporate Financing Rule. Companies and individuals must report to the Commission within **ten days** on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became **subject** to Section 13(d)(1). Companies and individuals making a tender offer must **have on file** at the time the tender offer commences a Schedule 14D-1.
