## INVESTMENT COMPANY ACT RELEASES

### STRONG DISCOVERY FUND II, INC., STRONG SPECIAL FUND II, INC., ET AL.

A notice has been issued giving interested persons until June 29 to request a hearing on an application filed by Strong Discovery Fund II, Inc., Strong Special Fund II, Inc. (collectively, Funds), Strong/Corneliuson Capital Management, Inc. (the Adviser) and other similar funds which the Adviser may manage in the future (the Other Funds) for an order pursuant to Section 6(c) of the Investment Company Act. The order would grant exemptions from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder to the extent necessary to permit shares of both the Funds and the Other Funds to be sold to and held by variable annuity and variable life insurance separate accounts of both affiliated and unaffiliated life insurance companies. ### SUNAMERICA CAPITAL APPRECIATION FUND, INC., ET AL.

A notice has been issued giving interested persons until June 30 to request a hearing on an application filed by SunAmerica Capital Appreciation Fund, Inc. and related entities under Section 17(d) of the Investment Company Act and Rule 17d-1 thereunder for an order allowing certain investment companies to participate in one or the other of two joint accounts to be used to enter into repurchase agreements. ### COMSTOCK PARTNERS STRATEGY FUND, INC., ET AL.

A notice has been issued giving interested persons until June 30 to request a hearing on an application filed by Comstock Partners Strategy Fund, Inc. (Fund), et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from Sections 18(f)(1), 18(g) and 18(i) of the Act. The order would permit the Fund to issue a new class of shares representing interests in the same portfolio of securities as an existing class of shares, with shares of the existing class thereafter only being issued to shareholders of the existing class upon reinvestment of distributions. GOVERNMENT SECURITIES EQUITY TRUST, ET AL.

A notice has been issued giving interested persons until July 6 to request a hearing on an application filed by Government Securities Equity Trust, et al. for a conditional order under Section 6(c) of the Investment Company Act. The conditional order would grant an exemption from Section 12(d)(1) permitting certain unit investment trusts to invest in shares of one of certain mutual funds and zero coupon obligations. The conditional order would also grant an exemption from Section 14(a) to exempt the trust sponsor from having to take for its own account or place with others \$100,000 worth of units in the trusts and from Section 19(b) and Rule 19b-1 to permit the trusts to distribute capital gains resulting from redemption of fund shares within a reasonable time after receipt. In addition, the conditional order would grant an exemption from Section 22(d) to permit waiver of any sales load otherwise applicable on fund shares that the trusts have purchased; under Sections 11(a) and (c) to permit certain offers of exchange involving the trusts; and under Section 17(d) and Rule 17d-1 permitting certain affiliated transactions involving the trusts. An order has been issued under Section 8(f) of the Investment Company Act declaring that Rousseau Capital, Inc. has ceased to be an investment company. (Rel. IC-18762 - June 8)

**ACQUISITION OF SECURITIES**

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
