CIVIL PROCEEDINGS

DUCK BOOK COMMUNICATIONS, LTD. PERMANENTLY ENJOINED BY DEFAULT

The Seattle Regional Office announced that on March 7 U.S. District Court Judge Justin Quackenbush entered a Final Judgment of Permanent Injunction by Default against Duck Book Communications, Ltd., a British Columbia corporation, for violations of the registration and antifraud provisions of the securities laws. The Court denied Duck Book's motion to set aside an Order of Default which earlier had been entered against the defendant. The Court considered Duck Book's resistance to the Final Judgment but determined that there was a reasonable likelihood that future violations of the securities laws would occur. The Court entered Findings of Fact and Conclusions of Law in support of its Judgment. Duck Book had published a widely distributed quarterly magazine and newsletter which touted the purchase of its common stock on the Vancouver Stock Exchange while omitting to disclose and misrepresenting material facts concerning the financial condition, business prospects, and risks of the investment. INVESTMENT COMPANY ACT RELEASES

WESTERN LIFE INSURANCE COMPANY

An order has been issued granting Western Life Insurance Company, Variable Account D of Western Life Insurance Company, and AMEV Investors, Inc. exemptions from Sections 26(a)(2)(C) and 27(c)(2) of the Investment Company Act to permit them to issue variable annuity contracts that permit the deduction of mortality and expense risk charges. HOLDING COMPANY ACT RELEASES

THE COLUMBIA GAS SYSTEM, INC.

A supplemental order has been issued concerning a proposal by The Columbia Gas System, Inc., a registered holding company, and certain of its subsidiaries. By order dated December 23, 1987 [Rel. 35-24541], the Commission authorized the extension through December 31, 1989 of the Subsidiaries' intercompany financing programs, Columbia's external short-term financing program, and the Intrasystem Money Pool, subject to the approval of state commissions having jurisdiction over the proposed transactions. The supplemental order releases jurisdiction over the transactions proposed during 1988 by Columbia Gas of Virginia, Inc. (Rel. 35-24610 - March 30)

THE SOUTHERN COMPANY

An order has been issued authorizing The Southern Company, a registered holding company, to make capital contributions to its subsidiaries, Alabama Power Company, Georgia Power Company, Gulf Power Company, and Mississippi Power Company, in amounts not exceeding \$130, \$210, \$40, and \$20 million, respectively, from April 1, 1988 through March 31, 1989. (Rel. 35-24611 - March 30)

GENERAL PUBLIC UTILITIES CORPORATION

A supplemental order has been issued authorizing General Public Utilities Corporation, a registered holding company, to repurchase up to five million shares of its common stock, \$2.50 par value, through December 31, 1991. (Rel. 35-24612 - March 30)

NOTICE OF PROPOSED RULE CHANGES

A proposed rule change has been filed under Rule 19b-4 by: The Options Clearing Corporation (SR-OCC-88-2) that would provide for the issuance, clearance, and settlement of Cash Index Participations (CIPS). A CIP is a security whose value is determined by reference to the value of an underlying stock index. (Rel. 34-25529); The New York Stock Exchange (SR-NYSE-88-3) to permit registrars, in addition to transfer agents, to use facsimile signatures on stock certificates. (Rel. 34-25530)

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
