INVESTMENT COMPANY ACT RELEASES

PRUDENTIAL ADJUSTABLE RATE SECURITIES FUND, INC., ET AL.

A notice has been issued giving interested persons until May 7, 1993 to request a hearing on an application filed by Prudential Adjustable Rate Securities Fund, Inc., et al. for an order under Section 6(c) of the Investment Company Act that would exempt applicants from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order would permit applicants to issue and sell an unlimited number of classes of shares, including two classes already existing, representing interests in the same investment portfolio. The order would also permit applicants to assess, and in certain circumstances to waive, a contingent deferred sales charge. (Rel. IC-19400 - April 12)

ITT LIFE INSURANCE CORPORATION, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting ITT Life Insurance Corporation, ITT Life Insurance Corporation Separate Account One (Separate Account) and Hartford Equity Sales Company, Inc. from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The exemptions apply to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account under a deferred variable annuity contract. (Rel. THE EQUITABLE CAPITAL FUNDS, ET AL.

A conditional order has been issued on an application filed by The Equitable Capital Funds (Trust), Equitable Capital Management Corporation (Equitable Capital) and Alliance Capital Management Corporation L.P. (Alliance) under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a). The order permits Alliance to serve without compensation as an investment adviser to certain series of the Trust, without shareholder approval, for a period of no longer than 120 days following a corporate reorganization that will result in the termination of the Trust's existing advisory agreement with Equitable Capital. HOLDING COMPANY ACT RELEASES

GULF POWER COMPANY

A supplemental order has been issued authorizing a proposal by Gulf Power Company (Gulf Power), an electric public-utility subsidiary of The Southern Company, a registered holding company. Gulf Power requests authorization for the issuance and sale by Jackson County, Mississippi of \$13 million (aggregate principal amount) in Solid Waste Disposal Facilities Revenue Bonds (Gulf Power Company Project), Series 1993 (New Revenue Bonds). To secure its payment obligations with respect to the New Revenue Bonds, Gulf Power proposes the issuance of collateral bonds to a trustee pursuant to a supplemental indenture. (Rel. 35-25790)

MISSISSIPPI POWER COMPANY

An order has been issued authorizing Mississippi Power Company (Mississippi), a wholly owned electric public-utility subsidiary company of The Southern Company, a registered holding company, to issue first mortgage bonds (New Collateral Bonds) in connection with the issuance and sale of pollution control revenue bonds (Revenue Bonds) by Jackson County, Mississippi in an aggregate principal amount of \$13 million. The Commission reserves jurisdiction over all transactions, including the issuance of other first mortgage bonds (Collateral Bonds), together with the New Collateral Bonds, in connection with the issuance and sale at any time on or before December 31, 1995 of other Revenue Bonds in an aggregate principal amount of up to \$37 million. The Commission also reserves jurisdiction over the issuance and sale at any time on or before December 31, 1995 of its first mortgage bonds and/or preferred stock in a combined aggregate principal amount of up to \$220 million, exclusive of the issuance of Collateral Bonds.
