PROPOSED AMENDMENTS TO RULES GOVERNING POST-EFFECTIVE AMENDMENTS TO INVESTMENT COMPANY REGISTRATION STATEMENTS

The Commission has proposed amendments to Rule 485, the rule under which post-effective amendments to registration statements filed by open-end management investment companies (mutual funds) and unit investment trusts (UITs) (collectively, funds) are permitted to become effective automatically, and related rules and forms. The proposed revisions would simplify the operation of the current rule and expand the conditions under which post-effective amendments filed by investment companies are permitted to become effective automatically. In addition, insurance company separate accounts would be permitted to use Rule 485, and Rule 486 (the rule governing post-effective amendments filed by separate accounts) would be rescinded. The Commission also is reproposing a rule providing procedures by which closed-end interval companies file post-effective amendments and subsequent registration statements. ADMINISTRATIVE PROCEEDINGS

COMMISSION MODIFIES SANCTION IMPOSED AGAINST STEPHEN BOADT

The Commission sustained disciplinary action imposed on Stephen Russell Boadt of Marina del Rey, California by the National Association of Securities Dealers. The NASD found that Boadt continued to act as financial and operations principal (FINOP) for E.A.C. Advisors, Ltd. for over twenty months after he had been ordered by the NASD not to act in that capacity until he requalified by examination. The Commission agreed that Boadt's failure was conduct inconsistent with just and equitable principles of trade.

The Commission also sustained the NASD's order censuring Boadt and fining him \$10,000. Boadt had argued that the fine was excessive. The Commission found that the fine was not excessive in light of the availability to Boadt of the NASD's installment plan under which respondents may pay fines by executing promissory notes. The Commission,

however, found excessive the NASD's requirement that Boadt be barred in the event he failed to pass the FINOP examination within 120 days. The Commission modified that sanction to provide that Boadt will be permitted to take the examination within 120 days of the date of the Commission's order but, if he fails the examination within that period, he would be barred from acting in any principal capacity until such time as he passed the FINOP examination. SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the Philadelphia Stock Exchange (SR-Phlx-91-05) to require that for a member to reject a trade executed off a specialist's book, the member must receive floor official approval based on a showing of good cause that the execution was in relation to the specialist's responsibility to maintain a fair and orderly market. Publication of the proposal is expected in the Federal Register during the week of September 20. (Rel. 34-32922)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the Chicago Board Options Exchange (SR-CBOE-93-35) to amend its fee reduction plan has become effective upon filing with the Commission. Publication of the proposal is expected in the Federal Register during the week of September 20. (Rel. 34-32923)

A proposed rule change filed by the Philadelphia Stock Exchange (SR-Phlx-93-33) to amend its Equity Transaction Value Charges has become effective upon filing with the Commission. (Rel. 34-32924)

PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-92-46) to amend Schedule E to the NASD By-Laws to require compliance with Schedule E if a member participating in a distribution of a public offering of debt or equity securities has a conflict of interest with the issuer. ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.

Below is a list of recent filings of Schedules 13D and 14D, which includes the following information: Column 1 - the company purchased (top), and the name of the purchaser; Column 2 - the type of security purchased; Column 3 - the type of form filed; Column 4 - the date the transaction occurred; Column 5 - the current number of shares (in 000's) owned (top) and the current percent owned; Column 6 - the CUSIP number (top) and the percent owned; and Column 7 - the status of the filing, i.e., new, update or revision.
