The Commission has made effective amendments to Form F-9 under the Securities Act of 1933 which recognize investment grade ratings by securities rating organizations recognized by Canadian securities regulators for purposes of certain filings under the multijurisdictional disclosure system for Canadian issuers. ## ENFORCEMENT PROCEEDINGS

---

### INJUNCTIVE ACTION BROUGHT AGAINST TIMOTHY RAFFERTY

The Commission announced that on June 24, 1993 a complaint was filed in the U.S. District Court for the Northern District of Illinois, Eastern Division, against Timothy Rafferty (Rafferty). Simultaneously, a Consent and Stipulation was filed wherein Rafferty consented to an order of permanent injunction enjoining him from violating Section 17(a) of the Securities Act, Sections 7(f) and 10(b) of the Exchange Act and Rule 10b-5 thereunder, and Section 3(b) of Regulation X promulgated by the Federal Reserve Board. The order leaves open the issues of an appropriate amount of disgorgement and civil penalty.

In its complaint, the Commission alleged that Rafferty engaged in a complex free riding scheme. As part of that scheme, Rafferty established several accounts in his name and in the names of various nominees, in at least seven broker-dealers. Rafferty then ordered the purchase of large blocks of Panther Mountain Water Park, Inc. stock, without the intention of paying for those shares. Rafferty also established accounts at broker-dealers to purchase the shares of Panther Mountain stock which were sold out by earlier broker-dealers for non-payment. [SEC V. Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
