## RULES AND RELATED MATTERS

---

### REVISIONS TO REGULATION D ADOPTED

The Commission adopted a number of revisions to Regulation D, the limited offering exemptive provision from the registration requirements of the Securities Act of 1933. One amendment adds to the lists of "accredited investors" certain governmental employee benefit plans with total assets in excess of \$5 million. Other changes include the new Rules 507 and 508 which are designed to address the issue of substantial and good faith compliance with the terms, conditions, and requirements of Regulation D. The amendments become effective 30 days after publication in the Federal Register. (Rel. 33-6825)

## OLDING COMPANY ACT RELEASES

---

### APPALACHIAN POWER COMPANY

An order has been issued authorizing Appalachian Power Company (APCo), subsidiary of American Electric Power Company, Inc., to sell to APCo's industrial customer, Virginia Polytechnic Institute and State University, for a purchase price of \$450,000 in cash, certain transformation and other related equipment located at APCo's Blacksburg, Virginia 69/12 KV Station. ### MISSISSIPPI POWER COMPANY

A supplemental order has been issued authorizing Mississippi Power Company, subsidiary of The Southern Company, to issue and sell through March 31, 1991 up to \$20 million of preferred stock, which had been previously authorized to be issued and sold through March 31, 1989 [Rel. 35-24732]. Jurisdiction is reserved, pending completion of the record, over the issuance and sale of up to \$40 million of bonds. (Rel. 35-24835 - Mar. 13)

## SELF-REGULATORY ORGANIZATIONS

---

### EFFECTIVENESS OF PROPOSED RULE CHANGE

The New York Stock Exchange filed a proposed rule change which became effective under Section 19(b)(3)(A) of the Securities Exchange Act. The proposal (SR-NYSE-89-4) establishes fees for NYSE's proposed "Correction System," which electronically will resolve unmatched trades. (Rel. 34-26620)

### NOTICE OF PROPOSED RULES CHANGES

The New York Stock Exchange, American Stock Exchange, and Chicago Board Options Exchange filed proposed rules changes under Rule 19b-4 (SR-NYSE-89-1; SR-Amex-89-3; and SR-CBOE-89-1) relating to sales practice and suitability rules concerning uncovered short options transactions. (Rel. 34-26621)

The Amex filed a second proposed rule change (SR-Amex-89-2) to (1) permit a member firm affiliated with an option specialist to conduct an upstairs over-the-counter market making business in the stock underlying the specialty option, and (2) to revise its Chinese Wall guidelines accordingly. (Rel. 34-26624)

Publication of the proposals are expected to be made in the Federal Register during the week of March 13.

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
