## COMMISSION ANNOUNCEMENTS

---

### COMMISSIONER SCHAPIRO CONFIRMED

On November 18, 1989, Mary L. Schapiro was confirmed by the Senate to a five-year term as a Commissioner, expiring in June 1994. She was sworn into that term at 10:30 a.m. today by Associate Justice Sandra Day O'Connor of the United States Supreme Court. The ceremony was held in the Indian Treaty Room of the Old Executive Office Building.

### OFFICE OF INTERNATIONAL AFFAIRS ESTABLISHED

Chairman Richard C. Breeden yesterday announced the creation of a new Office of International Affairs within the Commission. The new Office of International Affairs, which will report directly to the Chairman, will have primary responsibility for negotiating Memoranda of Understanding between the SEC and foreign securities regulators, as well as for coordinating activities relating to enforcement programs pursuant to those agreements. The Office also will operate in a consultative role regarding the significant ongoing international programs and initiatives of the Commission's operating divisions and offices. Chairman Breeden named Michael D. Mann, currently the Associate Director for International Affairs within the Division of Enforcement, as the Office's first Director. (Press Rel. 89-87)

## ADMINISTRATIVE PROCEEDINGS

---

### NYSE ACTION AGAINST JOHN GORDON SIMEK AFFIRMED

The Commission has affirmed disciplinary action taken by the New York Stock Exchange against John Gordon Simek of Interlaken, New Jersey, a former exchange member. The Exchange barred Simek from membership, allied membership, approved person status, and employment or association with any member or member organization in any capacity.

Both the Exchange and the Commission found that Simek, a floor broker, attempted to evade liability for questioned trades by improperly shifting his responsibility to others, failed to follow Exchange procedures for questioned trades, issued checks that were returned for insufficient funds, failed to make timely payments and reports to the NYSE, and made false statements to NYSE investigators. In sustaining the bar, the Commission noted that Simek's transactions were dishonest and caused substantial losses to others. (Rel. 34-27528)

## CRIMINAL PROCEEDINGS

---

### PENNY STOCK PROMOTER JOHN E. WORTHEN SENTENCED

The U.S. Attorney for the Southern District of California and the Denver Regional and Salt Lake Branch Offices announced that on December 11 Judge Leland C. Nielsen sentenced John E. Worthen. Worthen was indicted in December 1987 on twelve counts of criminal contempt of an injunction obtained by the Commission in 1974. The Court sentenced Worthen to time served on three of four counts, to which he had pleaded guilty. Worthen previously had been incarcerated for approximately six months following his arrest. He was placed on probation for five years on the fourth count to which he pleaded guilty. Conditions of probation include that Worthen violate no laws, particularly the Securities Act and the Exchange Act. He was also ordered not to own or deal in the stock of any nonpublic company or any company not registered with the Commission. This prosecution of a recidivist penny stock promoter involved fraudulent statements concerning Western Pacific Technology, formerly of Arcadia, California, and Nordic Ltd., Inc. of Salt Lake City, Utah, and the subsequent manipulation of the stock of the two companies. ## HOLDING COMPANY ACT RELEASES

---

### GEORGIA PACIFIC POWER COMPANY ENERGY CORPORATION

Notices have been issued giving interested persons until January 8, 1990 to request a hearing on proposals by: GEORGIA POWER COMPANY (Georgia), an electric public-utility subsidiary of The Southern Company, a registered holding company, to issue and sell on or before December 31, 1990, (a) first mortgage bonds, preferred stock, pollution control revenue bonds, and effect borrowings in the form of term loans, in an aggregate amount up to \$850,000,000 with specified sub-limits for each security; and (b) short-term notes to banks and commercial paper to dealers in an aggregate amount at any one time outstanding of up to \$1,000,000,000; and LOUISIANA POWER & LIGHT COMPANY (LP&L), and its parent company, Entergy Corporation (Entergy), a registered holding company, whereby LP&L will issue and sell its common stock in amounts of up to 18,961,000 shares through December 31, 1990, and Entergy will acquire such shares, for an aggregate cash purchase price not to exceed \$125 million. ## SELF-REGULATORY ORGANIZATIONS

---

### NOTICE OF PROPOSED RULE CHANGE

The Midwest Stock Exchange (SR-MSE-89-07) has filed a proposed rule change under Section 19(b) of the Securities Exchange Act to shorten from five days to three the period after trade date within which MSE members may make a claim for certain reports concerning securities transactions. Publication of the notice in the Federal Register is expected to be made during the week of December 11. (Rel. 34-27533)

## ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
