ADMINISTRATIVE PROCEEDINGS AS SEAS

U.S. SECURITIES

#### MARK BENSKIN BARRED

The Commission instituted public administrative proceedings against Mark Stephen Benskin (Benskin) pursuant to Section 15(b) of the Securities Exchange Act of 1934 (Exchange Act) and Section 203(f) of the Investment Advisers Act of 1940 (Advisers Act).

Benskin submitted an Offer of Settlement consenting to the entry of an Order containing findings that Benskin: (1) was permanently enjoined from violations of certain provisions of the Securities Act of 1933, the Exchange Act and the Advisers Act by judgment of the U.S. District Court for the Western District of Tennessee in connection with his participation in a Ponzi scheme (SEC v. Mark Stephen Benskin and Mark Benskin & Co., Inc., Civil Action No. 90-2514-HA); and (2) was convicted upon a plea of guilty in the same district court of forty counts of mail fraud and ten counts of securities fraud for his involvement in the Ponzi scheme (U.S. v. Mark Stephen Benskin and Mark Benskin & Company, Inc., Crim. Action 89-20166-G). The Order permanently bars Benskin from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. (Rel. 34-28755)

### PROCEEDINGS INSTITUTED AGAINST JAMES RAPHOLZ, JR.

The Commission instituted public administrative proceedings under the Investment Advisers Act of 1940 (Advisers Act) and the Investment Company Act of 1940 (Investment Company Act) against James L. Rapholz, Jr., (Rapholz) and James L. Rapholz, Jr., d/b/a Economic Advice. Rapholz, of Lighthouse Point, Florida, has been registered with the Commission as an investment adviser since December 1977. Rapholz is the president and sole investment adviser for Palm Beach Diversified Equity Fund, Inc. (PBDEF). PBDEF has been registered with the Commission since 1984 as a closed-end, management investment company.

The Order Instituting Proceedings (Order) alleges that from about September 1986 until about October 1989, Rapholz made misrepresentations and omissions of material fact to clients concerning the investment objectives of PBDEF. The Order further alleges that since about January 1988, Rapholz has caused PBDEF to: (1) fail to make required filings with the Commission; (2) fail to send required financial reports to investors; and (3) fail to maintain and preserve various required books and records. The Order alleges that Rapholz thereby willfully violated the anti-fraud provisions of the Advisers Act and willfully aided and abetted violations of the periodic reporting and books and records provisions of the Investment Company Act. #### INVESTMENT COMPANY ACT RELEASES

#### ASA LIMITED

An order has been issued under Section 7(d) of the Investment Company Act on an application filed by ASA Limited. The order permits applicant to amend its charter and by-laws, along with its custodian and subcustodian agreements, where appropriate, to allow for: (a) an increase from \$75,000 to \$200,000 in the amount of cash applicant can hold outside of the custody of a United States custodian to cover administrative expenses; (b) the ability to invest up to 5% of its assets in interest-bearing bank accounts with "eligible foreign custodians" or "overseas branches of qualified United States banks," as those terms are defined in Rule 17f-5 under the Act; and (c) certain changes in the composition and operation of applicant's board of directors.
