## INVESTMENT COMPANY ACT RELEASES

### ROSENBERG SERIES TRUST

A conditional order has been issued under Sections 6(c) and 17(b) of the Investment Company Act exempting Rosenberg Series Trust (Trust), et al. from the provisions of Section 17(a)(1) of the Act to the extent necessary to permit the Trust's Small Capitalization Series (Series) from time to time to sell its shares to the Equity Portfolio of Bell Atlantic Mutual Funds, Inc. The investment adviser of the Series is also the subadviser of the Equity Portfolio. (Rel. IC-18023 - March 1)

DEAN WITTER REYNOLDS

A temporary conditional order has been issued under Section 9(c) of the Investment Company Act exempting Dean Witter Reynolds Inc. from the provisions of Section 9(a) of the Act to relieve it from any ineligibility resulting from the employment of three individuals who have been enjoined from engaging in certain securities or commodities-related conduct. The order extends the period of exemption granted by a prior temporary order for the shorter of 45 days or until the date on which the Commission takes final action on applicant's request for a permanent order. Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
