INVESTMENT COMPANY ACT RELEASES

PUBLIC EMPLOYEES RETIREMENT TRUST FIDUCIARY INCOME FUNDS

Orders have been issued under Section 8(f) of the Investment Company Act declaring that PUBLIC EMPLOYEES RETIREMENT TRUST and FIDUCIARY INCOME FUNDS, INC. have ceased to be investment companies. (Rel. IC-18033 - March 8 and IC-18036 - March 12, respectively)

MASSMUTUAL MONEY MARKET FUND

A conditional order under Section 17(b) of the Investment Company Act has been issued on an application filed by MassMutual Money Market Fund, et al. The order grants an exemption from Section 17(a) to permit certain registered investment companies to acquire substantially all of the assets of certain other registered investment companies. (Rel. IC-18034 - March 12)

BENHAM EQUITY FUNDS

A conditional order has been issued under Section 17(d) of the Investment Company Act and Rule 17d-1 thereunder on an application filed by Benham Equity Funds, Capital Preservation Fund II, Inc. and Benham Management Corporation permitting them to operate a joint repurchase agreement account. (Rel. IC-18035 - March 12)

HOLDING COMPANY ACT RELEASES

EASTERN UTILITIES ASSOCIATES

An order has been issued authorizing Eastern Utilities Associates (EUA) and its subsidiaries, Eastern Edison Company, EUA Cogenex Corporation, Montaup Electric Company and Blackstone Valley Electric Company (collectively, Subsidiaries), to contribute to the Eastern Utilities Associates Employees' Savings Plan (Plan) an additional 200,000 shares of EUA common stock, \$5 par value, or cash. The cash can be used to purchase up to 200,000 additional shares of EUA common stock, through December 15, 1995, for the purpose of making such shares available for purchase under the Plan. (Rel. 35-25269)

GENERAL PUBLIC UTILITIES CORPORATION

A supplemental order has been issued authorizing General Public Utilities Corporation (GPU), a registered holding company, and its subsidiaries, Jersey Central Power and Light Company, Metropolitan Edison Company and Pennsylvania Electric Company, through March 31, 1991, to issue, sell and renew six-month notes to banks in aggregate outstanding amounts of up to \$150 million. Further, they may issue, sell and renew nine-month notes to banks in aggregate outstanding amounts of up to their respective charter limitations on short-term debt, but \$200 million in the case of GPU; and, in the case of the subsidiaries, to issue and sell commercial paper in outstanding amounts of up to their respective charter limits. However, aggregate outstanding short-term borrowing amounts by each company may not exceed its charter limitations, or \$200 million in the case of GPU. The Commission reserved jurisdiction over the issuance, sale and renewal of nine-month notes to lenders other than commercial banks, insurance companies or similar institutions through March 31, 1992. PROPOSED RULE CHANGE

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-91-10) with the Commission under Rule 19b-4 of the Securities Exchange Act to amend its Plan For The Implementation of FOCUS Reports so that most FOCUS information will be filed with the NASD electronically, not by paper filings. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 18.
