CIVIL PROCEEDINGS

PRELIMINARY INJUNCTION ENTERED AGAINST DAVID STERNS AND THE HUNTOR GROUP

The Commission announced that on March 28 the U.S. District Court for the Central District of California, Judge Edward Rafeedie, preliminarily enjoined The Huntor Group and David D. Sterns from further violations of the registration and antifraud provisions of the federal securities laws. Judge Rafeedie also entered an Order Freezing Assets of David D. Sterns and Appointing a Special Agent to monitor expenses and perform a review and accounting of The Huntor Group. In addition, the Court ordered The Huntor Group to withdraw the voluntary petition for reorganization under Chapter 11 of the U.S. Bankruptcy Code it had filed subsequent to the filing of the Commission's complaint on March 11, 1991.
