PROPOSED RULE CHANGES

Proposed rule changes have been filed by the following under Rule 19b-4: Options Clearing Corporation (SR-OCC-91-10) relating to OCC's financial responsibility rules; and Participant Trust Company (SR-PTC-91-09) to authorize PTC to join the Securities Clearing Group, an association of clearing agency self-regulatory organizations. IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE
