### PUBLICATION OF REGULATORY FLEXIBILITY AGENDA AND RULES SCHEDULED FOR REVIEW

The Commission today authorized the publication of its Regulatory Flexibility Agenda and Rules scheduled for review in the October 1991 edition of the Unified Agenda of Federal Regulations. This publication lists the rulemaking actions, including rule reviews, which the Commission anticipates considering in the next six to twelve months. ## ADMINISTRATIVE PROCEEDINGS

---

### DECISION BARRING ROBERT GLEAVE FINAL

The decision of an administrative law judge barring Robert C. Gleave of Aurora, Colorado from association with any broker or dealer has become final. Gleave was formerly a vice-president of Excel Securities, Inc., an Englewood, Colorado brokerage firm.

The law judge found that in 1988 Gleave was a principal conspirator in a fraudulent scheme to list the worthless stock of Protecto Industries, Inc. in the pink sheets and manipulate its price. The law judge also found that Gleave violated registration provisions in connection with the offer and sale of that stock and that he was convicted in 1989, on the basis of his guilty plea, of securities fraud and conspiracy to commit securities fraud, wire fraud and bank fraud. Finally, the law judge found that he was enjoined in 1990, with his consent, from violations of registration and antifraud provisions of the securities acts. (Rel. 34-29656)

## SELF-REGULATORY ORGANIZATIONS

### PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-91-20) with the Commission that will enable broker-dealers using the Institutional Delivery and International Institutional Delivery Systems to exchange trade data for transactions that will settle outside the automated settlement systems. Publication of the proposal is expected in the Federal Register during the week September 16. (Rel. 34-29674)

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
