ENFORCEMENT PROCEEDINGS

THOMAS CONNOLLY BARRED

The Commission entered an Order Instituting Proceedings, Making Findings and Imposing Remedial Sanctions (Order), by consent, against Thomas P. Connolly (Connolly), of Wilmington, Massachusetts, a former registered representative with WMA Securities, Inc., barring him from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. The Order is based on the entry of a Permanent Injunction against Connolly in SEC v. Richmond (D. Mass, filed July 15, 1998). In that matter, Connolly consented, without admitting or denying the allegations of the Commission's complaint, to the entry of the Permanent Injunction enjoining him from violating the securities registration, antifraud and broker-dealer registration provisions of the federal securities laws. The Commission's complaint alleged that Connolly was one of several salesman who used false representations, concerning rate of return and risk, to sell fictitious unregistered International Certificates of Deposit (ICDs) purportedly issued by Royal Meridian International Bank (RMIB), a non-existent bank. The complaint also alleged that Connolly sold the ICDs after his broker-dealer issued a compliance warning prohibiting the solicitation or sale of RMIB products. The Commission's action is continuing as to the remaining defendants. (Rel. 34-40947; File No. 3-9811)

TWO BROKERAGE FIRMS CENSURED, ORDERED TO CEASE AND DESIST AND FINED FOR FAILING TO MAKE TIMELY YEAR 2000-RELATED DISCLOSURE

The Commission issued an order against Allegheny Financial Programs, Inc. (Allegheny) of Weston, West Virginia and Atlantic-Pacific Capital, Inc. (Atlantic-Pacific) of Greenwich, Connecticut for failing to timely file their Forms BD-Y2K. The Order arises out of the October 20, 1998 proceedings instituted against 18 brokerage firms for failing to timely file all or part of Form BD-Y2K and contains findings that Allegheny and Atlantic-Pacific, two firms with minimum net capital requirements of \$5000, were required to and failed to file part I of Form BD-Y2K by August 31, 1998. The Order further finds that, despite receiving a letter from the NASD reminding them of their failure to file the form in a timely manner, Allegheny and Atlantic-Pacific had not filed part I of Form BD-Y2K by October 2, 1998. The Order censured Allegheny and Atlantic-

Pacific, ordered them to cease and desist from committing or causing any violations or future violations of the BD-Y2K requirements of the Exchange Act, and required each firm to pay a \$5000 civil penalty. Allegheny and Atlantic-Pacific consented to the Order without admitting or denying the findings contained in the Order. (Rel. 34-40948; File No. 3-9759)

TEMPLETON DRAGON FUND, INC.

A notice has been issued giving interested persons until February 8, 1999, to request a hearing on an application filed by Templeton Dragon Fund, Inc., a registered closed-end management investment company. Applicant requests an order under Section 6(c) of the Act granting an exemption from Section 19(b) of the Act and Rule 19b-1 under the Act to permit it to make up to four distributions of net long-term capital gains in any one taxable year, so long as it maintains in effect a distribution policy with respect to its common stock calling for quarterly distributions of a fixed percentage of its net asset value. An order has been issued on an application filed by IEI Capital Corp. for an order under Section 6(c) of the Investment Company Act exempting it from all provisions of the Act. The order permits IEI Capital Corp. to sell certain debt securities and use the proceeds to finance the business activities of its parent company, Indiana

Energy Inc., and certain companies controlled by the parent company.

HARTFORD LIFE AND ANNUITY INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until February 8, 1999, to request a hearing on an application filed by Hartford Life and Annuity Insurance Company, ICMG Registered Variable Life Separate Account One and Hartford Life and Annuity Insurance Company Separate Account Six (together with ICMG Registered Variable Life Separate Account One, the Accounts) .
