ENFORCEMENT PROCEEDINGS

MICHAEL BYRD CONSENTS TO INJUNCTION AND PAYMENT OF \$35,000 TO SETTLE INSIDER TRADING CASE

The Commission announced that on April 12 the United States District Court for the Western District of Texas, Austin Division, entered a final judgment of permanent injunction settling the Commission's insider trading claims against Michael Byrd, and ordering him to pay \$35,000.

Without admitting or denying the Commission's allegations, Byrd consented to the entry of the judgment, which permanently enjoins him from violating the antifraud provisions of the federal securities laws. The judgment requires Byrd to pay disgorgement and prejudgment interest, but waives payment of all but \$35,000 of these amounts, and does not impose a civil penalty based on Byrd's demonstrated inability to pay.

The Commission's complaint alleged that Byrd, while acting as a consultant to defendant First National Entertainment Corp. (FNAT), knew facts indicating that the revenue projections FNAT was disseminating to the public for an animated film called "Happily Ever After" were inflated. Byrd sold FNAT stock while in possession of this information, before the movie opened to dismal revenues, and FNAT stock prices declined sharply after those revenues were disclosed publicly. [SEC v. INVESTMENT COMPANY ACT RELEASES

THE AQUINAS FUNDS, INC. AND AQUINAS INVESTMENT ADVISORS, INC.

An order has been issued on an application filed by The Aquinas Funds, Inc. and Aquinas Investment Advisers, Inc. under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of the Act and Rule 18f-2 under the Act. The order permits applicants to enter into and materially amend subadvisory agreements without obtaining shareholder approval. (Rel. IC-23810 - April 27)

HOLDING COMPANY ACT RELEASES

COLUMBIA ENERGY GROUP, ET AL.

A notice has been issued giving interested persons until May 18, 1999, to request a hearing on a proposal by Columbia Energy Group (Columbia), a registered holding company, and its nonutility subsidiaries. Columbia proposes to expand its natural gas exploration and production activities in Canada and to increase its

investment in these activities from \$5 million to \$55 million.

AMEREN CORPORATION, ET AL.

An order has been issued authorizing Ameren Corporation, a registered holding company, and certain other subsidiaries, through February 27, 2003, to: (1) issue and sell up to 25 million shares of common stock; (2) incur short-term debt in an aggregate amount not to exceed \$1.5 billion; (3) issue guarantees in an amount not to exceed \$1 billion; (4) issue and sell \$300 million in unsecured debentures; and (5) finance the acquisition of exempt wholesale generators and foreign utility companies. PROPOSED RULE CHANGES
