COMMISSION ANNOUNCEMENTS

SUSAN OCHS, DIRECTOR OF LEGISLATIVE AFFAIRS, TO LEAVE THE COMMISSION

On July 2, the Commission announced that Susan M. Ochs, Director of the SEC's Office of Legislative Affairs, will leave the Commission at the end of this month to pursue a masters degree in business administration at Harvard Business School. Susan F. Wyderko, currently Counsel to Chairman Arthur Levitt, will serve as Acting Director of the Office until a successor is named. (Press Rel. 99-76)

HOLDING COMPANY ACT RELEASES

GEORGIA POWER COMPANY

An order has been issued authorizing Georgia Power Company (Georgia Power), a wholly owned subsidiary of The Southern Company, a registered holding company, to convey all of its rights, title and interests in and to real and personal property, including engineering drawings, comprising up to 30 of its distribution and transmission substation facilities to the Georgia Transmission Corporation (GTC), a nonassociate company. In exchange, GTC will convey to Georgia Power all its rights, title and interests in and to real and personal property comprising up to four of GTC's distribution and transmission substation facilities, an exchange equalization payment of \$3,808,831, and an additional payment of \$560,000 to ensure that Georgia Power suffers no after tax loss on the exchange. SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change (SR-NYSE-99-27) filed by the New York Stock Exchange to implement a \$200 fee for each candidate in connection

with the new Front Line Specialist Clerk Qualification Examination (Series 21) to be given by the NYSE has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of July 5. (Rel. 34-41576)

A proposed rule change filed by the Pacific Exchange to reorganize PCX Rule 6.87 (SR-PCX-99-23) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of July 5. (Rel. 34-41582)

The Emerging Markets Clearing Corporation filed a proposed rule change (SR-EMCC-99-6), which became effective upon filing, establishing a fee for bond trade data submitted directly to EMCC by a member. Publication of the proposal is expected in the Federal Register during the week of July 5. (Rel. 34-41590)

The MBS Clearing Corporation filed a proposed rule change (SR-MBSCC-99-03) to add an addendum to MBSCC's rules regarding the eligibility of applicants. The proposed rule change has become effective upon filing with the Commission. Publication of the proposal is expected in the Federal Register during the week of July 5. (Rel. 34-41592)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change, on an accelerated basis, submitted by the Chicago Stock Exchange (SR-CHX-99-07) to extend a pilot program relating to the trading of Nasdaq/NM securities on the CHX. Publication of the order is expected in the Federal Register during the week of July 5. (Rel. 34-41586)

The Government Securities Clearing Corporation filed a proposed rule change (SR-GSCC-98-05) to automate the transfer of government securities via the Automated Customer Account Transfer Service offered by NSCC. The Commission has approved the proposed rule change on an accelerated basis. Publication of the proposal is expected in the Federal Register during the week of July 5. (Rel. 34-41589)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted by the Philadelphia Stock Exchange (SR-Phlx-98-56) to permanently approve the enhanced parity split Pilot Program for equity and index option specialists, and to adopt an enhanced parity split for specialists that develop and trade new products. Publication of the order is expected in the Federal Register during the week of July 5. (Rel. 34-41588)
